## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of International Union of Operating Engineers Local 324 Retirement Trust Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 - Description of the Fund**

The following description of International Union of Operating Engineers Local 324 Retirement Trust Fund (the "Fund") provides only general information. For a more complete description of the Fund's provisions, refer to the plan document or summary plan description.

***General***

The Fund is a defined contribution plan established by Operating Engineers Local 324 and participating stationary engineer employers. All employees of the participating employers are eligible for participation in the Fund. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each participant may make contributions from compensation in 1 percent increments or by a dollar amount as long as plan limitations are not exceeded. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain limitations established by the Internal Revenue Code (IRC). Contributions from employees are recognized on the accrual basis in the plan year to which the accrual applies.

Certain participant contributions in 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, and 2024 were paid after the time frame required by the Department of Labor (DOL). Certain contributions of lost earnings were made to the Fund during 2024 and 2023, and certain contributions of lost earnings will be made to the Fund subsequent to year end. The delinquent participant contributions were remitted in 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, and 2024.

Employer matching contributions are provided based upon collective bargaining agreements.

***Participant Accounts***

Each participant's account is credited with allocations of the participant's contributions and employer's contributions. Participant accounts are credited with fund earnings and charged with an allocation of administrative expenses. Allocations are based on individual account earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Fund.

***Vesting***

Participants' contributions and the employer match contribution, and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

***Participant Notes Receivable***

Participants may borrow a minimum of \$1,000 up to a maximum of \$10,000 or 50 percent of their elective deferral account balances, excluding the Roth deferrals, whichever is greater, not to exceed \$50,000. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

***Payment of Benefits***

Upon termination of employment, the participant or, in the case of death, the beneficiary, can elect to receive the participant's account balance in a single lump sum or in various installment annuities.

**December 31, 2024 and 2023**

**Note 1 - Description of the Fund (Continued)**

***Termination***

Upon termination of the Fund, the trustee shall distribute all remaining assets, after payment of any expense properly chargeable against the Fund, to participants based on the value of their account balances on the termination date.

***Hardship Withdrawals***

Participants may request that a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Lincoln Financial Group Trust Company, Inc. or its affiliates. Lincoln Financial Group Trust Company, Inc. is the trustee of the Fund; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Fund's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate account is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

All administrative expenses are paid by the Fund.

**December 31, 2024 and 2023**

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Fund invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Lincoln Financial Group Trust Company, Inc. (the "Trustee") holds the Fund's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Fund has received a determination letter from the Internal Revenue Service indicating that the Fund, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Although the Fund has been amended since receiving the determination letter, management believes that the Fund is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Fund has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

The Fund's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 6 - Investment Contracts**

The Fund has a benefit-responsive investment contract with Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Fund.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, Lincoln National Life Insurance Company considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Fund to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement for that portion of net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.
