Scope and Nature of the ERISA Section 103(a)(3)(C) Statements

We have performed audits of the accompanying financial statements Veolia Water Resources 401(k) Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Veolia Water Resources 401(k) Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that covers the eligible employees of Veolia Utility Resources, LLC and its subsidiaries and certain affiliates (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective December 30, 2024 the Plan was amended to change the name of the Plan from Suez Water Resources LLC 401(k) Plan to Veolia Water Resources 401(k) Savings Plan.

During the year ended December 31, 2024, participants in the Plan were transferred in and to other plans sponsored by the Company based on participant employment status changes and organization restructuring. The Plan transferred \$48,823,597 to the Veolia North America 401(k) Savings Plan. In addition, participant loans totaling \$1,413,450 were transferred to the Veolia North America 401(k) Savings Plan. The Plan had transfers in from the SUEZ Water Resources LLC Collectively Bargained 401(k) Plan of \$95,029,377. In addition, participant loans totaling \$4,326,054 were transferred in from the SUEZ Water Resources LLC Collectively Bargained 401(k) Plan. Effective January 1, 2025, participants have become eligible to participate in the Suez Water Resources Inc. 401(k) Plan and the Veolia North America 401(k) Savings Plan.

Transfers in during 2024 and 2023 were \$431,978 and \$1,199,430, respectively, and represent assets transferred to the SUEZ Water Resources LLC Collectively Bargained 401(k) Plan because of a change in the status of participants from bargained to non-bargained employees of the Company. Transfers out during 2024 and 2023 were \$180,883 and \$151,409, respectively, and represent assets transferred to SUEZ Water Resources LLC Collectively Bargained 401(k) Plan as a result of a change in the status of participants from non-bargained employees to bargained employees of the Company.

With the Veolia merger with SUEZ, IRS Rules regarding mergers and acquisitions allow for a transition period when two organizations with retirement programs come together. Veolia has begun the process of coordinating investments and plan features within the timeframes provided under those IRS Transitional Rules for Coverage, Participation, and Benefits, Rights and Features. None of the coordination has been finalized or executed as of the date of filing.

Eligibility

All employees of the Company, except for those who are covered by a collective bargaining agreement and leased employees, automatically become eligible to participate in the Plan upon hire and are automatically enrolled in the Plan at a 3% pre-tax deferral percentage. Employees may elect not to participate in the Plan.

Contributions

The Plan permits participants to make pre-tax contributions of between 1% and 50% of their eligible compensation for the year, provided such contributions do not exceed the dollar limitation in effect under

the Internal Revenue Code (the “Code”). The Plan also permits participants to make post-tax contributions between 1% and 50% of their eligible compensation for the year, provided such contributions do not exceed the allowable amount under the Code. The total of the participants’ pre-tax contributions and post-tax contributions may not exceed 50% of their compensation for the year and may not exceed the allowable amount under the Code. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans.

The Plan provides for employer matching contributions for eligible employees, with rates and formulas varying by company, location or facilities, and hire dates as defined in the plan document.

Participants are fully vested in their contributions and earnings thereon immediately, and become fully vested in the Company’s contributions and earnings thereon after one year of credited service. Full vesting also occurs upon attaining age 65, permanent disability or death, regardless of the participant’s length of Service.

Investment Options

All of the Plan’s investment options are participant-directed into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with his or her contribution, the Company’s matching contribution, and Plan earnings or losses, and is charged with an allocation of administrative expenses.

Forfeitures

Forfeitures of terminated, non-vested participants’ accounts are first applied to restore any participant accounts of employees who are re-employed and any remaining amounts are used to pay plan expenses as applicable. Forfeitures from employees for the years ended December 31, 2024 and 2023 were \$51,009 and \$24,157, respectively. Plan forfeitures of \$294 and \$27,778 were applied in conjunction with the payment of employer contributions and plan expenses, respectively, for the year ended December 31, 2024. Plan forfeitures of \$6,190 and \$845 were applied in conjunction with the payment of employer contributions and plan expenses, respectively, for the year ended December 31, 2023. Forfeitures of \$494 were transferred in the Plan during the year ended December, 31 2024 from the Suez Collectively Bargained 401(k) Plan. The available balance of forfeitures as of December 31, 2024 and 2023 were \$86,491 and \$38,842, respectively.

1. Description of the Plan (continued)

Payment of Benefits

Benefits may be paid upon death, disability, termination, normal retirement or attainment of age 59½ to the participants or their beneficiaries. These benefits are generally paid in lump-sum amounts equal to the value of the participant's vested interest in his or her account. The Plan also permits installment distributions not to exceed a ten-year period.

Notes Receivable from Participants

Participants may borrow from their accounts in amounts ranging from \$1,000 to \$50,000, provided the loan is not more than 50% of their vested account balances. The terms of the loans range from one to five years, with longer terms permitted for the purchase of a primary residence. The maximum number of loans a participant may have outstanding at any time is three. The loans are secured by the balance in the participant's account and bear interest at a fixed interest rate which is determined when the loan is made by reference to market and non-market interest rates (ranging between 4.25% and 9.5% at December 31, 2024). Interest is fixed for the term of the loan. Principal and interest are paid through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. All transaction fees are paid from participants' accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Presentation

The Plan's financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value generally by reference to published market prices valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of investments are recorded on a trade date basis (the day the order to buy or sell is executed). Interest income is accrued when earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

The Plan holds an investment in the Vanguard Retirement Savings Trust, a common and commingled trust (the "Trust") that invests solely in the Vanguard Retirement Savings ("VRST") Master Trust. The Plan's investment in the Trust is valued at the unit value of the Trust. The Trust values its investments in the VRST Master Trust similarly. The underlying investments of the VRST Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond trusts and bond mutual funds. The contracts are comprised of: (a) traditional investment contracts issued by insurance companies and banks which are not transferable but provide for benefit-responsive withdrawals by Plan participants at contract value, and (b) alternative investment contracts consisting of investments together with contracts under which a bank or other institution provides for benefit-responsive withdrawals by Plan participants at contract value. For fully benefit-responsive investment contracts included in the VRST, contract value is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined contribution plan.

The Plan holds an investment in the Prudential Core Plus Bond Fund Class 12. This Fund was established by the collective trust of Prudential Trust Company as a vehicle to invest in a diversified portfolio of debt securities. The Fund will be invested primarily in fixed income securities in the U.S. investment grade sectors, as well as U.S. fixed income securities rated below investment grade, the debt of developed international markets and the debt of emerging markets. The Fund may also invest in fixed income comingled vehicles. The fund is valued at unit value.

The Plan holds an investment in the Columbia Trust Dividend Income Fund Institutional 1 Fund. The fund primarily invests its net assets (including the amount of any borrowings for investment purposes) in a diversified portfolio of income-producing (dividend-paying) equity securities, which will consist primarily of common stocks but also may include preferred stocks and convertible securities. The fund may also invest up to 20% of its net assets in debt securities, including securities that, at the time of purchase, are rated below investment grade or are unrated but determined to be of comparable quality. The fund may also invest up to 20% of its net assets in foreign securities. The fund may invest in derivatives, including futures, forwards, options, swap contracts and other derivative instruments. The investment option is a collective investment trust, managed by Ameriprise Trust Company. The fund is valued at unit value.

The Plan holds an investment in the AB US Large Cap Growth Collective Investment Fund (W Series) Class L (the "Underlying Fund") of the AB Collective Investment Trust Series. It invests primarily in large-

cap US stocks and may invest in non-US securities. This investment option is a collective investment trust, managed by Wilmington Trust, N.A. The fund is valued at unit value.

The Plan holds an investment in the BlackRock MidCap Growth Equity Fund Class L1. The Fund invests solely in the MidCap Growth Equity Fund F (the "Underlying Fund"). The underlying fund invests and reinvests in a portfolio primarily consisting of equity securities issued by U.S. mid-capitalization companies. The investment option is a collective investment trust, managed by Wilmington Trust, N.A. The fund is valued at unit value.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

3. Fair Value Measurements

Accounting Standards Codification topic ("ASC") 820, Fair Value Measurements and Disclosures, defines fair value, and establishes a framework for measuring fair value in US GAAP and disclosing fair value measurements. It also applies under other accounting pronouncements that require or permit fair value measurements.

The fair value hierarchy for disclosure of fair value measurements under ASC 820 is as follows:

- Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Quoted prices, other than quoted prices included in Level 1, that are observable for the assets or liabilities, either directly or indirectly.
- Level 3: Valuation inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during 2024 and 2023.

- Mutual funds: Valued at quoted prices (unadjusted) in an active market at year-end.
- Self-directed brokerage accounts: Self directed brokerage accounts include cash and mutual funds, which are valued at quoted prices (unadjusted) in an active market of the underlying investments held by the Plan at year-end.
- Common collective trust funds: The fair value of the common collective trust funds are determined by the custodian of the common collective trust funds based on the underlying assets, which represent the net asset value, a practical expedient to fair value, of units held by the Plan. The Plan

does not have any unfunded commitments relating to its investment in the common collective trust fund, or any significant restrictions on redemptions. Participant directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in shares of mutual funds managed by Fidelity Management Trust Company ("Fidelity" or the "Trustee"). Fidelity acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Total administrative expense paid by the Plan to parties-in-interest amounted to \$165,688 and \$88,958 for the years ended December 31, 2024 and 2023, respectively.

Fidelity receives revenue from certain investments in the Plan. Fidelity and the Employer have agreed that if this revenue exceeds an agreed upon revenue rate, Fidelity shall make an amount equal to such excess available to the Plan to pay ERISA qualified plan administrative expenses. For the years ended December 31, 2024 and 2023, an excess of \$38,571 and \$36,253, respectively, was made available to the Plan. No revenue was used to pay for ERISA qualified plan administrative expenses, or allocated to participant accounts for the years ended December 31, 2024 and 2023, respectively. The remaining balance available to pay future expenses was \$91,433 and \$49,075, respectively, as of December 31, 2024 and 2023.

5. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required schedule is in complete and accurate:

6. Income Tax Status

The Plan received a determination letter from the Internal Revenue Service dated February 8, 2018, maintaining that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator and the Plan's counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that would not meet the more likely than not standard and be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
