Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for

one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the 403(B) Thrift Plan of Delta Area Economic Opportunity Corporation's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the 403(B) Thrift Plan of Delta Area Economic Opportunity Corporation's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedules on pages 12 - 13, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements
For the Years Ended December 31, 2024 and 2023

NOTE A: DESCRIPTION OF THE PLAN

The following description of 403(b) Thrift Plan of Delta Area Economic Opportunity Corporation ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is the retirement plan provided for employees of Delta Area Economic Opportunity Corporation ("Agency").

- 1) General - The Plan was restated effective December 1, 2013. The Plan is a defined contribution plan covering all employees of Delta Area Economic Opportunity Corporation. The Plan is subject to the provisions of the Employee Retirement Income Security Act. The Board of Directors is responsible for oversight of the plan.
- 2) Contributions - Each year, participants may contribute as much as they want of pre-tax or Roth annual compensation, as defined in the Plan, up to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The employer will contribute a fixed match equal to 100% of each participants' contributions up to 3% of their compensation. They will also contribute a base contribution equal to 2% of each participants' compensation. Participants hired after January 1, 2020 are automatically enrolled in the plan, unless they decline, and have 3% withheld from their pay.
- 3) Participant Accounts - Each participant's account is credited with the participant's contribution and Agency matching and base contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) Vesting - Participants are vested immediately in their contributions plus actual earning thereon. Vesting in the Company's portion of their accounts is based on the number of years of service. The plans vesting schedule is as follows: Years of Service: 0-1= 0%, 2 = 50%, 3 = 75%, 4 or more = 100%. Vesting is not continuous service; break-in-service rules are recognized.

NOTE A: DESCRIPTION OF THE PLAN (Continued)

- 5) Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or rollover amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of their account as a lump sum distribution or rollover. The Plan will make a mandatory distribution of the participant's account if the value of the participant's account is \$7,000.00 or less. If the value of the participant's account is more the \$7,000.00, distribution of the Plan account cannot be made before the normal retirement date of the participant without their written consent.

- 6) Participant Loans - Participants may be granted a loan of up to 50% of the present value of the non-forfeitable accrued benefit of the Participant under the Plan. Loans cannot exceed \$50,000.00 and may not be less than \$1,000.00. The loan must be repaid in five years and loan payments are made through after-tax payroll deductions. The interest on the loan will be determined by the administrator based on a review of interest rates charged for similar types of loans by other lenders, and is recorded under generally accepted accounting principles in the United States of America. The Plan had loans outstanding at December 31, 2024 and 2023 in the amount of \$110,258.36 and \$68,398.19, respectively.

- 7) Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$48,268.05 and \$5,985.19 respectively. These accounts are used to reduce employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$6,004.49 and \$47,251.90 from forfeited nonvested accounts.

NOTE B: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at estimated fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and Sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefit payments are recorded when paid.

NOTE B: SIGNIFICANT ACCOUNTING POLICIES (Continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Agency. Expenses that are paid by the Agency are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution under the terms of the plan document, the participant loan balance is reduced and a benefit payment is recorded.

NOTE C: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

NOTE D: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE D: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts (PSAs) of the custodian invest in registered investment companies, which are invested in debt and equity securities of U.S. and foreign companies at various levels of market capitalization. Units held in PSAs are valued using the NAV of the fund. The NAV is based on fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. Accordingly, the unit value for pooled separate accounts is classified outside of the valuation hierarchy, but is included below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

Collective Investment Trusts: Collective investment trusts (CITs) invest in registered investment companies, which are invested in debt and equity securities of U.S. and foreign companies at various levels of market capitalization. Units held in CITs are valued using the NAV of the fund. The NAV is based on fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. Accordingly, the unit value for CITs is classified outside of the valuation hierarchy, but is included below to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

Interest Accumulation Account: The IAA is valued at fair value as of the last day of the Plan year. Fair value approximates contract value and is the total of all amounts allocated under the contract through contributions plus accrued interest, minus withdrawals, transfers and administrative charges. Amounts allocated to the IAA become part of the general assets of the custodian (General Account). The General Account supports insurance and annuity obligations of the custodian. The General Account consists of all general assets, other than those in separate accounts and other segregated asset accounts of the custodian. The custodian guarantees the value and bears full investment risk for all amounts that participants allocate to the General Account. The custodian guarantees a minimum interest credit, which was 2.85% at December 31, 2024. Interest is credited on dates determined by the custodian, but not less frequently than once each calendar month. Accordingly, this investment is classified within the level 3 of the valuation hierarchy.

Stable Value Fund: The stable value fund is valued at fair value as of the last day of the Plan year. Fair value approximates contract value and is the total of all amounts allocated under the contract through contributions plus accrued interest, minus withdrawals, transfers and administrative charges. Amounts allocated to the stable value fund become part of the general assets of the custodian (General Account). The General Account supports insurance and annuity obligations of the custodian. The General Account consists of all general assets, other than those in separate accounts and other segregated asset accounts of the custodian. The custodian guarantees the value and bears full investment risk for all amounts that participants allocate to the General Account. The custodian guarantees a minimum interest credit, which was 2.30% at December 31, 2024. Interest is credited on dates determined by the custodian, but not less frequently than once each calendar month. Accordingly, this investment is classified within the level 3 of the valuation hierarchy.

NOTE D: FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Accordingly, the unit value for the mutual funds is classified within level 1 of the valuation hierarchy.

NOTE E: PLAN TERMINATION

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Plan account.

NOTE F: RELATED PARTY/PARTY-IN-INTEREST TRANSACTIONS

The plan also has the following service providers: Jarred, Gilmore, and Phillips, PA is the plan auditor, Delta Area Economic Opportunity Corporation is the plan sponsor, and Lincoln Financial Group is the third party administrator.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H: PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, there were multiple pay periods that resulted in contributions being delinquent. The total amount of delinquent contributions was \$86.40.

NOTE I: SUBSEQUENT EVENTS

The Plan evaluated events and transactions occurring subsequent to December 31, 2024, through October 10, 2025, the date the financial statements were available to be issued. During this period, there were no subsequent events requiring recognition in the financial statements. Additionally, there were no nonrecognized subsequent events requiring disclosure.
