### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the financial statements of Wayne Memorial Defined Contribution 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Wayne Memorial Defined Contribution 403(b) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, and a certification from an agent on behalf of a qualified institution, as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### ***Disclaimer of Opinion***

We do not express an opinion on the accompanying financial statements of Wayne Memorial Defined Contribution 403(b) Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### ***Basis for Disclaimer of Opinion***

As described in *Note 10* to the financial statements, Wayne Memorial Defined Contribution 403(b) Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

### ***Responsibilities of Management***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Wayne Memorial Defined Contribution 403(b) Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities***

**Note 1. Description of the Plan**

***General***

The following description of Wayne Memorial Defined Contribution 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions, which is available from the plan administrator.

The Plan is a defined contribution plan covering employees of Wayne Memorial Hospital and affiliates (collectively, the "Hospital"). Nonexcluded employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Hospital. Participants are required to attain age 20½, have completed six months of service, and worked 1,000 hours during the plan year to qualify for the Plan's discretionary employer contributions. Employees who participate and accrue benefits in the Wayne Memorial Hospital Pension Plan, a defined benefit plan, are not eligible to participate in the Plan's employer contributions.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). During 2024 and 2023, Hand Benefits & Trust Company (until October 7, 2024); UMB Bank, n.a. (until September 30, 2024); Matrix Trust Company; Fiduciary Trust International of the South, a subsidiary of Franklin Templeton Investments (until investments were transferred to Matrix Trust Company on May 25, 2023); Transamerica Financial Life Insurance Company, Inc.; TI-Trust, Inc.; and Everlake Life Insurance Company served as custodians of the Plan.

***Plan Restatement and Change in Custodian and Recordkeeper***

Effective October 1, 2024, the Plan was amended and restated ("Plan Amendment") and Empower Trust Company, LLC, replaced Hand Benefits & Trust Company and UMB Bank, n.a., as custodian, and Empower Retirement, LLC, became the recordkeeper for those custodial accounts.

Plan assets transferred to the new custodian were transferred into funds comparable to those offered by the previous custodian. The conversion initiated a "Black Out" period beginning the week of September 23, 2024, through the week of October 27, 2024. During this period, funds cannot be diversified or withdrawn from the Plan until the new recordkeeper has time to accurately complete the conversion. During this time, employee contributions continues to be made through payroll deductions and were deposited and held in a holding account until completion of the Black Out period. At the end of the Black Out period, these funds were invested in the funds requested by each participant or mapped into equivalent funds as previously elected by the participant at the previous custodian.

***Contributions***

The Plan permits eligible employees to have the Hospital make annual contributions of up to 100% of eligible compensation, through a salary deferral election, not to exceed the limits imposed by the Internal Revenue Code (IRC). Employee rollover and employee Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Plan provides for employer discretionary matching contributions and discretionary nonelective contributions as determined by the Hospital's Board of Directors. For 2024 and 2023, the Hospital made nonelective contributions of 3% of eligible compensation and matching contributions of 50% of participants' contribution up to 6% of compensation. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing contributions into any of the investment account options offered by the Plan and may change the allocation to the extent permitted by the individual investment contract agreements.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Hospital's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans held by Empower and Hand Benefits & Trust Company is based on the prime rate plus 1%. Interest on the loans held by Lincoln Investment Planning, LLC is based on the prime rate plus 2% as of the first business day of each calendar quarter. A loan may be repaid in full as of any date without penalty.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Hospital's contribution portion of their accounts plus earnings thereon is based on years of credited service. A participant is fully vested after three years of credited service or upon reaching age 65 while actively employed. Upon termination of service due to death or disability, a participant's account is also fully vested.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his account, installments, or various annuity options. Hardship withdrawals and in-service withdrawals are also permitted, as defined in the plan document.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$52,707 and \$13,487, respectively. Forfeited nonvested accounts may be used to pay plan expenses or reduce future employer contributions. Forfeitures of \$0 and \$13,626 were used to reduce Hospital contributions for the plan years ended December 31, 2024 and 2023, respectively. During 2024 and 2023, no plan expenses were paid from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Variable annuities are valued at estimated fair value as provided by Everlake Life Insurance Company.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Hospital or the Plan, at the Hospital's discretion.

**Note 3. Certification of Plan Custodians and Custodian's Agent**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC; Hand Benefits & Trust Company; UMB Bank, n.a., by its authorized agent Lincoln Investment Planning, LLC; Fiduciary Trust International of the South, a subsidiary of Franklin Templeton Investments; Matrix Trust Company; and Transamerica Financial Life Insurance Company, Inc., all qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the custodians or their affiliates. The Plan paid \$241,578 and \$245,386 of direct administrative fees to custodians and investment advisors during 2024 and 2023, respectively. The Plan also paid \$3,479 and \$6,558 of administrative fees to Lincoln Investment Planning, LLC (Lincoln) during 2024 and 2023, respectively. These fees are included in investment income as reported by Lincoln. The Hospital provides certain administrative services at no cost to the Plan and pays certain administrative fees on behalf of the Plan.

**Note 5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

***Recurring Measurements***

(A) Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts included above are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

***Investments Measured Using the Net Asset Value per Share Practical Expedient***

The value of the Plan’s variable annuities is determined using net asset value (or its equivalent) as a practical expedient. Variable annuities invest primarily in mutual funds that invest in fixed income, domestic, international, and income funds and are intended to align with various stock indexes. As of December 31, 2024 and 2023, there were no unfunded commitments associated with these investments and each may be redeemed daily.

**Note 6. Investment Contracts with Insurance Companies**

The Plan has a fully benefit-responsive investment contract with MetLife Insurance & Annuity Company of Connecticut (MetLife). MetLife maintains the contributions in the Met Managed GIC in a MetLife separate account. The Plan also has investment contracts with Transamerica Financial Life Insurance Company, Inc. (Transamerica), the Transamerica fixed funds. Transamerica maintains the contributions to the fixed funds in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contracts are fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by MetLife and Transamerica, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

The guaranteed investment contracts permit the insurance companies to terminate the agreements under certain circumstances with 60 days' written notice.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

## **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 8. Plan Termination**

Although it has not expressed an intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**Note 9. Plan Tax Status**

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan previously adopted a pre-approved volume submitter 403(b) plan document sponsored by Benefit Plans Administrative Services LLC, and was restated effective October 1, 2024, by adopting a pre-approved volume submitter 403(b) plan document sponsored by Empower Retirement LLC. Therefore, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Annuity and Custodial Accounts Excluded from the Financial Statements**

As permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*, (FAB 2009-02), the plan administrator has elected to exclude certain annuity and custodial accounts from the Plan's financial statements. These contracts and custodial accounts were limited to employee contributions held under a voluntary 403(b) plan arrangement prior to January 1, 2009. The amount of the excluded annuity and custodial accounts at December 31, 2024 and 2023, the related income and distributions for the years then ended could not reasonably be determined.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through October 13, 2025 which is the date the financial statements were available to be issued.
