## Independent Auditors' Report

### 1. Plan Description

The following description of the Presence Marketing, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering eligible employees of Presence Marketing, LLC and Affiliates (the "Company" or "Employer") who have 1 month of service, have attained the age 21, and are not excluded employees. Excluded employees include non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute up to 85% of their eligible compensation, as defined in the Plan document, on a pre-tax or after-tax (Roth) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from their eligible compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The auto-enrollment provision of the Plan was amended effective January 1, 2024, to provide that all newly eligible employees are automatically enrolled in the Plan at a deferral rate of 3% of eligible compensation, unless they affirmatively elect not to participate in the Plan, and their contributions are invested in a designated balanced fund until changed by the participant. All participants who are automatically enrolled will have their deferral percentages increased by 1% each year up to a maximum of 6%.

During the year ended December 31, 2024, the Company matched 100% of each participant's first 4% of contributions for the Plan year for eligible employees. The Employer may also make a discretionary nonelective contribution to the Plan. During 2024, no discretionary nonelective contributions were made to the Plan.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company matching contributions and allocations of Plan earnings (losses) thereon. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Plan Description (*continued*)

#### ***Vesting***

Participants are fully vested in their contributions plus actual earnings thereon. Vesting in the Employer contributions portion of their accounts plus earnings thereon is based on years of continuous service, as defined in the Plan document. A participant vests at a rate of 20% per year of credited service and is 100% vested after five years of credited service.

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,938 and \$1,904. These accounts may be used to reduce future Employer contributions or pay Plan expenses. During 2024, forfeitures of \$12,451 were used to reduce Employer contributions. During 2024, no forfeitures were used to pay Plan expenses.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$500 up to a maximum amount of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Loans are repaid through payroll deductions over a period of between one and five years, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a thirty-year period. A participant can only have 1 loan outstanding from the Plan at a time.

#### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or installments. Alternately, participants can choose to defer receipt of their distribution until, by law, minimum distributions are required. However, if a participant's vested balance is \$5,000 or less the balance will be distributed in a lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest as a lump sum distribution. In-service withdrawals of vested balances may be elected by participants who have reached 59 ½ years of age.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need. Additionally, the minimum amount for a hardship distribution is \$500 and the participant must be an active employee.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”); contributions and investment income are recognized when received and disbursements are recognized when made, except for investments and their related gains or losses, which are reflected at fair value. The Plan has determined that the modified cash basis of accounting is an acceptable basis for preparation of the financial statements in the circumstances. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets of the Plan in conformity with U.S. GAAP.

#### ***Use of Estimates***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, all of the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus unpaid accrued interest. Defaulted notes receivable from participants are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefit when a distributable event occurs.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are paid by the Plan and are included in net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### 4. Party-In-Interest Transactions

Reliance Trust Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the Company and Reliance Trust Company. Reliance Trust Company receives revenue from mutual fund service providers for services Reliance Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Reliance Trust Company for its administrative services to the Plan. If the revenue received by Reliance Trust Company from such mutual fund service providers exceeds the amount owed under the MSA, Reliance Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The balance in the plan expense account at December 31, 2024 and 2023 was \$107,817 and \$79,635. During 2024, there was \$85,485 remitted to the Plan. Fees paid by the Plan for administrative expenses to Reliance Trust Company for the year ended December 31, 2024 were \$62,171.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 4. Party-In-Interest Transactions (*continued*)

Certain employees of the Company, who may be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

### 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 6. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the prototype document preparer by a letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 7. Risk and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
