Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Construction Industry 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements of information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* Section –

Notes to Financial Statements

1. Description of Plan

The following description of the Construction Industry 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a multiple employer, profit-sharing, 401(k) salary-deferred thrift plan covering all eligible non-bargaining class employees of the participating employers. The Plan, established effective January 1, 1997, and restated effective January 1, 2013, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Participants are considered eligible for all contribution types upon completion of one year of service and attaining age 21. Each year, participants may contribute a portion of their pretax annual compensation, as defined in the Plan, subject to certain limitations under the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan Year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans and certain IRAs (“rollover contributions”).

For work performed by participants that are subject to prevailing wage laws, the participating employers are required to contribute based on a fringe-benefit rate that satisfies the prevailing wage laws (“prevailing wage contribution”). Matching contributions equal to a percentage of a participant’s elective deferral contributions are determined by the individual participating employers. Additional amounts may be contributed at the option of the individual participating employers. Contributions are subject to certain limitations.

Participant Accounts – Individual accounts are participant directed and are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant’s share of Plan earnings. Participant accounts are decreased by participant distributions and the participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based on the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions, for any employer prevailing wage contributions, employer safe-harbor contributions and rollover contributions and actual earnings thereon. Vesting in all other employer contributions plus earnings thereon is based on years of continuous service and occurs at a rate of 20% per year. A participant is 100% vested after five years of credited service.

Construction Industry 401k Plan

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Forfeitures – In years ended December 31, 2024 and 2023, forfeitures from non-vested accounts totaled \$2,857 and \$1,802, respectively. These amounts can be used to reduce future employer contributions or to pay certain plan expenses. Forfeitures used to reduce employer contributions and pay certain plan expenses totaled \$302 and \$3,149 in years ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants – In accordance with Plan provisions, participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, in \$1,000 increments. The notes are secured by the balance in the participant’s account and bear interest at a variable rate. The term of the loan may not exceed five years unless the loan is for a principal residence in which a longer repayment term may be permitted.

Payment of Benefits – Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or various life annuities. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service distributions for participants who have attained the age of 59½ from accounts which are 100% vested.

Income Taxes – The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the prototype plan is qualified under Section 401 of the Internal Revenue Code. The Plan has been amended since the effective date of the IRS letter. However, the Plan Administrator believes that the Plan is operating in compliance with the requirements of the Code. Accordingly, no provision for income taxes have been included in the accompanying financial statements.

Plan Termination – Although they have not expressed any intent to do so, the participating employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts and their vested account balance would be distributed.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on an ex-dividend date, if received. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as those held during the year.

Investment Risks and Uncertainties – The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statement of net assets available for benefits.

Participant Notes Receivable – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. The Plan had excess contributions payable for years ended December 31, 2024 and 2023 totaling \$3,648 and \$6,603, respectively. Such amount is included in payables in the statements of net assets available for benefits.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Investment-related expenses are included in net investment gain from pooled separate accounts and stable value fund. Expenses to maintain the Plan are included in administrative expenses and charged directly to participant accounts.

Party-in-Interest Transactions – Plan investments include a stable value fund and pooled separate accounts managed by Transamerica. Transamerica is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act – On December 29, 2022, the SECURE 2.0 Act was signed into law to address various retirement issues. SECURE 2.0 Act includes provisions to help participants increase retirement savings and simplify and clarify certain retirement plan rules. SECURE Act 2.0 increases the age for RMDs to age 73, effective January 1, 2023, and increasing it to age 75 by 2033. Plan management is currently reviewing SECURE 2.0 provisions and will amend the plan as required.

Subsequent Events – Plan management has evaluated subsequent events through October 14, 2025, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. Also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Interest bearing cash – This is stated at cost, which approximates fair value.

Pooled Separate Accounts – The Plan invests in various Pooled Separate Accounts (“PSA”) offered by Transamerica Life Insurance Company (“Transamerica”) that utilize a variety of investment managers. This variety allows participants to select the options that best reflect their investment style – from conservative to aggressive. Underlying assets in the PSAs include a variety of fixed maturity securities, mutual funds, equity securities, and cash and cash equivalents. PSAs are valued daily using publicly available quoted market prices. Those PSAs investing in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets (Level 1 inputs). Those PSAs directly investing

in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities (Level 2 inputs). Net change in fair value is reflected by net increase/decrease in investment unit values. Such increases/decreases include interest, dividends, realized and unrealized gains/losses from the underlying investments.

In determining unit values, PSAs begin with a specified unit price determined by Transamerica, and the number of units issued are calculated to match the current fair market value of the underlying investment (shares x price). This is known as unitizing the underlying assets. However, the rate of return of each will be consistent, taking into account any plan/participant expenses. PSA fair values are determined daily. Participants can redeem their investment in PSAs daily without restriction.

5. Guaranteed Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract, Transamerica Stable Value Core Option Account ("Stable Value account"), with Transamerica. Transamerica maintains the contributions in a general account. The Stable Value account seeks to protect against any loss of principal while providing returns in excess of money market funds and U.S. Treasury bills. The Stable Value account provides a guaranteed interest rate for a specified period of time. The rate credited is based on a formula established by Transamerica and has no minimum or maximum interest rate. The credited interest rate is reviewed on a semi-annual basis for resetting. Interest is credited based upon the daily balance at a rate that is the daily equivalent of the effective annual rate of interest applicable for the semi-annual period.

Notes to Financial Statements (continued)

5. Guaranteed Investment Contract with Insurance Company (continued)

Because the Stable Value account meets the criteria to be considered fully benefit-responsive, it is reported at contract value. Contract value is the relevant measurement attribute as contract value is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. The contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value on a daily basis.

The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Stable Value account at December 31, 2024 and 2023 was \$314,670 and \$620,861 respectively.

Certain events might limit the ability of the Plan to transact at contract value with Transamerica. Such events include amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination of the contract. The Plan Administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with Transamerica and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow Transamerica to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of a material obligation under the contract, a material misrepresentation or a material amendment to the agreement without the consent of Transamerica.

6. Transfer to Other Plans

During year ended December 31, 2024, James M. Stafford, Inc., who was a participating employer, transferred assets out of the Plan to another qualifying plan totaling \$11,248.

7. Reconciliation with Form 5500

The accompanying financial statements, which are prepared in accordance with U.S. GAAP, calculate realized gains and losses on sales of securities and unrealized gains and losses (change in market value on securities held at year-end) using historical cost. However, Form 5500, Annual Return/Report of Employee Benefit Plan, requires the calculation of such gains and losses to be measured on the basis of revalued cost on Schedule H. Revalued cost is calculated based on the market value of a security on the first day of the fiscal year plus the cost of any current year purchases, less the beginning market value of any current year sales. In total, however, the financial statement calculation of gains and losses and the calculation for Form 5500 are the same.

In addition, notes receivable from participants of \$27,346 as of December 31, 2024, are reported as receivables in the financial statements; however, they are reported as investments on Schedule H of Form 5500.
