Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Jackson Walker L.L.P. Partners Cash Balance Plan IV (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the statement of accumulated plan benefits as of December 31, 2023 and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

General

The Jackson Walker L.L.P. Partners Cash Balance Plan IV (the “Plan”) is a defined benefit cash balance plan covering partners of Jackson Walker, L.L.P. (the “Firm” or “Employer”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan was established on January 1, 2022 and is funded entirely by contributions in a Trust Fund by the Firm. The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Plan Administration

The Plan is administered by the Management Committee (collectively the “Committee”) appointed by the Firm. Charles Schwab Trust Bank (the “Trustee”), serves as trustee of the Plan and provides custodial and recordkeeping services.

Participation and Eligibility

An eligible employee is an equity partner who is actively providing service for the Firm as of December 31, 2024 (“Effective Date”). An equity partner shall become a participant on the later of (i) the Effective Date, (ii) the attainment of age 21 and the first anniversary of their employment date or (iii) the date the employee becomes a member of the class of Eligible Employees.

Once an Eligible Employee becomes a participant in the Plan, they shall continue to participate in the Plan while they provide services for the Firm as an Eligible Employee.

If a participant has not terminated from service but ceases to be an Eligible Employee, such participant shall become an inactive participant in the Plan. An inactive participant shall not receive cash balance credits. However, inactive participants shall continue to receive credit for vesting for each included year of service and earnings credits. If an excluded employee who is not a participant becomes eligible to participate in the Plan by reason of a change in employment classification, they will participate in the Plan immediately if they have satisfied the minimum service requirement and would have otherwise previously become a participant.

Funding Policy

The Firm’s policy is to make annual contributions based on calculations of an independent actuary in an amount at least sufficient to satisfy minimum funding requirements. Participants may not contribute to the Plan. The Firm’s contributions for the years ended December 31, 2024 and 2023 met the minimum funding requirements of ERISA.

Participant’s Accounts

For each year of benefit service, the cash balance account will be credited with a cash balance credit based on the approved plan formula described below. Under the Plan provisions, amounts are credited by the Employer to the participants’ hypothetical accounts. The maximum cash balance credit is determined in accordance with the provisions of the Plan document and various Internal Revenue Service (“IRS”) rules and regulations as follows:

$\$1,600 \times (\text{Partner Points} - 30) \times \text{Multiplier}$, but in no event less than \$8,000 nor greater than the maximum cash balance credit. Partner Points represent the equity partner’s budgeted income set by the Firm for the calendar year divided by 10,000. The approved multiplier will be 100% unless prescribed at 25%, 50%, 150% or 250% as authorized by the Firm.

The participants' hypothetical accounts also receive earnings/investment credits. Earnings are credited daily based upon the rate of return earned on Plan assets. The maximum earnings credit shall be the amount determined by applying a 5% annualized rate of return to the maximum account as of the beginning of the day.

The Committee authorizes contributions from the Firm into the Plan.

Vesting

For purposes of vesting, a participant shall always have a 100% non-forfeitable interest in their cash balance account upon participation in the Plan.

Actuarial Method

The Plan obtains an actuarial valuation each year from an independent third-party actuary. The valuation is used to determine whether anticipated benefits may reasonably be provided from anticipated contributions when combined with existing assets of the Plan.

Payment of Benefits

Benefits are determined based on the greater of the participant's hypothetical account balance or the participant's actuarial equivalent account balance, as defined. A participant is entitled to a distribution of the entire cash balance account if employment is continued beyond the attainment of age 59½.

Upon termination or retirement, although the Plan is designed to communicate the value of the participant's benefit as the cash balance account, the form of benefit distribution is a Qualified Joint & Survivor Annuity or a lump sum, as defined. The amount of the annuity is the actuarial equivalent of the cash balance account.

If a participant dies after his or her Normal Retirement Date, but prior to retiring on his or her Postponed Retirement Date, his or her beneficiary shall be entitled to benefits under the Plan, as defined. If unmarried or if a designated beneficiary other than a spouse, the benefit payable upon death is a lump-sum payment equal to the cash balance account.

Expenses

The Plan Administrator shall be entitled to reimbursement out of the Trust Fund for its reasonable expenses properly and actually incurred in the performance of its duties in the administration of the Plan provided that the Firm in the discretion of the Firm may pay such expenses. Expenses that are paid by the Firm and not anticipated to be reimbursed out of the Trust Fund, are excluded from these financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ significantly from those estimates.

Funding Policy

The Firm will contribute to the Trust Fund such sums and at such times as may be determined in accordance with the funding method and policy which are consistent with Plan objectives. All contributions when made to the Trust Fund and all property and funds of the Trust Fund, including income from investments and from all other sources, will be retained for the exclusive benefit of participants, spouses and beneficiaries included in the Plan and will be used to pay benefits provided hereunder or to pay reasonable expenses of administration of the Plan and the Trust Fund to the extent not paid by the Firm.

Benefits Payments

Benefits are recorded when paid.

NOTE 3 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions to employees for services they have rendered as of the valuation date. The actuarial present value of accumulated plan benefits is determined by the Plan's actuary based on the beginning of year election and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the present value of future payments (through discounts for interest) and the probability of payment (by means of decrements for events such as death, withdrawal, or early retirement) between the valuation date and the expected date of payment. The effect of Plan amendments is recognized during the year in which such amendments become effective.

The significant actuarial assumptions used in the valuation as of December 31, 2023 are as follows:

The foregoing actuarial assumptions are based upon the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuation been performed as of December 31, 2023, there would be no material differences.

NOTE 4 - FINANCIAL INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- Cash and investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, part iv, line 4i - schedule of assets (held at end of year) as of December 31, 2024.
- Schedule H, part iv, line 4j - schedule of reportable transactions for the year ended December 31, 2024.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan utilizes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023. Although management believes the valuation methods used by the Plan are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date:

Interest Bearing Cash - Interest bearing cash is valued at amortized cost and is highly liquid.

Money Market Fund - The money market fund is valued at the closing price reported on the active market on which the fund is traded.

Exchange Traded Fund - Exchange traded funds are valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are open-end exchange funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The exchange traded fund held by the Plan is deemed to be actively traded.

Government Agency Obligations - Government agency obligations are valued using market-based models, which consider yield, price of comparable securities, coupon rate, maturity, credit quality and dealer-provided prices. Fixed income securities, other than U.S. Treasury securities, generally do not trade on a daily basis. The fair value estimates of such fixed income securities are based on observable market information rather than market quotes as of the measurement date. Accordingly, the estimates of fair value for such fixed income securities, as provided by the pricing service, are included in Level 2 of the hierarchy. U.S. Treasuries are generally included in Level 1 of the hierarchy when values are based on unadjusted market prices as of the measurement date.

NOTE 6 - TAX STATUS OF THE PLAN

The Plan has applied for an IRS determination letter. The Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The investment allocation of the Plan is directed by the Firm. Such investments are exposed to various risks, such as interest rate, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term could materially affect the amount reported in the statements of net assets available for benefits and the funding status of the Plan.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported on certain assumptions pertaining to interest rates and employee demographics, all of which are subject to change due to uncertainty inherent in the estimations and assumptions process. It is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

NOTE 8 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Charles Schwab Trust Bank serves as the trustee and custodian for the Plan. Cash held by the Trustee was \$2,706,156 and \$7,561,634 as of December 31, 2024 and 2023, respectively. Certain Plan investments are managed by affiliates of the Trustee.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, distribution of the Plan assets shall be made to the participants according to the provisions in the Plan document. If the Plan is terminated, a portion of those benefits are insured by the Pension Benefit Guaranty Corporation ("PBGC"). Whether a particular participant's accumulated plan benefits will be paid depends on both the priority of those benefits and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guarantee, while other benefits may not be provided for at all.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14 2025, the date the financial statements were available to be issued.

The Cash Balance Account, or its actuarial equivalent payable as an annuity, subject to IRS maximums. Benefits are payable immediately following termination of employment or while in service for participants who have reached age 59.5.

VESTING

Each participant is always 100% vested in his or her Cash Balance Account.

STATUTORY LIMITS

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.
