INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chadron Community Hospital and Health Services Employees' Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chadron Community Hospital and Health Services Employees' Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Chadron Community Hospital and Health Services Employees' Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Chadron Community Hospital and Health Services Employees' Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 PLAN DESCRIPTION

The following description of Chadron Community Hospital and Health Services Employees' Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective August 1, 1974. The Plan is a money purchase plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the sponsor and trustee – Chadron Community Hospital and Health Services. The Plan covers employees of Chadron Community Hospital and Health Services (Company). Third party administrators maintain the records of the participant data and hold the Plan assets.

Eligibility

Employees who have completed one year of service, defined as a 12 consecutive month period during which the employee completes 1,000 or more hours of service are eligible to participate in the Plan. Eligibility dates are the first day of each month following the month that all eligibility requirements are met.

Contributions

The Company contributes a matching contribution of up to 3% of participant's contribution, equal to the participant's deferral percentage made to the Chadron Community Hospital and Health Services Tax Deferred Annuity Plan.

Employer contributions will not be made to a participant in any plan year in which the participant does not complete 1,000 hours of service, except that a participant who has died or retired during the Plan year shall receive a contribution.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

Payment of Benefits

On termination of employment, death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum payment, or installment payments, or annuity payments. Distribution of benefits upon termination become automatic if the participant's account balance is less than \$7,000. Participants must attain age 65 to qualify for in-service distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

Participant Accounts

Each participant's account is credited with the employer's matching contribution and allocations of plan earnings and expenses. Plan earnings and expenses are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' Investment Options

Participants must direct their matching contributions to selected investments as made available and determined by the Plan. Participants may change their investment options throughout the year by contacting the recordkeeper of the Plan, American United Life Insurance Company, a OneAmerica company.

Vesting

Participants are immediately vested in any rollover contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death and retirement. A participant is 100% vested after five years of credited service, which is defined as the completion of at least 1,000 hours of service during the plan year.

Forfeitures

Forfeited amounts are used to reduce future employer matching contributions. Employer contributions were reduced by \$9,508 and \$8,094 from forfeited non-vested accounts for the years ended December 31, 2024 and 2023, respectively. All forfeitures are used during the year leaving no remaining forfeitures at either December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions

Matching contributions from the Company are recorded in the year in which the employee contributions to the Chadron Community Hospital and Health Services Tax Deferred Annuity Plan are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

NOTE 3 TAX STATUS

The Plan adopted a non-standardized Money Purchase Plan sponsored by OneAmerica Financial Partners, Inc. The non-standardized plan has received an opinion letter dated November 30, 2020 from the Internal Revenue Service as to the non-standardized plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. The Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believe the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the custodian, American United Life Insurance (AUL).

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a group annuity contract with AUL which consists of a fixed component and a variable component. The fix component meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for a fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. The contract value of the investment contracts at December 31, 2024 and 2023 was \$703,988 and \$780,218, respectively.

AUL maintains the contributions in a general account. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The guaranteed interest rate is based on a formula

agreed upon with the issuers, but may not be less than 4.00%. Such interest rates are reviewed on a quarterly basis for resetting. Participants may transfer funds every 90 days and are limited per contract year to 20% of the participant's account value as of the first day of the Plan year unless the participant's balance is less than \$2,500. Effective October 2021, contributions into the AUL Fixed Account were frozen. Future contributions are into the AUL Stable Value Account which carries a minimum interest rate of 1.50%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The variable components are invested in pooled separate accounts which are valued as described in Note 6.

NOTE 6 FAIR VALUE MEASUREMENT

Financial Accounting Standards Board Statement ASC Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:
Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any assets to be classified within the fair value hierarchy table. See *Investments Measured Using the Net Asset Value per Share Practical Expedient* in the following table to reconcile investments at fair value on the Statements of Net Assets Available for Benefits.

NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

Plan investments are shares of pooled separate accounts and benefit-responsive investment contracts that are managed by AUL. AUL is a provider as defined by the Plan and, therefore, qualify as party-in-interest transactions. Investment management fees are paid by the Plan participants as part of the investment purchase price pursuant to the contracts.

NOTE 8 AMENDMENT AND TERMINATION

Subsequent to year-end, the Plan has initiated steps toward termination. Management intends to terminate the Plan and transfer participant account balances into the Chadron Community Hospital and Health Services Tax Deferred Annuity Plan, which is also sponsored by the Company. The timing of the termination and related asset transfers has not yet been finalized, and it is uncertain whether the termination will be completed during the 2025 or 2026 plan year. Until the termination is executed and all assets have been distributed, the Plan will continue to operate in accordance with its current provisions. The financial statements continue to be presented on the accrual basis of accounting as the Plan termination request has not yet been approved by all the necessary parties, and the Plan remains subject to its ongoing provisions.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

Other than the information disclosed in Note 8, no other significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through October 14, 2025, which is the date these financial statements were available to be issued.
