## Independent Auditor's Report

To the Plan Committee and Participants  
Hanover Foods Corporation 401(k) Savings Plan  
Hanover, Pennsylvania

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Hanover Foods Corporation 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## **Basis for Opinion**

### **Note 1 - Description of Plan**

The following description of the Hanover Foods Corporation 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General**

The Plan is a defined contribution pension plan covering substantially all employees of Hanover Foods Corporation (the Company) who have 30 days of service and have attained age 21. Collective bargaining employees are not eligible to participate, except certain members of Local 152 of the United Food and Commercial Workers Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 25% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company shall match 50% of the participants' contributions, with a maximum match equaling 2.5% of the participants' eligible compensation contributed to the Plan. Participants must be employed on the last day of the plan year and have worked 1,000 hours during the plan year, or terminate service during the plan year due to death, disability, or retirement in order to receive the matching contribution. The 2024 employer matching contribution amounted to \$546,418. The 2023 employer matching contribution amounted to \$532,112, of which \$71,697 was in Series C Convertible Preferred Stock. The Company may make an additional discretionary profit-sharing contribution. The Company did not make a discretionary profit-sharing contribution during 2024 or 2023. Contributions are subject to certain IRS limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching contribution, as well as allocations of (a) the Company's profit-sharing contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence, in which case the loan may be up to thirty years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%, set the first day of each month. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon distribution, the fair value of any Series C Convertible Preferred Stock in a participant's account is disbursed in cash.

In addition, the Plan allows for hardship distributions if certain criteria are met.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,571 and \$67,499, respectively. These accounts will be used to pay administrative expenses or to reduce future employer contributions. Beginning January 1, 2024, amounts forfeited of the Series C Convertible Preferred Stock will be held in suspense until accumulated to a material amount for the plan sponsor to purchase back from the Plan. Forfeitures used to reduce employer contributions receivable totaled \$20,838 and \$75,561 as of December 31, 2024 and 2023, respectively.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully the benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Valuation of Investment in Convertible Preferred Stock**

There were 10,000 shares of Series C Convertible Preferred Stock held by the Plan at December 31, 2024 and 2023. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method.

#### **Valuation of Investment in Convertible Preferred Stock (continued)**

The estimated fair value of the investment in Series C Convertible Preferred Stock of the Company is determined based upon the results of an appraisal performed by an independent appraiser. As a result of the appraisal, the convertible preferred stock is valued at \$133.06 and \$128.29 per share at December 31, 2024 and 2023, respectively.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to the distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses.

### **Note 3 - Information Certified and Provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) and Newport Trust Company, LLC**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules related to certain investments and notes receivable from participants held as of December 31, 2024, and net appreciation in fair value of certain investments, interest and dividends, and interest income on notes receivable from participants for the period December 1, 2024 to December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Principal Trust Company, the custodian of the Plan.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules related to investments and notes receivable from participants held as of December 31, 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2023 to November 30, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Newport Trust Company, LLC, the former custodian of the Plan.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the Hanover Foods Corporation Series C Convertible Preferred Stock is determined based upon the results of an appraisal performed by an independent appraiser. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical projected cash flow and net income, return on assets, return on equity, market comparables, and fair value of the Company's assets and liabilities.

The Plan's interests in the collective trust fund (CTF) and pooled separate accounts (PSAs) are valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The CTF and PSAs are direct filing entities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5 - Fully Benefit-Responsive Investment Contract**

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, up to 3.00% but may not be less than 0.15%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- A. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- B. Premature termination of the contracts.
- C. Plan termination or merger.
- D. Changes to the Plan's prohibition on competing investment options.
- E. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- A. An uncured violation of the Plan's investment guidelines.
- B. A breach of material obligation under the contract.
- C. A material misrepresentation.
- D. A material amendment to the agreements without the consent of the issuer.

### **Note 6 - Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2010, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### **Note 6 - Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contribution portion of their account.

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The financial statements include Hanover Foods Corporation Series C Convertible Preferred Stock, whose value has been estimated by the plan administrator with the assistance of an independent valuation specialist in the absence of readily ascertainable market value. Because of the inherent subjectivity in any valuation, the estimated value may differ significantly from the value that would have been used had a ready market for the securities existed and the difference could be material.

### **Note 9 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are in pooled separate accounts and a guaranteed investment contract managed by Principal Life Insurance Company, an affiliate of Principal Trust Company. Principal Trust Company is the custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions.

The Plan invests in convertible preferred stock of the plan sponsor, Hanover Foods Corporation. These transactions qualify as party-in-interest transactions. All other transactions which may be considered parties-in-interest relate to normal management and administrative services, and the related payment of fees.

### **Note 10 - Prohibited Transactions**

During 2024, the plan sponsor inadvertently failed to deposit \$13,359 of participant deferrals within the required timeframe as stated by the United States Department of Labor regulations. The plan sponsor intends to reimburse the Plan for lost interest, file Form 5330, and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

During 2023, the plan sponsor inadvertently failed to deposit \$19 of participant deferrals within the required timeframe as stated by the United States Department of Labor regulations. The plan sponsor intends to reimburse the Plan for lost interest, file Form 5330, and pay the applicable excise tax in 2025. The excise tax payments will be made from the plan sponsor's assets and not from assets of the Plan.

### **Note 11 - Reclassification**

Certain amounts in the 2023 financial statements have been reclassified to conform with the 2024 presentation.

### **Note 12 - Subsequent Events**

Plan management has evaluated subsequent events through October 14, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to December 31, 2024 were noted.
