Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jam City 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Jam City 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established in 2011 by Jam City, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Administration

The Company has appointed a Plan Administrator to manage the operation and administration of the Plan. The Company has contracted with Minnesota Life Insurance Company (“Minnesota Life”) (a division of Securian Financial Group) to act as the custodian and Securian Financial Group (“Securian”), a third-party administrator, to process and maintain the records of participant data. Effective December 1, 2022, Securian’s full-service retirement plan business was acquired by The Standard, which is the marketing name for StanCorp Financial Group, Inc., and its subsidiaries. Standard Insurance Company (“Standard Insurance”) acts as the custodian and trustee. Standard Retirement Services, Inc. (“Standard Retirement”), provides financial recordkeeping and plan administrative services. The Company has established a 401(k) Committee to provide fiduciary oversight of the Plan and contracted with Independent Financial Group, LLC as the investment advisor.

Eligibility

All full-time employees of the Company aged 21 years old are eligible to participate in the Plan and may enter the Plan immediately upon hire.

Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax or Roth after-tax compensation to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions

The Plan allows a discretionary profit-sharing contribution and a discretionary employer matching contribution. Effective April 1, 2024, The Plan allows a discretionary employer matching contribution equal to 50% of the elective deferrals contributed by an eligible participant up to 5% of such eligible participant's compensation on a payroll basis. There were no discretionary profit-sharing contributions made during the Plan year ended December 31, 2024.

Investment Options

Participants must direct their salary deferral and employer contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via Internet website offered by Standard Retirement.

Vesting

Participants are immediately vested in their contributions. Participants vest in discretionary profit sharing or discretionary employer matching contributions based on their years of service over a 4-year vesting period as follows:

<u>Completed Years of Service</u>	<u>Vested Percentage</u>
1 but less than 2 years	25%
2 but less than 3 years	50%
3 but less than 4 years	75%
4 or more years	100%

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, employer contributions (if any), and allocations of the Plan's earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan allows participants to borrow \$1,000 up to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the participant's vested balance. Such notes bear interest a reasonable rate of interest charged for similar types of loans by other lenders and must be repaid to the Plan within a five-year period, unless the note is used for the purchase of a principal residence in which case the maximum repayment period may be longer. The maximum number of loans a participant may have outstanding is one loan for the purchase of a primary residence and one for general purposes. The specific terms and conditions of such notes are established by the Company. Outstanding notes receivable at December 31, 2024 from participants bear interest rates ranging from 4.25% to 8.50% and mature through 2052. Outstanding notes receivable at December 31, 2023 from participants bear an interest rate of 4.25% and mature through 2052.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Forfeited Accounts

Forfeitures are used to reduce employer matching contributions and plan expenses. At December 31, 2024 and December 31, 2023, the balance of forfeited non-vested accounts was \$535 and \$0, respectively.

Plan Expenses

The Company currently pays for most of the Plan's expenses. Plan expenses paid by the Company are excluded from these financial statements. Plan expenses not paid by the Company are charged on a pro-rata basis to the value of the participants account balances.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with the Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

Payment of Benefits

Upon termination, death, disability or retirement, participants or beneficiaries may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are also allowed under the Plan. The Plan allows for the automatic rollover into an individual retirement account for the participant account balances that do not exceed \$5,000.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment in the insurance company general account is stated at contract value.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Management fees charged to the Plan for investments in pooled separate accounts are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. There were no delinquent notes receivable as of December 31, 2024 and 2023. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Income Taxes

The Plan adopted a non-standardized form of a pre-approved plan sponsored by Minnesota Life. The pre-approved plan has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

NOTE 3 – FAIR VALUE MEASUREMENT

Financial Accounting Standards Board Accounting Standards Codification Topic No. 820 (ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts:

Units held in pooled separate accounts ("PSA") are valued using the NAV practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information.

NOTE 3 – FAIR VALUE MEASUREMENT (Continued)

At December 31, 2024 and 2023, all pooled separate accounts held by the Plan had a daily redemption frequency and redemption notice period of 30 days. Pooled separate accounts had no unfunded commitments and no redemption restrictions, unless the Plan was discontinued or in blackout period, in which case withdrawals are not permitted until the blackout period ends.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INSURANCE COMPANY GENERAL ACCOUNT

The Plan entered into a fully benefit-responsive guaranteed investment contract (GIC) with Minnesota Life Guaranteed Return Account totaling \$1,910,273 and \$991,724 as of December 31, 2024 and 2023, respectively. The crediting interest rate on the contract was 1.87% and 1.74% as of December 31, 2024 and 2023. The interest rate is reset quarterly. The guaranteed investment contract is reported at contract value. The terms of the investment contract require all permitted participant-initiated transactions with the Plan to occur at contract value with no conditions, limits, or restrictions. The insurance company general account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the insurance company general account is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for plan benefits attributable to the insurance company general account. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is the amount participants would receive if they were to initiate a permitted transaction under the terms of the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 4 – INSURANCE COMPANY GENERAL ACCOUNT (Continued)

The terms of the contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions. Although participants generally may withdraw assets from the contract without restrictions, Minnesota Life may impose a holding period of up to 270 days at the contract level in the event of a full contract discontinuance or partial contract discontinuance.

Permitted participant-initiated transactions are those transactions allowed by the Plan, such as any of the following: withdrawals for benefits, loans, and transfers to other funds within the Plan.

The best estimate of fair value for the account is contract value, as participants may withdraw assets at contract value without restriction, and assets are marked-to-market on a daily basis. Also, while the liquidation charge, if any, is applicable to the GIC, it would only apply upon contract termination and should not be taken into account when determining fair value, unless contract termination is probable. Transfer restrictions may exist for transfers out of the account to any competing investment option. Currently, this Plan has no competing investment options.

In the case of contract termination, a market value adjustment and/or liquidation charge may apply to General Account assets. However, it only needs to be considered if a contract termination is probable of occurring.

NOTE 5 – RELATED PARTY TRANSACTIONS

Certain Plan investments and notes receivable from participants and the related interest income are managed and held by Standard Insurance, the custodian of the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly the custodians of the Plan, have certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, dividend and interest and interest income on notes receivable from participants reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Investments reflected on the supplemental schedule: Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 7 – PLAN TERMINATION OR MODIFICATION

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and is subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for plan benefits would be distributed to the participants based on each participant’s interest in the Plan.

NOTE 8 – UNCERTAIN TAX POSITIONS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

NOTE 9 – NON-EXEMPT TRANSACTIONS

During 2021, the Plan sponsor failed to deposit \$185,054 of participant contributions within the required timeframe as stated by the United States Department of Labor’s regulations. The Company has deposited the contributions with the custodian during 2021 and deposited all lost earnings into the impacted participants’ accounts outside of the Voluntary Fiduciary Correction Program (“VFCP”) in 2024.

During 2022, the Plan sponsor failed to deposit \$192,279 of participant contributions within the required timeframe as stated by the United States Department of Labor’s regulations. The Company has deposited contributions with the custodian during 2022 and deposited all lost earnings into the impacted participants’ accounts outside of the VFCP in 2024.

During 2023, the Plan sponsor failed to deposit \$504,226 of participant contributions within the required timeframe as stated by the United States Department of Labor’s regulations. The Company has deposited the lost earnings related to lost earnings into the impacted participants’ accounts outside of VFCP in 2024.

During 2024, the Plan sponsor failed to deposit \$307,743 of participant contributions within the required timeframe as stated by the United States Department of Labor’s regulations. The Company has deposited \$307,657 contributions with the custodian and related lost earnings into the impacted participants’ accounts outside of the VFCP in 2024 and will deposit the missed contribution in the amount of \$86 and lost earnings into the impacted participant’s account outside of VFCP in 2025.

NOTE 10 – SUBSEQUENT EVENTS

In February 2025, the Plan engaged with USI Consulting Group as the investment advisor.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
