## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator  
Hexcel Corporation Voluntary Savings Plan for Kent Union Employees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hexcel Corporation Voluntary Savings Plan for Kent Union Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Hexcel Corporation Voluntary Savings Plan for Kent Union Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Hexcel Corporation Voluntary Savings Plan for Kent Union Employees and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ## **Responsibilities of Management for the Financial Statements**

## NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Hexcel Corporation Voluntary Savings Plan for the Kent Union Employees (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan that was established in 1990 by Hexcel Corporation (the "Company") to provide benefits to members of the I.A.M.A.W. District Lodge #160, Local Lodge #1103 Union and whose regular work schedule is 20 or more hours per week. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code ("IRC"), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

During 2024, participants transferred from the Hexcel Corporation 401(k) Retirement Savings Plan to the Plan total assets of \$65,821. During 2023, participants transferred from the Plan to the Hexcel Corporation 401(k) Retirement Savings Plan total assets of \$111,091.

### Master Trust

The assets of the Plan (except notes receivable from participants) were combined with the assets of the Hexcel Corporation 401(k) Retirement Savings Plan ("the 401(k) Plan") on January 1, 2011 to create the Hexcel Corporation Master Trust (the "Master Trust"). The investments included in the statements of net assets available for benefits represent the Plan's share of the investment in the Master Trust. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 2.5% or \$13,388,078 and \$11,630,635 as of December 31, 2024 and 2023, respectively. Net investment gains and losses relating to the Master Trust are allocated to the individual plans based upon individual plan participant account balances.

### Contributions

Participants may make voluntary pretax and Roth contributions subject to certain limitations under the terms of the Plan and the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions as determined by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

### Participant Accounts

Each participant's account is credited with the participant's contributions and investment earnings and charged with an allocation of administrative expenses. Allocations of investment earnings and administrative expenses are based on a participant account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

## NOTE 1 — DESCRIPTION OF THE PLAN (Continued)

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. If a loan was taken in the previous 12 months, the amount of the highest outstanding loan balance is deducted from the amount the participant may borrow. The notes are secured by the balance in the participant's account. The interest rate, determined quarterly, is set at 1 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service for any reason, participants with a vested account balance less than \$1,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance less than \$5,000, but greater than \$1,000 will receive an automatic rollover of their vested account balance into an individual retirement account. For terminated participants with a vested account balance greater than \$5,000, participants may defer payment of benefits until a later date and may take distributions in the form of a single lump-sum payment or substantially equal annual installments.

Withdrawals from a participant's vested account balance may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's vested accounts may also be made upon reaching age 59½, in accordance with the provisions specified in the Plan.

### Forfeitures

Forfeitures from participant non-vested accounts may be allocated to eligible participants employed at the end of each Plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,281 and \$1,247, respectively. There were no forfeitures used during 2024 or 2023.

## NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investment in the Master Trust represents the Plan's interest in the Master Trust. The Plan's investment is stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Investment Valuation and Income Recognition (Continued)**

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net investment gain (loss) from interest in Master Trust.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

**NOTE 3 — FAIR VALUE MEASUREMENTS (Continued)**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

Brokerage accounts: Self-directed accounts allowing the participant to invest in a variety of investments, such as stocks, bonds, mutual funds, stock warrants, options, and certificates of deposit. The Plan's investments in brokerage accounts primarily consist of mutual funds and common stocks, which are valued consistent with the methods described above.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The Company common stock and brokerage account investment options in the Master Trust are not available to participants of the Hexcel Corporation Voluntary Savings Plan for Kent Union Employees.

**NOTE 4 — INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (“Fidelity”), has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications are as of and for the years ended December 31, 2024 and 2023, and includes investment information related to fair value of investments, contract value of investments, notes receivable from participants, net investment gain (loss) from interest in Master Trust and interest income on notes receivable from participants that are included in the Plan’s financial statements and supplemental schedule of assets (held at end of year).

**NOTE 5 — INTEREST IN THE MASTER TRUST**

The Plan’s investment is held in the Master Trust, which is commingled with the assets of Hexcel Corporation 401(k) Retirement Savings Plan. Each participating plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by the Trustee. At both December 31, 2024 and 2023, the Plan’s interest in the net assets of the trust was approximately 2.5%. Investment income or loss is allocated based on participant balances, and administrative expenses relating to the Master Trust are allocated monthly to the respective plans based on the net asset value balances invested by each plan.

**NOTE 6 – GUARANTEED INVESTMENT CONTRACTS**

The Master Trust has entered into various benefit-responsive investment contracts with various insurance companies that are managed by Mellon Asset Management (“Mellon”). Mellon maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plans.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the plans by Mellon, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than contractually agreed upon. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the plans to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity dates.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Company portion of their account.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable to participants are considered exempt party-in-interest transactions.

**NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 10 – INCOME TAX STATUS**

The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated September 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
