**NOTE A - Description of Plan Provisions**

The following description of Hunger Task Force (Organization) Employees' Retirement Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the plan.

General

The Plan is a defined contribution plan established by the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Organization established the Plan for the benefit of its employees.

All full-time employees who are age 18 or older are eligible to participate in the elective deferral, safe harbor matching contribution, and discretionary profit sharing contribution of the Plan. Temporary employees must be age 21 or older and have completed 1,000 hours of service to be eligible to participate in the elective deferral, safe harbor matching contribution, and discretionary profit sharing contribution of the Plan. The Plan excludes collectively bargained employees, non-resident aliens with no income from a U.S source, independent contractors, and residents of Puerto Rico.

Fidelity Management Trust Company serves as the custodian of the Plan and provides investment products and recordkeeping services.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Service limitations. Participants who attain age 50 before the end of the Plan year are eligible to make catch up contributions. The Plan allows Roth elective deferrals and rollovers from other qualified plans. For 2024, the max contribution is \$23,000 and the max catch-up contribution is \$7,500. These amounts are subject to change each year by the Secretary of the Treasury.

The Organization makes a safe harbor matching contribution in an amount equal to 100 percent of the first 5% of your eligible compensation, contributed to the Plan as deferral contributions. In addition, the Organization may make additional discretionary contributions to the Plan.

The Plan includes an auto-enrollment provision. All participants are automatically enrolled at 3%. There is no auto escalation provision.

For the years ended December 31, 2024, the Organization made safe harbor contributions in the amount of \$231,175. There was also a 2024 discretionary contribution of \$133,450 contributed in 2025.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Participants may direct all their contributions among one or more funds subject to the allocation limitations set forth in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions. The participants currently have 23 investment options available.

Contributions Receivable

Contributions receivable are stated at unpaid balances. Management believes all receivables will be paid in accordance with the terms of the agreements. Thus, no allowance for uncollectible accounts is necessary at year end.

Vesting

Participants are 100% immediately vested in their elective deferral, rollover contributions, employer safe harbor contributions, and employer discretionary contributions.

Participant Loans

Loans are not permitted under this plan.

Payment of Benefits

Participants are eligible to receive benefits upon termination, death or reaching Normal Retirement Age, which is defined by the Plan as 65 years or the fourth anniversary of your Employment Commencement Date. Payments may be paid in either a single lump sum or installments over a period of time not more than assumed life expectancy. Payments can also be made as a rollover payments and partial withdrawals are allowed for any terminated employees. Benefits are recorded when paid.

Forfeitures

As all employees are 100% vested in their contributions, the plan does not have any forfeitures.

**NOTE B - Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present the assets available for Plan benefits and changes in those assets.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plans valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest Income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Recordkeeping fees are paid by the Plan. Certain other fees are paid by the Organization. For the year ended December 31, 2024, administrative expenses of \$8,316 have been paid out of plan assets.

**NOTE C - Information Prepared and Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and net appreciation in net asset value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information throughout the financial statements and the supplemental schedule related to the following amounts:

**NOTE D - Fair Value Measurements**

The Company has adopted the Financial Accounting Standards Board guidance on fair value measurements. A three-tier hierarchy is used to maximize the use of observable market data inputs and minimize the use of unobservable inputs and to establish classification of fair value measurements for disclosure purposes. The three levels of the hierarchy are described as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

*Shares of registered investment companies:* Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commissions. These funds are deemed to be actively traded, and are required to publish their daily net asset value (NAV) and to transact at that price.

*Collective Investment Trust:* The collective investment trust is valued based on the NAV of the units of the collective investment trust fund. The NAV, as provided by the custodian, is used as the practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the report date.

**NOTE E - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024, may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE F - Plan Termination and Amendments**

While the Organization has not expressed any intent to terminate the Plan, it has the right to do so, subject to the provisions of ERISA. In the event of termination, each participant automatically becomes vested to the extent of the balance in his or her account.

The Plan may be amended at any time by the Organization.

**NOTE G - Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity Management Trust Company, the custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fidelity Management Trust Company also performs administrative and recordkeeping services for the Plan. The transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Certain employees of the Organization provide trustee and administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Organization on behalf of the Plan.

**NOTE H - Tax Status**

The Organization adopted a non-standardized pre-approved profit sharing plan with CODA. The plan has received an opinion letter from the Internal Revenue Service as to the plan's qualified status. The plan opinion letter has been relied upon by the Plan. The plan has been amended since the prototype plan received the opinion letter, however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.
