## ***INDEPENDENT AUDITOR'S REPORT***

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of the CentralStar Cooperative, Inc. Co-Op 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the CentralStar Cooperative, Inc. Co-Op 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of December 31, 2023 and 2022, and for the years then ended, stating that the certified investment information, as described in the notes to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis of Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the CentralStar Cooperative, Inc. Co-Op 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CentralStar Cooperative, Inc. ***DESCRIPTION OF PLAN***

The following brief description of the CentralStar Cooperative, Inc. Co-Op 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

***General***

The Plan is a defined contribution retirement plan sponsored by CentralStar Cooperative, Inc. (the Sponsor). In May 2019, East Central Select Sires merged with NorthStar Cooperative to become CentralStar Cooperative, Inc. Effective July 1, 2019, the employees from East Central Select Sires became eligible for the Plan. Prior to July 1, 2019, the East Central Select Sires employees participated in the Select Sires, Inc. 401(k) Plan and Trust. In January 2020, there were rollovers of \$12,487,147 to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Eligibility***

An employee shall be eligible to participate in the Plan on the entry date (if employed) coincident with the date of completion of 90 days of service. To be eligible for discretionary, non-elective employer contributions, the employee must be 21 years of age and have completed one year of service. Employees are automatically enrolled upon eligibility and escalating default contribution rates and investments choices are applicable until changed or suspended by the employee.

***Contributions***

Eligible employees are automatically enrolled in the Plan at a 5% contribution level, unless they elect not to participate or elect a different contribution amount. The employer is authorized to deduct and withhold from such employee's compensation a specified amount, or percentage thereof, and to contribute such amount to the employee's account in the Plan. In accordance with Section 401(k) of the Internal Revenue Code, all amounts withheld from compensation and contributed to a participant's account, up to the maximum allowed, shall be excluded from gross income of the participant for federal income tax purposes.

The Sponsor matches 100% of each participant's first 3% of compensation contributed as elective deferrals for the Plan year, and 50% of each participant's deferral in excess of 3% of compensation not to exceed 5% of compensation. Participants direct these contributions among a choice of investment options. The Sponsor may also make discretionary profit-sharing contributions annually at an amount determined by the Sponsor's Board of Directors. Participants may rollover balances from other qualified plans which are reported as contributions on the statement of changes in net assets available for benefits. Rollover contributions totaled \$0 and \$295,268 for the years ended December 31, 2024 and 2023, respectively.

***Vesting***

Participants are immediately vested in their elective deferrals, employer matching contributions and actual earnings thereon.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution, (b) Plan earnings, and (c) an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as provided in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance for up to five years, unless for a primary residence, for which the maximum is 15 years. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the Plan administrator.

***DESCRIPTION OF PLAN - Continued***

***Administrative Fees and Expenses***

The majority of the investment advisory and administrative fees are absorbed by the Plan. Some expenses are paid by the Plan Sponsor.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in any of the various investment options offered by the Plan. Participants may change their investment options at any time. The Trustees review the investment options periodically and may make changes to the offerings from time to time when considered to be in the best interest of the Plan and its participants.

***Payment of Benefits***

Upon termination, participants may receive the vested portion of their account as a distribution in the form of a lump sum payment, or elect to remain a non-contributing participant in the Plan. A participant's account shall be payable to him or her, or in the event of death, to a beneficiary, upon the earlier of disability, termination of employment or retirement date. Retirement date is upon attainment of age 65 or age 55 with at least five years of service. Hardship withdrawals may be made for an immediate and heavy financial need of the participant as defined in the Plan agreement.

***Plan Amendments or Terminations***

CentralStar Cooperative, Inc. reserves the right at any time to amend or terminate the Plan, provided that no such amendment or termination shall have the effect of giving CentralStar Cooperative, Inc. any right, or of reducing the rights of any participant, in the funds then held by the custodian. No amendment to the Plan shall have the effect of eliminating or reducing a retirement benefit, or eliminating an optional form of benefit with respect to benefits attributable to service before the amendment.

***SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

***Basis of Accounting***

The financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America and those common to employee benefit plans. Following are the significant accounting policies adopted by the Plan and used in the preparation of these financial statements:

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on the Plan administrator's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

***Risks and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - Continued***

***Investment Valuation and Income Recognition***

Investments in mutual funds are recorded at fair value based upon quoted market prices at year end. See footnote entitled FAIR VALUE MEASUREMENTS for additional information. Income from investments is recorded as earned on the accrual basis of accounting. Cost of investments is determined using average cost and is used when determining realized gains and losses upon disposition.

The Plan invests in stable value funds, which are common collective trusts. The funds are measured at fair value using the net asset value as reported by the trust, which is the practical expedient. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Net asset value for these trusts is based upon contributions, withdrawals and earnings of the trust as reported by the fund managers. The statement of changes in net assets available for plan benefits is presented on a net asset value basis.

***Notes Receivable from Participants***

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest.

***Contributions***

Contributions are recorded as earned on the accrual basis when withheld from the participant's earnings and when contributions are allocated by the Plan Sponsor.

***Payment of Benefits***

Benefits are recorded when paid.

***INCOME TAX STATUS***

In its most recent determination letter, dated May 6, 2011, the Internal Revenue Service informed the administrator and Sponsor that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan administrator is not aware of any provision, action or event that has occurred that might affect the Plan's qualified status.

The Plan complies with Accounting Standards Codification (ASC) 740-10 related to uncertain tax positions. This standard prescribes a recognition threshold and measurement attribute for financial statement recognition and measurement of a tax position taken or expected to be taken on a tax return. Plan administration is not aware of any tax positions taken by the Plan that it considers to be uncertain. Tax returns for the years ended 2021, 2022 and 2023 are open and subject to examination by the Internal Revenue Service and Department of Labor.

***INVESTMENTS***

The Plan also invests in common collective trusts. The common collective trust value is based on net asset value per share (NAV), as reported in the fund's audited financial statements. The NAV, which is determined and made available to the Plan on a daily basis, is based on the fair value of the underlying investments held by the trust, less its liabilities. Transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations at the then current NAV will be carried out in an orderly business manner. The common collective trust has a daily redemption frequency, a redemption notice period of one year and no unfunded commitments.

**REPORTABLE TRANSACTIONS**

The Plan's assets are participant-directed, and thus, the schedule of reportable transactions is not required.

**PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by the Plan's custodians, as is customary in retirement plans. Milliman, Inc. serves as the Plan's third party administrator. BHM CPA Group, Inc. serves as the Plan's auditors. Transactions with these parties qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee received compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Sponsor and are not charged to the Plan.

**FAIR VALUE MEASUREMENTS**

The Plan complies with ASC 820 *Fair Value Measurements and Disclosures* to account for and report fair value. ASC 820 provides a single definition of fair value, a framework for measuring fair value and expanded disclosures concerning fair value. It also defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value of certain assets and liabilities are determined based on the fair value hierarchy established in the standard, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The standard describes three levels within its hierarchy that may be used to measure fair value which are:

**Level 1**

Values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

**Level 2**

Values are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3**

Values are generated from unobservable inputs that are supported by little or no market activity and that are a significant component of the fair value of the assets or liabilities. These unobservable inputs would reflect management's estimates of assumptions that market participants would use in pricing related assets or liabilities. Valuation techniques might include the use of pricing models, discounted cash flow models or similar techniques.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the classification of fair value assets and liabilities within the fair value hierarchy levels.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As noted earlier, certain investments are measured at contract value or net asset value as the practical expedient, and therefore have not been classified in the fair value hierarchy. The amounts presented in the table above are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual funds**

Mutual funds represent bond, domestic equity, international equity and balanced funds. They are valued at the net asset value (NAV) of shares held by the Plan at year end, as published on public exchanges, therefore they are classified as Level 1.

***FAIR VALUE MEASUREMENTS - Continued***

***Cash and cash equivalents***

Cash and cash equivalents are cash deposits that are not valued at fair value and therefore are not included in the fair value hierarchy.

***Common collective trusts***

Common collective trusts consist of stable value funds and various other investments. These are reported at net asset value and therefore are not included in the fair value hierarchy.

The plan did not have any transfers between levels in either year presented, and the new accounting guidance did not have a significant impact on the Plan's financial results or financial reporting.

***RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500***

No reconciliation was necessary for 2024 and 2023.
