NOTE 1 - DESCRIPTION OF PLAN

The following description of the Southeastern Pathology Associates, P.C. 401(k) Savings Plan (formerly the Southeastern Pathology Associates, P.C. 401(k) & Profit Sharing Plan) (the Plan) provides only general information. The Plan Sponsor is Southeastern Pathology Associates, P.C. (the Plan Sponsor or the Company). Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan, which was established January 1, 2002 and restated effective January 1, 2023, is a defined contribution plan covering employees of the Company and affiliates who have met the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees are eligible to defer a percentage of their compensation upon reaching the age of 21 and 30 days of completed service. The Plan currently provides Safe Harbor 401(k) employer contributions. Eligibility is based upon obtaining one year and 1,000 hours of applicable service.

Contributions: Each year, participants may contribute up to the amounts allowed by law of their compensation per payroll period on a tax deferred or Roth basis, as defined in the Plan. Participants are automatically enrolled at a 1% deferral rate upon becoming eligible to participate in the Plan. They may elect to discontinue or change deferrals at any time. Contributions are subject to certain limitations as determined annually by the Internal Revenue Code (IRC). The Plan also allows for additional pre-tax "catch-up" contributions to be elected by participants who had attained the age of 50 at the end of the Plan year.

The Plan Sponsor has elected to maintain a Safe Harbor 401(k) Plan with contributions to be allocated to each eligible participant at three percent of compensation.

Upon enrollment in the Plan, participants may designate how their contributions and those of the Plan Sponsor are to be apportioned among investment options. The participants can change their investment options at any time.

Participant Accounts: Each participant's account is credited with the participant's contribution, employer safe harbor contributions, employer discretionary contributions, and Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on the participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the employer's discretionary contribution portion of their accounts made prior to December 31, 2023, plus actual earnings thereon is based on years of continuous service. A participant is 20 percent vested after one year of credited service and vests an additional 20 percent each year thereafter, reaching full vesting after five years of credited service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 are automatically distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in installment payments over a 10-year period. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Effective January 1, 2023, participant loans are not permitted. Prior to January 1, 2023, participants could borrow up to 50 percent of their vested account balance, with a minimum of \$1,000 up to a maximum of \$50,000. All loans were secured by the balance in the participants' accounts and bore interest at rates commensurate with prevailing rates at the date of the loan issuance. Loan terms generally did not extend beyond five years. Principal and interest payments are made through payroll deductions based on an amortization schedule. Loans become due and payable upon termination of employment.

Forfeited Accounts: Forfeited account balances are used to pay administrative expenses first, with any amounts left over to be used to reduce future Company discretionary contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in investments reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks associated global events and international conflicts. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair value of participation units held in collective trusts is based on the net asset value per unit as reported by the fund manager. The collective trusts provide for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are managed and issued by The Vanguard Group, Inc., a service provider to the Plan, and the Plan holds a collective trust issued by Vanguard Fiduciary Trust Company, a company related to The Vanguard Group, Inc. Therefore, these transactions and the Plan's payment of fees to the Vanguard Group, Inc. and its affiliates qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
