Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited the financial statements of The Kitchen and Bath Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Kitchen and Bath Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of The Kitchen & Bath Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General – The Plan is a defined contribution plan sponsored by Ankeny Glass dba The Kitchen & Bath Company (the "Company") for the benefit of its employees who have attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants may contribute up to 100 percent of their compensation on a pre-tax basis, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limitations. After-tax contributions to the Plan are permitted up to the limits allowed by law. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Additionally, the plan has automatic enrollment of 3%.

The employer has a safe harbor match in the plan at the basic level, meaning a 100% match is made on the first 1% contributed and a 50% match is made on the next 5% contributed by the participants. Matching contributions are usually calculated and paid out each payroll period. The Plan also allows for discretionary profit-sharing contributions.

Participant Accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, allocation of the Plan earnings (losses) and charged with withdrawals. The participant's account may be charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments – Participants direct the investment of their contributions into any combination of the investment alternatives offered by the Plan in multiples of one percent. Plan participants may transfer funds from one investment fund to another. Transfers are effective the day made or the next business day.

Vesting – Participants are immediately vested in their contributions, rollover contributions, and actual earnings (losses) thereon. Safe harbor contributions and actual earnings will be fully vested after two years of service. Participants are vested in any employer profit sharing contributions and actual earnings (losses) thereon at the rate of 20% per year, starting after two years of service, with 100% vesting after six years of credited service.

Forfeitures – Forfeitures of non-vested employer contributions may be used to reduce future employer contributions or pay administrative expenses. Safe harbor matching contributions must be forfeited if contributions are excess elective deferrals or excess annual additions in accordance with the Plan document's matching section rules. Forfeitures also occur once the employee is terminated. There were no forfeitures during the year ended December 31, 2024.

Notes Receivable from Participants – Participants may borrow from their fund accounts from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The repayment period for the loans is not to exceed five years, unless the loan qualifies as a home loan then not to exceed fifteen years. The loans are secured by the balance in the participant's account. The interest rate charged on the loans is one percentage point above the prime rate. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, no notes receivable had been issued.

Payment of Benefits – On termination of service, a participant may elect to receive either a lump-sum payment equal to the value of his or her vested account, or installment payments over various periods as elected by the participant. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum, subject to automatic rollover provision for amounts up to \$5,000. A participant may withdraw all or part of their benefits derived from their contributions on account of hardship as defined by the Plan and applicable IRS regulations. Under these rules the participant must exhaust the possibilities of all other distributions and loans available under the Plan and meet certain other requirements.

2. **Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net earnings on investments include realized and unrealized gains and losses and interest and dividends recorded on an accrual basis.

Notes Receivable from Participants – Notes receivable from participants are valued at unpaid principal balance plus accrued but unpaid interest. If a participant does not make loan repayments and the plan administrator considers the participant's loan to be in default, the loan is treated as a benefit payment based on the terms of the Plan document.

Administrative Expenses – Administrative expenses of the Plan are paid by the Plan as provided in the Plan document. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Certain fees are paid by the Plan Sponsor which are not reflected in the Statements of Changes in Net Assets Available for Benefits.

Payment of Benefits – Benefit payments to participants are recorded upon distribution. As of December 31, 2024, net assets available for benefits included no benefits due to participants who had withdrawn from participation in the Plan but have not yet been paid.

3. **Fair Value Measurements**

ASC 820, *Fair Value Measurements and Disclosures* provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The Plan's policy is to recognize significant transfers between levels at the actual date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers in or out of Levels 1, 2, or 3.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets at fair value. There were no changes in the methodologies used at December 31, 2024.

Mutual Funds

The fair value of the mutual funds is valued at the daily closing price as reported by the fund. These funds are actively traded and are required to publish their daily net asset value and to transact at that price.

Cash and Cash Equivalents

Cash and money market funds held are primarily short-term money market funds that are categorized as Level 1. They are valued at cost plus accrued interest, which approximates fair value.

The following tables set forth by level, within the fair value hierarchy, a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024.

The valuation methods as described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. **Exempt Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Ascensus, the trustee and recordkeeper for the Plan. These transactions qualify as exempt party-in-interest transactions.

5. **Plan Termination**

Although it has not expressed any intention to do so, the participating employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

6. **Federal Income Tax Status**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan With CODA by a Third-Party Administrator, Ascensus LLC. The Internal Revenue Service has determined that the plan is designed in accordance with applicable sections of the IRC and informed the trustee of such in a letter dated June 30, 2020. The Plan administrative committee/plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

7. **Certification**

The Company has obtained certification from Ascensus that the Earnings from Investments and Investment Valuations information is complete and accurate.

8. Subsequent Events

The Plan has evaluated events and transactions occurring after December 31, 2024, for potential items required to be recognized or disclosed in the financial statements. Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.
