Note 1 – Plan Description

The following description of Star Plastics Manufacturing Group LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Star Plastics Manufacturing Group LLC, SDR Plastics, LLC and Star Plastics, LLC (collectively referred to as “the Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute any percentage, up to 75%, of their annual compensation on a pre-tax or after-tax basis. If a deferral election is not received, participants will be automatically enrolled to defer 3% of their compensation on a pre-tax basis. Effective January 1, 2024, the Company makes safe harbor matching contributions equal to 100% of the participant's elective deferrals that do not exceed 4% of the participant's plan compensation. Additional discretionary employer matching contributions are permitted by the Plan. The Company may make discretionary non-elective contributions to the Plan for all eligible participants at the option of the Company. There were no discretionary non-elective contributions for 2024. The Plan also allows for rollover and catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's and employer's contributions, and allocations of the Plan earnings and forfeitures of terminated participants' nonvested accounts and charged with an allocation of plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from salary deferrals and rollovers a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. A participant may not have more than two loans at a time. The loans are secured by the balance in the participant's account. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeited amounts are available to reduce the Company's contributions and administrative fees. As of December 31, 2024 and 2023, forfeited account balances were \$21,675 and \$9,547, respectively.

Vesting

Participants are immediately vested in their employee contributions, rollover contributions, and safe harbor matching contributions plus actual earnings thereon. Participants are 100% vested in non-elective employer contributions after one year of service or are employed on or after normal retirement age or if employment is terminated because of the participant's death or disability.

Benefit Payments

Upon termination of service, a participant whose vested account balance is equal to or less than \$1,000 is entitled to receive a lump-sum payment. If the vested portion of a participant's account balance is greater than \$1,000 but less than \$5,000, the participant may either elect to receive the distribution in cash or to roll over the distribution to an IRA or qualified plan of a new employer. If the vested amount exceeds \$5,000, the participant must consent to any distribution. If death occurs before the distribution of account begins, distribution must be completed by December 31 of the calendar year containing fifth anniversary of death unless the participant's spouse is the primary beneficiary. The Plan also includes provisions for in-service distributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Tax Status

The Plan has adopted a pre-approved plan sponsored by Metro Benefits, Inc., which has obtained its most recent opinion letter from the IRS dated June 30, 2020. The Plan Sponsor believes the Plan is currently being operated in compliance with the applicable requirements of the *Internal Revenue Code (IRC)*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and related notes. Accordingly, actual results may differ from those estimates.

Subsequent Events

The date to which events occurring after December 31, 2024, have been evaluated for possible adjustment to or disclosure in the financial statement is October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Certified by Custodian and Trustee

Certain information was certified as complete and accurate by Capital Bank and Trust Company, the Plan's trustee. The information is as follows:

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. The Plan initiates full redemption of the collective trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that additional changes in the values of investment securities will occur in the near term and that these could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 6 – Party-In-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee received compensation from the Plan.

The Company pays certain administrative fees on behalf of the Plan, including legal, accounting, trustee, and administrative fees and provides certain administrative services to the Plan at no cost. In addition, the Plan invests in certain proprietary funds of the trustee. Investments in funds issued by the trustee are considered related-party transactions. Fees paid by the Plan for investment management and custodial services amounted to \$20,826 for the year ended December 31, 2024.


