INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ClearChoice Dental Implant Centers 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTE 1--PLAN DESCRIPTION

The following description of the ClearChoice Dental Implant Centers 401(k) Profit Sharing Plan and Trust (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of ClearChoice Dental Management Services, LLC and its subsidiaries and affiliated practice entities as participating employers in the Plan (individually and collectively, “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On December 23, 2020, a subsidiary of ADMI Corp (referred to as “Aspen”) acquired 100% of the voting interest in ClearChoice Management Services, LLC, its parent entities, and its subsidiaries. Effective December 31, 2021, the Plan was frozen, and all contributions were ceased. Employees of participating employers became participants in the TAG The Aspen Group, formerly known as the Aspen 401(k) Plan, effective January 1, 2022.

Participant Eligibility: Prior to December 31, 2021, employees were eligible to participate in the Plan on the first day of the month following one month of service. Only employees of ClearChoice Management Services, LLC and National Dental Labs, LLC who are classified as Headquarter Employees were eligible for the discretionary employer matching contribution.

Contributions: Prior to December 31, 2021, participants could make before-tax or after-tax contributions to the Plan of up to 100% of their annual compensation not to exceed maximum tax-deferred limitations established by the Internal Revenue Code (“IRC”). The Plan allowed for participant deferral “catch-up” contributions in excess of plan limits for participants who have attained age 50 by the end of the Plan year. The Employer could elect to make discretionary matching contributions or non-elective discretionary contributions to eligible participants.

For the year ended December 31, 2019, the Plan Sponsor inadvertently failed to satisfy required compliance testing as set forth in Treasury Regulation Section 1.401(a)(4)-11(g), which resulted in a demographic failure of the Plan. The Plan Sponsor received notice of the failure during 2023, and entered a voluntary correction program by which the Plan Sponsor made a qualified nonelective contribution (“QNEC”), including lost earnings, to the impacted participants based on the date the contribution should have been made (October 15, 2020). The Company recorded the corrective contribution as other employer contribution receivable on the 2023 statement of net assets available for benefits. The Plan Sponsor funded the contribution and lost earnings in April and August 2024, respectively.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer discretionary matching contributions is determined on the graduated scale based on years of credited service. A participant is 20% vested after one year of vesting service and an additional 20% per year thereafter until fully vested.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions and (b) plan earnings, and is charged with their withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of their account balance upon retirement, death or disability.

Benefit Payments: Upon death, disability, retirement, or termination of service, a participant will receive a lump-sum payment in the amount equal to the participant's vested account balance. Benefit amounts under \$1,000 are automatically distributed to participants. Benefit amounts greater than \$1,000 but less than \$5,000 are automatically rolled over to an individual retirement account. Benefit amounts greater than \$5,000 remain in the Plan until further action is taken by the participant.

Notes Receivable from Participants: Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator.

Principal and interest are paid ratably through payroll deductions. Participant notes receivable have a maximum term of five years, unless such note is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 10 years from the date of the note origination. Participant notes are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's note shall be paid in full by the last day of the calendar quarter following the termination of employment.

Notes Receivable from Participants--Continued: Participants may have only one loan outstanding at any time unless one loan is a principal residence loan amortized for a period greater than five years.

Forfeitures: Forfeitures of Employer matching contributions are used to offset administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited non-vested amounts totaled approximately \$99,000 and \$62,000 respectively. The Company did not use forfeited nonvested accounts to pay plan expenses in 2024 or 2023.

Administrative Expenses: Origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Employer.

NOTE 2--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of the significant accounting policies followed in the preparation of the Plan's financial statements.

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts (Note 6), are reported at fair value as further described in Note 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount plan participants generally receive when executing transactions under the terms of the contract and plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment Valuation and Income Recognition--Continued: Net appreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Events Occurring After Reporting Date: The Plan's management has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. There were no such events or transactions identified by Plan management.

NOTE 3--RIGHTS UPON TERMINATION

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts would become fully vested.

NOTE 4--CERTIFIED INVESTMENT INFORMATION (UNAUDITED)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023 and for the years then ended included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the current trustee, T. Rowe Price Retirement Plan Services, Inc. ("T. Rowe Price"), that the following data included in the financial statements and supplemental schedule are complete and accurate

- Investment assets and notes receivable from participants, as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income, net appreciation in fair value of investments, and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, part IV, line 4i--schedule of assets (held at end of year) as of December 31, 2024.

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such certified information to the related information included in the financial statements and supplemental schedule.

NOTE 5--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) Topic 820, “Fair Value Measurements and Disclosures”, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following is a description of the valuation methodologies and assumptions used by the Plan to estimate the fair values of investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted market prices on nationally recognized securities exchanges (Level 1 inputs).

Common collective trusts: Valued at the net asset value (“NAV”) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the trustee reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6--INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a traditional fully benefit-responsive investment contract with The Standard. The Standard maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Employer, and certain other Employer-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which The Standard may terminate the contract. Examples of circumstances that would allow Standard to terminate the contract include the Plan's loss of its qualified status or material and adverse changes to the provisions of the Plan. If one of these events were to occur, The Standard could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 7--PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer and certain others. The Employer provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. The Employer also pays for certain professional services related to the Plan.

The Plan's payment of investment management and administrative fees to T. Rowe Price qualified as party-in-interest transactions as of and for the years ended December 31, 2024 and 2023. Notes receivable from participants, totaling \$362,306 and \$448,017 at December 31, 2024 and 2023, respectively, are also party-in-interest transactions.

NOTE 8--TAX-EXEMPT STATUS AND REPORTING

Effective March 1, 2022, the Plan has adopted a prototype non-standardized plan document which received a favorable opinion letter from the IRS dated August 19, 2020, which stated that the Plan is designed in accordance with applicable sections of the IRC. Plans that adopt prototype documents are not required to file for an individual determination letter. The Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
