## Notes to Financial Statements

### 1. Plan Description

The following description of the Archbold Expeditions, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all employees of Archbold Expeditions, Inc. (the "Company") who have completed twelve months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Eligibility* – Employees are eligible to participate in the salary deferral portion of the Plan after twelve months of service, provided they completed at least 83 <sup>1</sup>/<sub>3</sub> hours in each month. To participate in the employer contribution portion of the Plan, employees must have completed at least one year of service and contribute a minimum of 2% of eligible compensation. Newly eligible employees are enrolled in the Plan on the first day of the pay period following their anniversary date. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options offered by the Plan.
- c) *Contributions* – Each year, participants may contribute up to the maximum percentage allowable under the provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans.

The Company may make discretionary employer matching contributions. In 2024, the Company matched 5% of eligible compensation. Employees must complete one year of service with the Company and contribute a minimum of 2% of eligible compensation in order to receive this match. For the year ended December 31, 2024, the Company made matching contributions of \$119,381.

- d) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's matching contributions and (b) Plan earnings, and charged with an allocation of administrative expenses, if not paid by the Company. The Company generally

pays the Plan's administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- e) *Vesting* – Participants are immediately fully vested in their voluntary contributions, including catch-up contributions, rollover contributions from other plans, as well as the Company's discretionary contributions and earnings thereon.
- f) *Notes receivable from participants* – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan bears a reasonable rate of interest. Principal and interest is paid ratably through monthly payroll deductions.
- g) *Payment of Benefits* – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.
- h) *Forfeited accounts* – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$242 and \$230, respectively. Forfeited accounts may be used to reduce future employer contributions. In 2024, no forfeitures were used to reduce employer contributions.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Accordingly, actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts reported at contract value, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements. Fully benefit-responsive investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Payment of Benefits

Benefits paid to participants are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### 3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 13, 2025, the date the financial statements were available to be issued.

### 4. Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, TIAA-CREF, the custodian of the Plan, has certified to the completeness and accuracy of the following amounts in the accompanying financial statements:

### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds – Valued at the net asset value NAV of shares held by the Plan at year end. The Plan's mutual funds are deemed to be actively traded.

Fixed Annuity Contracts – Investments in fixed annuity contracts, except for fully benefit-responsive contracts, are valued at fair value by TIAA-CREF using a quantitative model using discounted cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issues. In determining the reasonableness of the methodology, the Plan administrator evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Fully benefit-responsive fixed annuity contracts are reported at contract value.

Pooled Separate Account (PSA) – Valued at the NAV based on the fair market value of the underlying investments of the account less its liabilities. The NAV, as provided by TIAA-CREF, is used as a practical expedient to estimate fair value. The PSAs investments consist of publicly traded, liquid investments.

## 6. Fixed Annuity Contracts

Each participant maintains an individual fixed annuity contract with TIAA-CREF. As part of the contracts, TIAA-CREF maintains a portion of the contributions in a guaranteed account, which is called the TIAA-CREF Traditional Fixed Annuity. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses by TIAA-CREF. The guaranteed minimum rate of interest is based on a formula established by TIAA-CREF and is a minimum of three percent. Any additional interest is not guaranteed. The crediting rate is reviewed on a quarterly basis for resetting. The Traditional Fixed Annuity does not permit TIAA-CREF to terminate the agreement prior to the scheduled maturity date.

Certain Traditional Fixed Annuity contracts are not considered to be benefit-responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering credit worthiness of the issuer. These contracts are subject to a 10-year withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment

will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account.

Certain Traditional Fixed Annuity contracts meet the fully benefit-responsive criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant's accumulation value shall be equal to the product of (a) the participant's guaranteed account accumulation value of the liquidation date, reduced by the liquidation charge applicable on the liquidation date and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include: (a) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt; (b) premature termination of the contracts; (c) Plan termination or merger; (d) changes to the Plan's prohibition on competing investment options (e) bankruptcy of the Plan sponsor.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer or limit the ability of the Plan to transact at contract value with the participants.

## 7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 8. Related Party Transactions

The Plan's investments are managed by TIAA-CREF, the custodian of the Plan, and therefore, the transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than as direct payments to the custodian.

## 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon either full or partial termination of the Plan an affected Participant's right to their account balance is 100% vested.

## 10. Tax Status

The IRS has determined and informed the Company by August 2017 letter that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
