1. Description of Plan

The following description of the Engage! Learning, LLC 401(k) Plan (the “Plan”) provides only general information. The Plan is a defined contribution plan that was originally established January 1, 2012. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

The Plan covers substantially all employees of Engage! Learning, LLC (the “Company”) who have attained age 21 and completed six months of service. Certain non-resident aliens with no U.S. source income and members of collective bargaining units for which Plan participation was not part of the bargaining agreement are ineligible to participate in the Plan. The employee enters the Plan on the first day of the month following the completion of the eligibility requirements.

Contributions

Each year, participants may contribute a portion of their compensation, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Contributions may be designated as Roth 401(k) contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make “catch-up” contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation. The Plan also provides for an annual automatic escalation provision of 1 percent up to 5 percent of eligible compensation for all contributing participants, unless they elect otherwise.

The Plan provides for safe harbor employer nonelective contributions. The safe harbor employer nonelective contributions are 6.5 percent of an active participant’s eligible compensation.

The Company may elect to make discretionary employer matching contributions to the Plan based on a percentage of compensation that a participant contributes to the Plan. No discretionary employer matching contributions were made to the Plan for the year ended December 31, 2024. The Company may also elect to make nonelective contributions to the Plan. To receive any discretionary employer nonelective contributions, participants must be employed on the last day of the Plan year. No discretionary employer nonelective contributions were made to the Plan for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the participant’s contributions and any discretionary employer matching contributions, as well as allocations of safe harbor employer nonelective contributions, discretionary employer nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

A participant, at all times, has a fully vested (100%) interest in their own contributions, rollover contributions, and safe harbor employer nonelective contributions plus actual earnings thereon. Vesting in discretionary employer matching contributions and discretionary employer nonelective contributions are based on years of service. A

participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Forfeited Amounts

Forfeitures represent the non-vested portion of terminated participant's employer matching and nonelective contributions. Forfeitures are generally applied to reduce employer contributions or used to pay administrative expenses. Total unallocated forfeiture account balances were \$12,016 and \$11,235 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures of \$0 were used to reduce employer contributions; forfeitures of \$0 were used to pay administrative expenses of the Plan.

Benefit Payments

Upon termination of service, death, disability, or retirement (age 59 ½), a participant may elect to receive either a lump sum up to the value of the participant's vested interest in his or her account or partial payments. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0") upon termination, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59 ½. Participants are also permitted to take hardship withdrawals in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time. In addition, minimum payments must begin subject to Internal Revenue Service ("IRS") guidelines.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee, custodian, and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and discretionary employer matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. Safe harbor employer nonelective contributions and discretionary employer nonelective contributions, if any, are recorded in the year in which the related participant compensation was earned.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature elected by that participant and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audit of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, a qualified institution and trustee of the Plan, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment activity, including net appreciation in fair value of investments and dividend income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies) listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any employer contributions for which they were not already vested, and all remaining assets in the Plan are to be distributed to the participants in accordance with the accrued benefits of such participants as of the date of termination.

7. Tax Status

Effective April 1, 2023, the Plan was amended and restated through the adoption of a pre-approved plan sponsored by Ascensus, LLC. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved plan document, as then designed, was in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is

designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Related-Party and Party-in-Interest Transactions

The Plan paid fees to the Vanguard Group, Inc. (“Vanguard”) during 2024. Vanguard provides recordkeeping services through an outsourcing agreement with Ascensus, LLC, and the Plan invests in mutual funds managed by Vanguard. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.
