Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ASHRAE Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ASHRAE Savings and Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF PLAN

The following is a brief description of the ASHRAE Savings and Investment Plan (the "Plan"). Participants or other interested parties should refer to the Plan Agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan adopted by the American Society of Heating, Refrigerating and Air-Conditioning Engineers, Inc. (the "Company"), effective March 31, 1999, to provide deferred tax benefits, savings and matching employer contributions to eligible employees. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been amended over the years to comply with tax regulations.

Delaware Charter and Trust Company d/b/a Principal Trust Company ("Principal") is the trustee and custodian of the Plan assets. The Plan has a 401(k) committee with responsibility for oversight of the Plan. The Plan's 401(k) committee, utilizing the recommendations of advisors, determines the appropriateness of investment offerings and monitors investment performance.

Effective January 1, 2024, the Plan transitioned its trustee and custodian from Vanguard Fiduciary Trust Company ("Vanguard") to Principal. All Plan assets previously held by Vanguard were transferred to Principal in February 2024.

B. Eligibility

Effective January 1, 2024, employees can participate in the Plan for purposes of salary deferrals after they have attained the age of 18 and completed three months of service. The entry date into the Plan is the first day of each Plan quarter coinciding with or following the date the eligibility requirements are met.

C. Contributions

Participants may contribute from 2% up to 100% of their pre-tax annual compensation, as defined by the Plan, subject to certain limitations for highly compensated individuals. Participants who attained age 50 before the end of the Plan year may make additional catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. For employees with less than 10 years of service, the Company contributes 100% of salary deferral contributions up to 6% of compensation. For employees with 10 or more years of service, the Company contributes 125% of salary deferral contributions up to 6%. Effective January 1, 2025, the Plan implemented the automatic enrollment feature in accordance with the requirements of the SECURE 2.0 Act. Unless participants elect to not defer or to defer another percentage or dollar amount, participants meeting the eligibility requirements,

as described above, are automatically enrolled in the Plan at 6%. Participants direct the investment of their contributions into various investment options offered by the Plan, which include various registered investment companies and guaranteed interest contracts. For the year ended December 31, 2024, the Company's matching contributions totaled \$598,837.

The Plan also allows the Company to make discretionary non-elective contributions ("profit-sharing contributions") to the Plan. The profit-sharing contributions are allocated to eligible participants based upon a New Comparability allocation formula as defined in the Plan document. To qualify for the annual profit-sharing contribution, the participant must have worked at least 1,000 hours and be employed on the last day of the Plan year. These eligibility requirements do not apply to any participant that terminates employment due to death, disability, or after reaching age 65. The profit-sharing contribution for the year ended December 31, 2024 totaled \$713,791 and is included as receivable in the accompanying financial statements.

D. Participant Accounts

Participants' accounts are maintained by the Plan Trustee, Principal Trust Company, and are credited with the participant's contribution, the Company's contributions, and an allocation of the investment income (loss). Each participant is charged with fees upon receiving distributions, as well as an allocated portion of plan administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of service. A participant is fully vested after six years of service. Participants' accounts also become fully vested upon death, disability, attainment of age 65, or termination of the Plan.

F. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance minus the highest loan balance during the one-year period before the loan is made. A participant may have only one loan outstanding at any time. The loans, which are collateralized by the balance in the participant's account, bear interest at 3.25% - 10.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

G. Payments of Benefits

Upon termination of service due to death, a lump-sum distribution will be made to the beneficiary or representative as soon as administratively feasible with a final payment made consisting of any allocations occurring after the date of initial distribution. For other distributions after termination, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or in substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the Participant and his/her beneficiary. The Plan has an automatic force-out provision of all accounts below \$5,000 upon separation. In addition, the Plan allows in-service withdrawals in the case of hardships or after a participant obtains the age of 59-1/2.

H. Forfeited Accounts

Amounts forfeited by participants who are terminated from the Plan prior to being fully vested are used to reduce employer contributions and administration expenses. For the year ended December 31, 2024, employer contributions were reduced by \$71,530 through the use of forfeitures from non-vested accounts, and administrative expenses were reduced by \$4,045. Total unused forfeited balances as of December 31, 2024 and 2023 were \$629 and \$8,564, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

E. Contributions

Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from the participants.

F. Payments of Benefits

Benefits are recorded when paid.

G. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants or beneficiaries are charged directly to the participant account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

H. Subsequent Events

Subsequent events have been evaluated by management through October 14, 2025, the date these financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a hierarchy for inputs used in measuring fair value of investments that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. The three levels of the fair value hierarchy under FASB ASC 820 are described as below:

Level 1 within the hierarchy states that valuations are based on unadjusted quoted market prices for identical assets or liabilities in active markets. Level 2 within the hierarchy states that valuations are based on quoted prices for similar assets in active markets, quoted prices for identical assets in inactive markets or other observable inputs other than quoted market prices. Level 3 within the hierarchy states that valuations are based on significant unobservable inputs.

At December 31, 2024 and 2023, investments are the only assets that are measured at fair value on a recurring basis in periods subsequent to initial recognition. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Registered investment companies* - Registered investment companies, which include mutual funds, are valued at the daily closing price as reported on the active market on which the individual securities are traded.
- *Pooled separate accounts* - The pooled separate account ("PSA") invests in a single mutual fund - the Principal Real Estate Securities R6 Fund (ticker PFRSX). The fair value of the mutual fund is a publicly quoted pricing input used in determining the net asset value ("NAV") of the PSA, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their accounts. Since the NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date, the Plan considers the PSA to have a readily determinable fair value.

4. PRINCIPAL FIXED INCOME GUARANTEED OPTION

During the year ended December 31, 2024, the Plan entered into the Principal Fixed Income Guaranteed Option, a fully benefit-responsive guaranteed investment contract with Principal. Principal maintains contributions in a general account. The account is credited with the Composite Crediting Rate and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 was \$1,032,952. The crediting interest rate is the composite crediting rate, which will never be less than the guaranteed minimum interest rate. Such interest rates are reviewed on a semiannual basis for resetting. At December 31, 2024, the composite crediting rate equaled 4.95%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that there are no events that would limit the Plan's ability to transact at contract value with participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract does have a surrender charge of 5% that may be charged based on cumulative transfer percentages and advance notice of intent to terminate if a Plan terminates its interest in the contract.

The guaranteed investment contract is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets as would be found in a stable value fund. As a result, the average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract.

5. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a as Principal Trust Company, and Vanguard Fiduciary Trust Company, the Trustees have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Under ERISA, a party in interest has a defined relationship with the Plan and includes fiduciaries, service providers, employers, and others that have a relationship with the Plan or the Company. ERISA prohibits certain transactions between a retirement plan and a party in interest that creates a potential conflict of interest. Principal Life Insurance Company provides contract administrative services to the Plan pursuant to the Plan Expense Agreement with the Company and, therefore, is a party-in-interest. During the year ended December 31, 2024, the Plan paid contract administrative fees totaling \$25,832 to Principal Life Insurance Company and other fees totaling \$200 for other services. These transactions qualify as exempt party-in-interest transactions as the services are essential to the on-going operation of the Plan. Fees incurred by the Plan for investment management services are netted against investment income, as they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants are also defined by ERISA as exempt party in interest transaction.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contributions.

8. TAX STATUS

The underlying Non-Standardized Pre-Approved Profit Sharing Plan designed by CCH Incorporated DBA FTWilliam.com has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the "Code"), and, therefore, the related trust is tax-exempt. The Plan Sponsor has determined that it is eligible to and has chosen to rely on the IRS opinion letter for the Plan. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

10. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

11. DELINQUENT CONTRIBUTIONS

During the year ended December 31, 2024, the Company remitted \$36,795 of participant deferrals 18 days after the amounts were withheld from the participant's pay. When the Company had originally transitioned to Principal from Vanguard, a control was implemented requiring a review process before Principal could automatically process deferrals into the Plan. In June 2024, the Company modified this control, which inadvertently caused the next payroll's participant deferrals to be remitted late. The Company did not identify this error until the following month. The control has since been corrected, and no other late remittances occurred during the Plan year. The Company will remit lost earnings to the affected participants by December 31, 2025.
