NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Lancaster-Fairfield CAP, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions. The Plan’s sponsor is the Lancaster-Fairfield Community Action Program, Inc. (the “Employer”).

General

The Plan is a defined contribution plan covering substantially all employees of the Employer. An employee is immediately eligible to defer a portion of their pretax compensation into the Plan. Eligible employees are employees who have attained the age of 21 and completed one year of service.

Contributions

The following types of contributions are permissible under the Plan: employee salary deferrals including Roth 401(k) deferrals, Employer matching contributions, Employer profit sharing contributions and employee rollover contributions. For purposes of the Plan, compensation is generally defined as total compensation that is subject to income tax and paid to the employee by the Employer during the Plan year. In addition, salary reductions to this Plan and to any other plan or arrangement will be included in compensation.

Participant Accounts

Each participant’s account is credited with deferred contributions, Employer contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are fully vested in their contributions and actual earnings thereon. Employees will be fully vested in certain Employer contributions after five years.

Notes from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account. Principal and interest are paid ratably through monthly payroll deductions.

Hardship Withdrawals

Hardship withdrawals are permitted by the Plan. A hardship distribution may be made to satisfy certain immediate and heavy financial needs. Examples of qualifying expenses include: medical, purchase of a principal residence, tuition for post-secondary education, prevention of eviction or foreclosure, funeral expenses, disaster or Coronavirus-related relief, and the repair of a principal residence.

Payments of Benefits

Upon termination of service, a participant may elect to receive the vested value of their account in a lump-sum payment or installments. Benefits are recorded when paid.

Forfeitures

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,184 and \$5,952, respectively. These accounts will be used to reduce future Employer contributions. Also, in 2024 and 2023, Employer contributions were reduced by \$2,974 and \$800, respectively, from forfeited non-vested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accounting principles that are followed by the Plan and the method of applying those principles conform to U.S. generally accepted accounting principles (U.S. GAAP).

A summary of the significant accounting and reporting policies applied in the presentation of the accompanying financial statements follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting Estimates

The financial statements have been prepared in conformity with U.S. generally accepted accounting principles. In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ significantly from those estimates.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The net appreciation in fair value of investments includes investments purchased, sold, and held during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Valuation of Investments (Continued)

Contract value is the relevant measurement attribute for the portion of the net assets available for benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Administrative Expenses

Certain administrative functions are performed by officers and employees of the Employer. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Employer.

NOTE 3 – INVESTMENTS

The Plan investments are administered by Nationwide Trust Company (the “Trustee”). The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate. Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor (DOL)’s Rules and Regulations for Reporting and Disclosure under Employee Retirement Income Security Act of 1974 (ERISA), the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedules, related to investments:

NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive investment contract with Nationwide Trust Company (“Nationwide”). Nationwide maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal, and a specified interest rate is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported by to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value of credit risk of the contract issue or otherwise. The fair value of the guaranteed investment contract at December 31, 2024 and 2023, was \$89,133 and \$91,923, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, with no minimum interest rate established. The crediting interest rate is established annually and is applied to all ongoing contributions made to the account. Interest rates are not subject to resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity was provisions; (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, and (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable. The average yield with adjustment to reflect the rate credited to participants is 1.97 percent as of December 31, 2024.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6 – TAX STATUS

The Internal Revenue Service (IRS) has previously determined and informed the Trustee by letter dated June 30, 2020, that the Plan, a defined contribution plan and related trust, is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under the Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Participant loans held by the Plan reflect party-in-interest transactions. The Employer may absorb significant costs incurred in relation to the administration of the Plan. Such costs include legal and accounting fees of \$14,420 for the year ended December 31, 2024.

NOTE 8 – FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan discloses fair value of its financial instruments. Financial instruments are defined as cash, evidence of ownership in an entity, or a contract which creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. If quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument. Investments, contributions receivable, and notes receivable from participants would be considered financial instruments. At December 31, 2024, the carrying amount of these financial instruments approximates fair value.

NOTE 9 – FAIR VALUE MEASUREMENTS

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level I: Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.
- Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
