INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Seward Co-op 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Seward Co-op 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF PLAN

The following description of the Seward Co-op 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution safe harbor 401(k) plan covering substantially all employees of Seward Community Cooperative, Inc. (the Co-op or the Employer) who have completed one year of employment with at least 1,000 hours of service and are age twenty-one or older. The Plan excludes non-resident aliens, leased employees, and on-call employees.

The Plan document was restated effective September 9, 2022, to comply with Internal Revenue Service regulations.

The Plan's custodian is John Hancock Life Insurance Company and the Plan's sponsor and Plan Administrator is Seward Community Cooperative, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Investments with John Hancock Life Insurance Company are held in pooled separate accounts.

Contributions - Participants are allowed to make elective deferral contributions up to IRS limits, as defined in the Plan. These contributions can be made pre-tax (traditional 401(k)) or after-tax (Roth 401(k)). In addition, participants who have attained age 50 are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Co-op made safe harbor matching contributions to the Plan equal to the sum of 100% of each participant's deferred contribution up to 4% of the participant's eligible compensation. The Plan allows for additional qualified non-elective contributions in amounts determined at the sole discretion of the Co-op's management. No additional qualified non-elective contributions were made in 2024.

1. DESCRIPTION OF PLAN (Continued)

Vesting - The participant's elective deferral contributions and earnings thereon are always 100% vested. Co-op contributions made after December 31, 2015, and earnings thereon, are always 100% vested. Co-op contributions made prior to December 31, 2015, and earnings thereon, are 100% vested after six years of credited service. Notwithstanding the above, a participant's account will be fully vested upon death, disability, or retirement after age 65 is reached.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Co-op's safe harbor matching contributions plus the Co-op's additional qualified non-elective contributions, if any, and (b) Plan earnings and increases or decreases in the value of investments, net of expenses. Allocations are based on account balances, participant earnings or specific participant transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant will receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If a participant terminates employment and the participant's vested account balance is less than \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

Forfeitures - Forfeitures are first used to pay any administrative expenses under the Plan. Any remaining forfeitures will be used to reduce Co-op contributions payable under the Plan, at the discretion of the Co-op's management. At December 31, 2024 and 2023, no forfeitures were available to pay administrative expenses or reduce future employer contributions. In 2024, no forfeitures were used to pay employer contributions or administrative expenses.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Co-op contributions are allocated on the same basis as employee contributions.

1. DESCRIPTION OF PLAN (Continued)

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms may range from 1 to 5 years or up to 15 years for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at prime plus two percent. The interest rates on notes outstanding at December 31, 2024 were 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net investment income or loss includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

Administrative Expenses - The Co-op pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

Payment of Benefits - Benefits are recorded when paid.

4. **INCOME TAX STATUS**

The volume submitter plan document adopted by the Plan obtained its latest advisory letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts are each invested in a distinct underlying mutual fund. The fair value of each pooled separate account is determined using the value per unit, which is based on the value of the underlying fund shares which are actively traded. There are no redemption restrictions in the pooled separate accounts. Because net asset value is used as a practical expedient, these investments are not categorized within the fair value hierarchy.

The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the pooled separate accounts could result in a different fair value measurement at the reporting date.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balance in their respective accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are shares of pooled separate accounts managed by and held by the custodian and, therefore, these transactions qualify as party-in-interest transactions.

The notes receivable from participants qualify as party-in-interest transactions.

The Plan's sponsor pays certain administrative expenses of the Plan.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 1, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
