## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. REPORTING ENTITY AND DESCRIPTION OF THE PLAN**

The following description of the Pharmpix Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

**Plan Description** - The Plan is a defined contribution retirement plan covering all employees, except for temporary employees.

The Plan was established on October 1, 2016, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Contributions** - Participants are permitted to make elective contributions up to the maximum amount in accordance with the provisions of the Puerto Rico Internal Revenue Code of 2011, as amended (\$15,000 for the year ended December 31, 2024 and 2023), in accordance with the provision of the Plan. Participants who are age 50 or older may make additional pre-tax catch-up contributions not exceeding \$1,500.

The Plan sponsor can make discretionary matching contributions to the Plan.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions and allocations of (a) the Plan Sponsor’s contributions and, (b) Plan’s earnings, and charged with an allocation of administrative expenses. Allocations are based on participant’s compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Participant Loans** - Participants may borrow from their vested account balance up to the Internal Revenue Service limit.

**Forfeitures** - Forfeitures under the plan may be used to reduce related plan costs and expenses and/or reduce the amounts the plan sponsor will contribute to the Plan. For the year ended December 31, 2024, forfeitures of \$5,371 were used to reduce plan administration fees. For the year ended December 31, 2023, forfeitures of \$25,370 and \$2,138 were used to reduce plan sponsor contributions and plan administration fees, respectively. As of December 31, 2024 and 2023, there were unused forfeitures of \$8,067 and \$13,424, respectively. Forfeitures are recorded within cash and cash equivalents in the accompanying statements of net assets available for benefits.

**Vesting** - With regard to participants’ accrued benefits derived from employer contributions, the participant will become vested based on completed years of service in accordance with the following schedule:

**Investment Options** - Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

**Payment of Benefits** - On termination of service due to retirement or death, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. There were no benefits payable to terminated participants as of December 31, 2024 and 2023.

**Hardship Withdrawals** - Under certain circumstances, as defined by the Plan, and pursuant to Puerto Rico tax regulations, participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The Plan's financial statements are prepared on the accrual basis of accounting. A summary of the most significant accounting policies used by the Plan are as follows:

**Use of Estimates in the Preparation of Financial Statements** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Cash and Cash equivalents** - Cash includes demand deposit while cash equivalents consist of all highly liquid investments, with original maturities of three months or less from the date of purchase, that are readily convertible to known amounts of cash.

**Contributions** - Employee contributions are recorded in the Plan period in which the Plan Sponsor makes payroll deductions from the Plan participants' earnings. Plan Sponsor's contributions are recorded when the board of directors have approved the amount to be contributed to the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 3 of the financial statements for additional disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net increase in the fair value of investments includes the Plan's unrealized gains and losses held at December 31, 2024 and 2023.

**Payment of Benefits** - Benefits are recorded when earned, which occurs when the benefit requested are approved by the Board of Directors. There were no benefits payable to terminated participants as of December 31, 2024 and 2023.

**3. FAIR VALUE MEASUREMENTS**

The FASB's authoritative guidance on *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under this guidance are described below.

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- a) Quoted prices for identical or similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual Funds and Fixed Income Fund* - The fair value is based on quoted net asset values ("NAV") of the shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Transfers Between Levels* - The availability of observable market data is constantly monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. There were no transfers between fair value levels during the year.

**4. INFORMATION CERTIFIED BY TRUSTEE**

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to by the trustee as complete and accurate by Banco Popular de Puerto Rico, the Plan's Trustee:

- All investments and corresponding fair values
- Transfers in/out
- Net appreciation or depreciation in fair value of investments
- Interest income and dividends
- Benefit payments
- Administrative expenses incurred and accrued

**5. TAX STATUS**

Effective October 1, 2016, the Plan was granted a qualification letter from the Puerto Rico Department of Treasury to operate under the provisions of section 1081.01 of the Puerto Rico Internal Revenue Code of 2011, as amended.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Puerto Rico Treasury Department. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in these financial statements.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to compliance with certain ERISA provisions. In the event of a Plan termination, each participant will retain a fully vested and nonforfeitable interest in his or her accounts. Upon such event, the Trustee will distribute to each Participant (or other person entitled to distribution) the value of the participant's accounts in a single lump sum payment.

**7. INVESTMENT RISKS**

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits. Individual participant's accounts bear the risk of loss resulting from fluctuations in fund values.

**8. PARTIES-IN-INTEREST**

As the trust company of the Plan, Banco Popular de Puerto Rico is considered as a party in interest, however, the services provided qualify as allowable party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued and concluded that there were no subsequent events requiring disclosure to these financial statements.
