INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Participants, and Beneficiaries of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cadwalader, Wickersham & Taft LLP Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cadwalader, Wickersham & Taft LLP Defined Contribution Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cadwalader, Wickersham & Taft LLP Defined Contribution Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. Description of Plan

The following description of the Cadwalader, Wickersham & Taft LLP Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, with a 401(k) arrangement established effective July 1, 1985, as restated August 1, 2017. The Plan covers partners and staff, as defined in the Plan document, of Cadwalader, Wickersham & Taft LLP (the "Firm" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Administration - The Plan is administered by the Firm, which is responsible for carrying out the provisions of the Plan. The Plan is funded through a trust of which Fidelity Management Trust Company ("Fidelity") is the trustee.

Eligibility - Partners and staff of the Firm are eligible to participate in the Plan on the first day of the month after the date of hire and attaining the age of 21. Non-legal and legal staff (together "employees") and partners may elect to make Participant Contributions (as described below) at the beginning of the first month once these requirements have been met or at any time thereafter.

Contributions

Participants may elect to have their annual compensation (in the case of employees) or distributions (in the case of partners) reduced by a specified amount from 1% to 50% and have the amount of the reduction contributed to the Plan as an Elective Contribution (including Roth Elective Contribution in the case of the employees). Elective Contributions other than Roth Elective Contributions are tax-deferred amounts that the participant elects to have contributed to the Plan; in the case of an employee, the participant's compensation is reduced by the amount of the Elective Contribution. The accumulations and earnings in a participant's Elective Contribution account build on a tax-deferred basis. Roth Elective Contributions are made on an after-tax basis but the earnings on which are tax-exempt upon withdrawal, if certain requirements are met. Participants may also make Voluntary Contributions which allow a participant to contribute additional amounts over the standard 401(k) limits on an after-tax basis, as defined in the Plan document. Voluntary Contributions can be made either in a lump sum or through payroll deductions from compensation or distributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional contributions above the otherwise applicable limitations, known as "catch-up contributions." Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible staff employees are automatically enrolled 35 days after their date of hire in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. In no event may participant pre-tax and after-tax contributions exceed any statutory limitations.

The Plan also provides for a Firm Profit Sharing contribution to each participant who is a partner. Such contribution will amount to 13.33% of partner compensation as defined in the Plan, but not more than \$46,000 in 2024.

The Firm also makes, on behalf of Basic Participants only, a Firm Basic Contribution ranging from 4% to 12% of the participant's Basic Compensation, as defined in the Plan document, for the six-month period beginning on January 1 or July 1, provided they are Basic Participants on such January 1 or July 1. Basic Participants are non-legal staff who have both attained age 21 and completed one year of service.

On behalf of each Matching Participant, the Firm makes a Firm Matching Contribution equal to 50% of the employee's Elective Contribution (including Roth Elective Contributions) for the Plan year, up to a maximum Matching Contribution of 3% of Compensation provided that the Matching Participant is employed on the last day of the Plan year. Matching Participants are non-legal staff who have both attained age 21 and completed three years of service; such employees become Matching Participants on the earliest January 1 or July 1 after both events occur.

The Firm Basic Contribution and Firm Matching Contribution receivables are included in the Firm contribution's receivable in the statements of net assets available for benefits. The Firm Basic Contribution receivable was \$1,247,830 and \$1,094,747 at December 31, 2024 and 2023, respectively. The Firm Matching Contribution receivable was \$550,761 and \$ 577,581 at December 31, 2024 and 2023, respectively.

Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the Participant's Contributions, the Firm contributions, and an allocation of the Plan earnings, and charged with withdrawals and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change those investments at will.

Vesting

Participants are vested immediately in their contributions, Firm Basic Contributions, Firm Profit Sharing Contributions and Firm Matching Contributions, plus actual earnings thereon. Prior to October 1, 2018, participants were subject to various vesting schedules for their Firm Basic Contributions and Firm Profit Sharing Contributions (20% vested after 2 years and continued to vest 20% per year and became fully vested after 6 years, or fully vested upon 3 years of service).

Notes receivable from participants

Loans may be made to participants upon their request, subject to approval by the Firm. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate for loans is established by the Plan administrator from time to time as provided in the loan policy based upon market conditions and surveys of various commercial lenders. Generally, the rate established for loans of five years or less has been approximately one point above the prime rate, and, for longer terms, approximately two points above the prime rate. Principal and interest are paid through payroll deductions or deductions from partners' distributions in equal payments sufficient to fully amortize the loan over its term. Loan terms may not exceed five years, except for loans that are taken for the purpose of acquiring a participant's principal residence. As of December 31, 2024, outstanding participant loans have maturities through 2050 and bear interest ranging from 4.25% to 10.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, installment payments or partial payments. Installment payments are payable over a fixed number of years elected by the participant which may not exceed the life expectancy of the participant, or the joint life expectancies of the participant and his or her beneficiary. Upon attainment of age fifty-nine and one-half, participants may withdraw part or all of their balance in their Elective Contribution and Roth Contribution accounts. Participants are also eligible to withdraw part or all of their balance in their Voluntary Contribution accounts. Participants are eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. These financial hardships include certain disasters declared by FEMA. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

The Plan document requires that forfeited nonvested accounts be used to reduce employer contributions for the current Plan year, with any excess carrying over to next Plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated by the employer as a Firm Basic Contribution or Firm Profit Sharing Contribution, as applicable. The Plan's forfeited nonvested accounts balance was approximately \$128,000 and \$166,000 at December 31, 2024 and 2023, respectively.

During the year ended December 31, 2024, approximately \$459,000 of forfeitures were used to reduce Firm Contributions as follows: 1) approximately \$218,000 to reduce deposit of prior year Firm Basic, Matching and Gateway Contributions, and 2) approximately \$241,000 to reduce deposit of Basic Contribution for the six-month period ended June 30, 2024. The Firm Contributions receivable in the amount of \$1,798,591 recorded as of December 31, 2024 is presented net of approximately \$104,000 of forfeitures used to reduce this employer contribution.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Substantially all expenses, with the exception of fees related to notes receivable from participants and distribution fees, incurred in connection with the administration of the Plan are paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, the date these financial statements were available to be issued. There were no subsequent events requiring adjustment to or disclosure in the financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds (registered investment companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund (collective investment trust): Valued at NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to make a full withdrawal from the Vanguard Retirement Savings Trust III ("VRST III"), a twelve-month notice is required. VRST III reserves the right to temporarily delay Plan-level withdrawals pending availability of cash proceeds from the sale of securities liquidated to fund a withdrawal and other circumstances as determined by the VRST III's trustees.

Any such withdrawal may be made in cash or in-kind in the discretion of the VRST III's trustees. For participant-level transactions relating to the VRST III, reinvesting in a competing investment is prohibited for ninety days.

4. Information Certified by Trustee

Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. Related-Party and Party In Interest Transactions

Certain Plan investments are shares of registered investment companies and units in a collective trust managed by the trustee. Investment management service fees were netted against the return credited to the Plan on each investment. Certain of these transactions may constitute party-in-interest transactions, but if so, are exempt from sanctions applicable to such transactions by reason of exemptions promulgated by the Department of Labor. Fees paid by the Plan to Fidelity Workplace Services LLC, for recordkeeping and investment advisory services were \$130,651, for the year ended December 31, 2024.

Certain employees of the Firm who participate in the Plan perform administrative services related to the operation, recordkeeping, and financial reporting of the Plan and use the Firm's facilities to do so. In addition, certain employees of the Firm who participate in the Plan, and who are parties-in-interest, have borrowed funds from the Plan. These transactions are party-in-interest transactions but are covered by statutory exemptions under the IRC and ERISA, and administrative exemptions promulgated thereunder.

6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, each participant or beneficiary would receive the current value of his/her account in a manner prescribed by the Plan which is subject to the provisions set forth in the IRC and ERISA.

7. Tax Status

The Internal Revenue Service ("IRS") issued favorable determination letter with respect to the Plan dated June 13, 2017, having found that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since issuance of the letter, and, effective August 1, 2017, has undergone a merger with two related plans. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, Plan management believes it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the securities, and therefore, the value of the participant's account balances and amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.
