#### NOTE A - DESCRIPTION OF THE PLAN

The following description of the Signode Industrial Group LLC Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### **General**

The Plan is a defined contribution plan available to all full-time and part-time, non-bargaining unit employees of Signode Industrial Group LLC (the Company) and certain of its subsidiaries and affiliates (the Company, its subsidiaries and its affiliates are collectively referred to as the Employer). Eligible employees are defined as employees who were eligible to participate in the Illinois Tool Works (ITW) Plan on April 30, 2014, or will become eligible to participate in the Plan on their employment commencement date, which could depend on factors such as 1,000 hours of service or completion of 12 consecutive months of employment. The Plan is administered by a committee appointed by the senior vice president of human resources of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). During 2023, the Plan changed recordkeeper and trustee on or about June 20, 2023, all assets of the Plan were transferred from Fidelity Management Trust Company (Fidelity or Former Trustee) to Vanguard Fiduciary Trust Company (Vanguard or Trustee). The Plan was also amended and restated effective June 20, 2023.

##### **Participant Plan Transfers**

Participant account balance transfers between the Plan and a plan maintained by an affiliate are permissible whenever an employee participating in the Plan changes positions within the Plan sponsor's organization or an amendment to the Plan document and/or labor agreement occurs, causing the employee to no longer be eligible to participate. In either case, the participant account balance may be transferred to the Plan for which the employee becomes eligible for participation upon the Company's direction and in accordance with the Plan document.

##### **Contributions**

Employees electing to participate in the Plan may contribute up to 50% of their pretax annual compensation, as defined by the Plan and the Internal Revenue Code (IRC), as a combination of pretax and Roth, subject to Internal Revenue Service (IRS) limitations. Effective June 20, 2023, employees are allowed to make deferral elections on separate bonus (incentive/commission). Eligible employees who do not affirmatively elect to make participant contributions or decline to participate during the first 60 days of employment shall be automatically enrolled in the Plan at a rate of 3% of their compensation. Participants over 50 years of age may make additional contributions (catch-up contributions) to the Plan. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company matches the first 3% of compensation that a participant contributes to the Plan. For every additional 1% that the employee contributes above 3%, the Company matches an additional 0.5%, up to a maximum matched contribution of 4.5%. Effective June 20, 2023, the Company elected to match 100% of salary deferrals up to 6% of plan compensation. The Plan also provides for an additional contribution (Company basic contribution) to eligible participants hired before January 1, 2015. These contributions are included in the Employer contribution balance in the statement of changes in net assets available for benefits.

##### **Vesting**

Participant and Company matching contributions are fully vested at all times. Company basic contributions made into the Plan vest after three years of eligible service.

***Investment Options***

Participants direct the investment of their contributions and account balances into various investment options offered by the Plan. Investment options include a self-directed brokerage option.

Participant and Company contributions may be directed to any of the eligible investment options offered by the Plan.

***Participant Accounts***

Individual participant accounts are maintained and credited with participant contributions, Employer contributions and allocations of the Plan's earnings or losses. Allocations of each fund's earnings or losses are based on the ratio of each participant's account balance in such fund to the total of all participants' balances in that fund. The costs of certain administrative and investment services provided by the trustee are paid from participants' accounts or assets within the appropriate investment option, as applicable.

***Forfeitures***

Forfeitures that arise as of any valuation date shall be determined and applied to reduce the amount of Company matching contributions, Company basic contributions or for Plan expenses in accordance with the Plan document. There were \$42 and \$7,866 of forfeited non-vested accounts from Company contributions at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, approximately \$203,000 was used to offset Company basic contributions.

***Payment of Benefits***

Upon retirement, termination of employment, death or physical disability, benefits are payable in one lump sum or installments not less frequently than annually, as permitted by the Plan. Participants who terminate service with the Company and have a vested account balance of less than \$1,000 will have their vested account balance distributed in a single lump sum or partial payments unless it is rolled over into another qualified plan.

Participants may be permitted to withdraw contributions in the case of financial hardship, subject to certain limitations. Participants less than age 59½ are allowed source-specific in-service withdrawals as stated in the Plan document. Participants are entitled to receive payments without terminating employment upon attainment of age 59½. Participants who have terminated employment and reached a certain age are required to take minimum required distributions in accordance with the terms of the Plan and applicable law. As of January 1, 2023, the required minimum distribution age was amended to be age 73.

***Notes Receivable from Participants***

Participants may borrow up to 50% of their vested account balances up to a maximum of \$50,000, less the highest outstanding loan balance(s) within the last 12 months (subject to certain limitations set forth in the Plan), for terms not exceeding five years. Principal and interest are paid ratably through payroll deductions.

Participants may have up to two outstanding loans at any given time and only one loan may be taken during any 12-month period. The interest rate charged on loans is based on a nationally published prime rate by Reuters in effect on the first business day of the calendar quarter in which the loan is requested and will be a fixed rate for the term of the loan. The loans are secured by the balances in the participant's vested accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts in the financial statements and disclosures. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan provides participants the option to direct their contributions to numerous investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Valuation of Investments***

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques that are consistent with the market, income or cost approach are used to measure fair value. See Note C for description of investments held by the Plan at fair value.

***Income Recognition***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

***Administrative Expenses***

Certain trustee, record-keeping, administrative and investment management fees are paid by the Plan. All other expenses of the Plan are paid by the Company.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based on the terms of the Plan document. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Benefit Payments***

Benefit payments to participants are recorded upon distribution.

**NOTE C - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

- Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access;
- Level 2 - Inputs (other than quoted prices included within Level 1) are observable for the asset or liability, either directly or indirectly which include;
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
- Level 3 - Inputs are unobservable for the asset or liability and rely on management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. (The unobservable inputs should be developed based on the best information available in the circumstances and may include the Plan's own data).

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the net asset value (NAV) of shares held at year-end, which is obtained from an active market.

*Collective trust funds* - Valued at the NAV of units of each bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust for up to 12 months in order to ensure that securities liquidations will be carried out in an orderly manner. There are no unfunded commitments for the collective trust funds.

*Self-directed brokerage accounts* - Valued based on the underlying holdings which consist primarily of mutual funds, common and preferred stocks, and corporate bonds which are valued based on the quoted closing price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - TAX STATUS**

The Plan previously adopted the Former Trustee's nonstandardized prototype plan document which received an opinion letter dated June 30, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC. In June 2023, in connection with the change to the current Trustee, the Plan amended and restated the Plan by adopting the current Trustee's nonstandardized prototype plan document which also received an opinion letter dated June 30, 2020. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the Plan and related trust are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 or 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE F - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE G - PARTIES-IN-INTEREST**

Certain investments are currently managed by an affiliate of Vanguard, the current Trustee. Therefore, these transactions qualify as party-in-interest. Additionally, the Plan has loans to participants that also qualify as party-in-interest transactions.

**NOTE H - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024, financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
