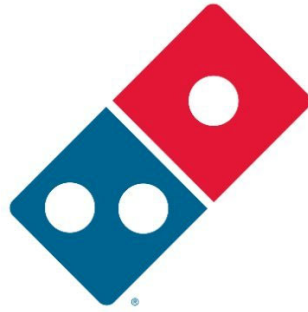

NOTE – A: DESCRIPTION OF THE PLAN

The following description of the Boston Pie, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established to provide substantially all employees of Boston Pie, Inc. and Master Pie, Inc. (collectively, the “Company”), with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance. Empower Trust Company, LLC is the trustee of the Plan and Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as recordkeepers for the Plan.

Eligibility: All employees of the Company, other than non-resident aliens and those covered by a collective bargaining agreement, who have attained the age of 21 are eligible after 1 year of service, as defined by the Plan.

The Plan includes an automatic enrollment provision. Therefore, upon meeting the eligibility requirements, the Company automatically, on behalf of the participants, defers 3% of the participants' eligible compensation, as defined by the plan document.

Participant Contributions: Upon meeting eligibility requirements, participants may contribute up to the maximum amount permitted by Code Sections 401(k), 402(g), 404 and 415 (\$23,000 in 2024). Participants may also contribute amounts representing distributions from other qualified plans. Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional “catch-up” contribution (\$7,500 in 2024). Participants may cancel, modify or otherwise as allowed change any of the automatic elections at any time. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds, common collective trust funds and a guaranteed investment account as investment options for participants.

Employer Contributions: The Company may contribute a discretionary matching contribution on behalf of active participants. During the year ended December 31, 2024 the Company made matching contributions of 10% of a participant's contribution on the first 4% of eligible compensation, excluding catch-up contributions. During the year ended December 31, 2024, employer matching contributions totaled \$21,084.

The Company may also make discretionary non-elective profit-sharing contributions on behalf of eligible participants. Participants must have provided 1,000 hours of service during the plan year and must be employed on the last day of the plan year to be eligible for non-elective profit-sharing contributions. The Company did not make any non-elective profit-sharing contributions during the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the (a) Company's contribution and, (b) Plan earnings (losses), and an allocation of administrative expenses paid by the Plan.

NOTE – A: DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants are fully vested immediately in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's contributions upon attaining the age of 65 or completing six years of credited service, whichever occurs first.

Prior to attainment of six years of service, participant vesting in Company contributions is determined as follows:

Forfeited Accounts: When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeitures are retained in the Plan and are used to offset future employer discretionary contributions to the Plan and pay qualifying expenses. During the year ended December 31, 2024, forfeitures totaling \$701 were used to reduce the Company's discretionary matching contribution and forfeitures totaling \$3,765 were used to pay qualifying expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$244 and \$1,043, respectively and are included in investments, at fair value, on the accompanying statements of net assets available for benefits.

Payment of Benefits: Benefits equal to the value of the participant's vested interest in his or her account may be distributed upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions from the Plan may be made in a single lump sum, installments or partial withdrawals. Withdrawals from the Plan before termination of employment are available upon attainment of the age of 59.5 or upon demonstration by the participant to the plan administrator that the participant is suffering from a "hardship", as defined by the Plan. Distributions to participants are recorded when paid.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested interest in the Plan, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% plus the prime rate as published in the Wall Street Journal on the first business day of the month in which the loan originated. Loan repayment terms shall not exceed 5 years. However, if the loan is used to acquire the principal residence of the participant, the term may be extended to 15 years. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

NOTE – A: DESCRIPTION OF THE PLAN (Continued)

Other Income: The Plan includes a recordkeeping expense account, under which certain mutual fund expenses that are charged by the mutual fund companies to the individual participants are recaptured by the Plan and held in a guaranteed investment account. These funds are then used to pay for expense of the Plan that benefit the Plan's participants as approved by the IRC, Department of Labor and ERISA. During the year ended December 31, 2024 these funds totaled \$1,020, and are included in other income on the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, there was no remaining balance in the recordkeeping expense account.

NOTE – B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting/Presentation: The accompanying financial statements have been prepared on the accrual basis of accounting. The financial statements and notes are representations of management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Investment Value and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note C for a discussion of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the period or at the time of purchase during the period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation includes realized and unrealized gains and losses on the fair value of investments held by the Plan.

Expenses: Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in either net appreciation of fair value of investments or administrative expenses. The Plan sponsor has elected to absorb administrative costs of the Plan.

Use of Estimates: Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Accordingly, actual results could differ from those estimates, and such differences may be material.

Reclassifications: Certain reclassifications have been made to the prior year's financial statements to conform to the current year presentation. These classifications had no effect on previously reported results of operations or net assets.

NOTE – C: FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), Topic 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. This hierarchy consists of three broad levels:

- *Level 1* – Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority,
- *Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* – Inputs that are unobservable for the asset or liability that are significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and level 3 inputs are only used when higher level inputs are not available. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no assets or liabilities measured at fair value on a non-recurring basis.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment account: Valued using a discounted cash flow valuation methodology where the interest rate is reset on at least an annual basis and the discount rate is a risk based market rate.

Common collective trust funds: Valued at the NAV per unit based on the underlying assets. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair values. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE – C: FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. Fair values of assets and liabilities measured on a recurring basis at December 31, 2024 and 2023 are as follows:

NOTE – D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, any unallocated assets of the Plan would be allocated to participant accounts and account balances will be distributed in full to participants.

NOTE – E: TAX STATUS

The Plan operates under a pre-approved plan which has received a favorable opinion letter from the Internal Revenue Service dated November 14, 2022, indicating that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Plan management believes and represents that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated the tax positions taken or expected to be taken and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE – G: PARTIES-IN-INTEREST

Party-in-interest transactions include those transactions with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are mutual funds and a guaranteed investment account managed by Empower Retirement LLC, a subsidiary of the Plan's trustee and therefore these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules, as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions that are exempt from the prohibited transactions rules, as defined by ERISA.

NOTE –H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE – I: CONCENTRATIONS

At December 31, 2024, two investments accounted for 40% of the Plan's total investments. At December 31, 2023, two investments accounted for 37% of the Plan's total investments.
