### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of TimelyCare 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the TimelyCare 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more comprehensive description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Timely Telehealth, LLC (the "Company", "Plan Sponsor", or "Employer"), was established effective January 1, 2020. The Plan was most recently restated effective April 1, 2024, and is designed to comply with Section 401(a) and related provisions of the Internal Revenue Code (IRC). The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan covers substantially all employees of the Company and its affiliate Telehealth Physicians Network, PLLC, who meet certain eligibility requirements and is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services are provided by Charles Schwab Trust Bank (the "Trustee"), while recordkeeping services are performed by Ascensus, LLC (as of December 31, 2024 and for the period from November 14, 2024 through December 31, 2024) and were performed by Newport Retirement Services (for the period from January 1, 2024 through November 13, 2024) (the "Recordkeepers"). The Trustee is responsible for the custody and management of the Plan's assets while the Recordkeepers manage participants' accounts and related transactions.

Eligibility

All employees of the Company are eligible to participate in the Plan immediately after 1 month of employment and attainment of age 21, except for any part-time, temporary, or seasonal employees, or employees with fewer than 1,000 hours of service; union employees, nonresident aliens, and leased employees. Eligible employees may enter the Plan on the first day of the month coincident with or next following the date the requirements are met.

Eligibility (continued)

Effective April 1, 2024, the eligibility requirements were amended as follows. Part-time employees can fully participate in the Plan. Seasonal and temporary employees can make elective deferrals only. Excluded employees for all contribution types are union employees, nonresident aliens, and leased employees. Excluded employees for safe harbor, matching, and nonelective contributions are temporary employees and seasonal employees.

Contributions

Participants may elect to contribute through payroll deductions amounts up to 100% of their annual eligible compensation, as defined by the Plan, on a pre-tax or after-tax (as Roth contributions) basis, up to a maximum amount allowed by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC limit, which was \$7,500 for 2024. Unless otherwise elected by the participant, all eligible employees are automatically enrolled in the Plan at a pre-tax deferral rate of 2% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified employer-sponsored retirement plans or individual retirement accounts (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching Employer contributions, discretionary nonelective Employer contributions, and safe harbor matching Employer contributions. Effective January 1, 2024, the safe harbor matching Employer contribution is 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's eligible compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's eligible compensation but do not exceed 5% of the participant's eligible compensation. The safe harbor matching Employer contribution totaled \$909,793 for the year ended December 31, 2024. The Company did not make any discretionary matching or nonelective Employer contributions for the year ended December 31, 2024.

Participant accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, rollovers, allocations of the Company's contributions, if any, and investment earnings and charged with an allocation of investment losses and administrative expenses not paid directly by the Company. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions and rollovers, plus actual earnings thereon. As of March 31, 2023, discretionary matching Employer contributions are vested immediately. As of January 1, 2024, safe harbor matching Employer contributions are vested immediately. Prior to March 31, 2023, discretionary matching Employer contributions were subject to same vesting schedule as the discretionary nonelective Employer contributions.

The vesting schedule for the discretionary nonelective Employer contributions is as follows:

Participants become fully vested in discretionary nonelective Employer contributions if the participant incurs severance from employment from the Employer as a result of full and permanent disability or death.

Payment of benefits

Distributions and withdrawals are payable to participants upon retirement, termination of employment, attainment of age 59 ½, financial hardship, disability, or death. Normal retirement age is 65 years. If the participant's vested account balance is equal to or less than \$5,000 upon termination, the balance will be rolled over to an individual retirement account designated by the plan administrator immediately if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents.

Effective January 1, 2024, the Plan's involuntary cash out and automatic rollover provision amount was increased from \$5,000 to \$7,000.

Notes receivable from participants

Participants may borrow against their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable (or "loans") terms are generally five years or less, but may exceed five years if the purpose of the loan is to purchase a principal residence. Participants may only have one loan outstanding at any time. The notes receivable are secured by the remaining balance in the participant's account and bear interest determined by the Plan administrator based on the prevailing interest rates. Interest rates ranged from 10.00% to 10.50% as of December 31, 2024. Notes receivable from participants mature at various dates through November 2029.

Forfeitures

The Plan provides that forfeited unvested account balances can be used to offset Employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$124 and \$122, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Employer contributions or pay administrative expenses.

Administrative expenses

Certain administrative expenses of the Plan, including recordkeeping and audit fees, were paid directly by the Company for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan and impact Plan earnings.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and the disclosure of contingent liabilities. Actual results may differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. Employer contributions, if any, are recorded in the year they are earned and coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon the contribution recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions are recorded when they are received by the Trustee.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. Delinquent participant loans are recorded as deemed distributions based upon the terms of the Plan documents.

Administrative expenses

Administrative expenses are recorded when incurred.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee, determined to be a qualified institution by the Plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year). The Trustee has certified that the following data included in the financial statements is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of fair value hierarchy are as follows:

- Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the plan has the ability to access.

- Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market, exchange-traded, and mutual funds - Valued at the daily closing price as reported on an open exchange. Such funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

Self-directed brokerage funds - consists of cash and exchange traded funds. Cash is valued at cost, which is fair value. Exchange traded funds are valued as disclosed above.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY AND PARTY-IN-INTEREST

ERISA defines parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management identified related parties to the Plan that were also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan Sponsor pays certain fees on behalf of the Plan. The Plan is not required to reimburse the Plan Sponsor for fees on its behalf.

The Trustee retains as compensation, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Certain Plan investments are owned and managed by the Trustee or their affiliates, therefore, these investment transactions qualify as exempt party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The Plan has adopted the TD Ameritrade Trust Company's Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, stating that the Plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
