Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hand To Shoulder Center of Wisconsin 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - Description of Plan

The following brief description of the Hand To Shoulder Center of Wisconsin 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, as adopted effective January 1, 1989, and restated effective July 31, 2022, covering substantially all employees of Hand to Shoulder Center of Wisconsin (referred to as the "Company"), who have attained the age of 21 and completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service ("IRS"). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants may direct their contributions into various investment options offered by the Plan. All investments are participant-directed.

The Plan adopted a safe harbor match in which the Company makes a nonelective safe harbor contribution equal to 5% of a participant's eligible compensation each year. The Company may also, at its discretion, make annual profit sharing contributions to the Plan. For the year ended December 31, 2024, the Company made profit sharing contributions to the Plan with a calculation that integrates with Social Security. The calculation was determined to be 5.71 percent to 8.33 percent dependent on the participant's Social Security wage base.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor matching contribution, (b) the Company's discretionary profit sharing contribution, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting - Participants are immediately vested in their voluntary contributions, rollover contributions, and safe harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested in the Company's profit sharing contributions after 6 years of credited service.

Participant Loans - The Plan includes a provision allowing eligible participants to borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms generally range from one to five years. Loans for the purchase of a primary residence may exceed the five-year term as deemed by the Plan administrator. Participants are only allowed to have two loans outstanding at one time. The loans are secured by the vested balance in the participant's account and bear interest at a rate equal to 1 percent above the Prime Rate. Interest rates range from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

NOTE 1 - Description of Plan - Continued

Payment of Benefits - Upon a participant's attainment of normal retirement age, disability, termination of service or death, the participant or their beneficiary is entitled to receive the value of his or her vested account balance in the form of a lump-sum distribution, a series of periodic installments not to exceed five years, or partial withdrawals, as described in the Plan's provisions. If the vested benefit is less than \$5,000, a lump-sum distribution will be made regardless of whether or not an election has been made. Hardship distributions from participants' voluntary contributions are permitted if certain criteria are met. The Plan also provides for in-service distributions upon the attainment of age 59 1/2.

Administrative Expenses - All administrative expenses may be paid out of the Plan unless paid by the Plan sponsor. During 2024, expenses were paid by both the Plan and the Plan sponsor.

Forfeited Accounts - Nonvested portions of participants' accounts will be forfeited upon termination of employment. At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$2,783 and \$11,924, respectively. These accounts may be used to reduce future employer contributions or Plan expenses. During 2024, employer contributions were reduced by \$21,320.

NOTE 2 - Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

Basis of Accounting and Presentation - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Notes Receivable From Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through October 13, 2025, the date which the financial statements were available to be issued.

NOTE 4 - Fair Value Measurements

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 - Fair Value Measurements - Continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Pooled Separate Accounts:** Valued at the daily closing price as reported by the fund. These funds publish their daily net asset value (NAV) and transact at that price. The pooled separate accounts held by the Plan are deemed to be actively traded.
- **Partnership Interest:** Valued using the capital accounts which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - Tax Status

The Company became a participating employer in the Pension Inc. Non-Standardized Pre-Approved Profit Sharing Money Purchase Plan with CODA effective July 31, 2022, and is relying on its opinion letter dated June 30, 2020. The Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7 - Transactions with Parties-in-Interest

Fees for legal and professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan utilizes a cash account and holds investments that are managed by John Hancock Life Insurance Company, the custodian of the Plan. The Plan also allows participants to take out loans against their account balances and these transactions are deemed party-in-interest transactions. These transactions are not however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of December 31, 2024 and 2023.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements of net assets available for benefits.

NOTE 10 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.
