### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Fiesta Tableware Company and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union and Local Union No. 419M Individual Account Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Fiesta Tableware Company and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union and Local Union No. 419M Individual Account Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Fiesta Tableware Company and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union and Local Union No. 419M Individual Account Pension Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE A – DESCRIPTION OF PLAN**

The following brief description of The Fiesta Tableware Company (the “Company”) and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union and Local Union No. 419M (the “Union”) Individual Account Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Effective May 1, 2021, The Hall China Company and The United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union and Local Union No. 417M Individual Account Pension Plan Merged with the Fiesta Tableware Plan.

**General**

The Plan is a defined contribution profit sharing pension plan covering all Company employees that are represented by the Union. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Company contributes to the Plan such amounts that are specified by written agreements between the Company and the Union. The contributions to the Plan are based on a prescribed amount of cents multiplied by the hours worked by eligible employees, and are allocated to each participant’s account based on the participant’s actual hours worked. The contribution rate was \$0.75 per labor hour throughout 2024 and 2023.

Participants may elect to contribute, on a salary-deferral basis, amounts up to 100% of their pretax annual compensation but not to exceed certain limitations.

Employees of the Company that meet certain criteria are eligible to receive a death benefit of \$1,000 upon retirement. An account is separately maintained within the investments of the Plan to fund the payments. There were no contributions to the fund during 2024 and 2023. The account had a balance of \$9,454 and \$9,317 at December 31, 2024 and 2023, respectively.

**Participant Accounts and Vesting**

Each participant’s account is credited with the participant’s contributions, the Company’s contribution, and an allocation of plan earning and losses and administrative expenses. Allocations of the Plan’s earnings and losses are based on the proportion that each participant’s account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants are immediately fully vested both in their voluntary and Company contributions plus actual earnings thereon.

If a participant of the Plan is no longer represented by the Union but is still employed by the Company, the participant may transfer their account balance to another defined contribution pension plan maintained by the Company. Similarly, if a non-union employee takes a union position with the Company, the participant may transfer their account balance from their existing defined contribution pension plan with the Company to the Plan.

**Eligibility**

Any Company employee who is represented by the Union is eligible to participate in the Plan. An eligible employee shall cease to be an eligible employee if and when he/she ceases to be employed by the Company or represented by the Union. Eligible employees become a plan participant on their one year anniversary date.

**Notes Receivable from Participants For Hardships**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of the vested balance of their account. The receivables are secured by the balance in the participant's account and must bear interest at the prime rate. Notes had fixed rates of interest ranging from 4.25%- 7.25% for the term of the notes during 2024 and 2023. Principal and interest may be paid through payroll deductions or by check.

**Payment of Benefits**

Upon termination of employment, participants are entitled to 100% of their account balance. Benefits are payable in an amount equal to the value of the participant's vested interest in his or her account, either in a lump sum payment, equal annual installments over a period not to exceed ten years, or in a rollover to an eligible retirement plan.

**Plan Termination**

Although they have not expressed any intent to do so, the Company and the Union have the right to terminate the Plan at any time. Upon termination, the employer may direct benefits to be paid in one lump sum to participants. A complete discontinuance of contributions by the employer shall constitute a termination.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Notes Receivable from Participants for Hardships**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. Accounting standards require that participant loans be classified as notes receivable from participants in the accompanying financial statements; however, the Department of Labor requires these to be classified as investments on the Form 5500 and on the schedule of assets (held at end of year).

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The trustee shall pay all expenses incurred in the administration of the Plan from the Plan assets.

**NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by the Plan's trustee, Charles Schwab Trust Company.

**NOTE D – FAIR VALUE MEASUREMENTS**

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 fair value inputs are based on inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted market prices in active markets for similar assets, quoted prices in markets that are not active for identical or similar assets and other market observable inputs such as interest rate, credit spread and foreign currency exchange rates observable in the marketplace or derived from market transactions.

Level 3 fair values are based on at least one significant unobservable input for the asset. Level 3 securities contain unobservable market inputs and as a result considerable judgment may be used in determining the fair values.

**NOTE D – FAIR VALUE MEASUREMENTS (continued)**

Certain investments are measured at fair value using the net asset value (NAV) per share, or its equivalent, as a practical expedient. These investments include commingled funds which may include money market funds, common collective trusts and pooled separate accounts which are typically valued using the NAV provided by the administrator of the fund. The Plan assets include common collective trusts. In accordance with accounting guidance, these investments have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices on the last business day of the Plan year.

*Common collective trust:* Units held in collective investment trusts are valued using the NAV of the fund, as a practical expedient. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective investment fund is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – RISKS AND UNCERTAINTIES**

The Plan provides various investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE F – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

**NOTE G – PARTY-IN-INTEREST**

Certain parties provide services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan allows participants to borrow funds against their account balances. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment and administrative services amounted to \$69,988 and \$87,729 for the years ended December 31, 2024 and 2023, respectively.

**NOTE H – SUBSEQUENT EVENTS**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
