Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Panacea Products Corporation – PPC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [an ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Panacea Products Corporation – PPC 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The PPC 401(k) Plan (Plan) which was established in 1977 is a defined contribution profit sharing plan for the purpose of providing retirement benefits to employees of Panacea Products Corporation. The Plan is funded by employee compensation deferral contributions, employee rollover contributions, plan sponsor matching contributions and plan sponsor discretionary profit-sharing contributions.

All employees who are not members of a collective bargaining unit, are 21 years old and have completed six months of service are eligible to and may participate in the Plan. An employee may begin to participate in the Plan on the first day of the plan year or the first day of the seventh month of the plan year after eligibility requirements have been met.

The Plan Sponsor, Panacea Products Corporation, acquired an existing business in April, 2017. The related employees of the acquired company were permitted to participate in the Plan provided they had already met the eligibility criteria of the Plan. Accordingly, the participants of the Plan increased by approximately 50 employees during the 2017 year. Participants were also permitted to contribute rollover funds to the Plan, which resulted in additional plan assets being received of approximately \$696,700 during the 2017 year.

The Plan is primarily funded by employee contributions based on a percentage (maximum 100%) of each participating employee's compensation. However, total deferrals by an individual participant in any calendar year may not exceed a dollar limit set by law (\$23,000 in 2024 and \$22,500 in 2023). Plan participants who are at least 50 years old by the end of the year may make special "catch-up" contributions. The limit for "catch-up" contributions was \$7,500 in 2024 and \$7,500 in 2023. The limit for both types of contributions may be increased in future years for changes in the cost of living. Participants are also permitted to make rollover contributions to the Plan.

The Plan sponsor makes a matching contribution which cannot exceed 25% of the first 4% of a participant's compensation deferred. In addition, the Plan sponsor may make a discretionary profit-sharing contribution on behalf of all employees who have completed a year of service (1,000 hours) and are actively employed on the last day of the Plan year. Any discretionary contributions are allocated to the eligible employees based on the relationship of an employee's compensation for the year to the total of all eligible compensation paid for the year.

Participants elect to allocate contributions between twenty-six (26) available funds, each fund providing different investment objectives and degrees of risk. In addition, a participant can borrow the lesser of 50% of his account balance or \$50,000 subject to certain conditions. Any amounts borrowed must be repaid within five years unless used to purchase a principal residence. In this case, the repayment period is fifteen years.

Participants are fully vested at all times in their salary deferral contributions and earnings thereon. Participants vest in employee matching and discretionary contributions according to the following schedule:

Forfeitures

Forfeitures, historically, have been used to reduce employer matching contribution. During 2024 and 2023, forfeitures were \$5,099 and \$4,555, respectively. Unallocated forfeited amounts at year end were \$9,849 in 2024 and \$4,750 in 2023.

Withdrawals

Amounts can only be withdrawn from the Plan upon terminating employment, death, disability, attaining normal retirement age (age 59 ½), and hardship withdrawals subject to guidelines prescribed by the Internal Revenue Service.

Participant Accounts

An account is maintained for each participant. The account balances are adjusted:

- For a pro rata share of investment income, expenses, gains and losses based on fund activity and the number of units held in the applicable fund.
- For salary deferral contributions made by the participant.
- For Plan sponsor matching contributions.
- For Plan sponsor discretionary profit-sharing contributions.

NOTE 2 – ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments

Investments are reported at aggregate fair value. Money market mutual funds, mutual funds, corporate bonds and common stocks are valued at the last reported sales price on the last business day of the plan's year. The change between fair value and the cost of investments is reflected in the statements of changes in net assets available for benefits.

Income Recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned on participant loans. Dividends and capital gain income are included in the determination of Unit Value and included with realized and unrealized gains and losses earned on the underlying investments. Accordingly, the investment earnings include all these elements of investment earnings on the underlying assets held by the Plan.

Benefit Payments

Benefits are recorded when paid.

Receivables

Employer matching contributions declared but not funded at year end are reflected as receivables. Employee contributions received but not remitted to the trustee at year end are reflected as receivables. Employer profit sharing contributions declared, but not paid until after year end are reflected as receivables. Historically, all contributions declared or received by the employer have been remitted in a timely fashion in accordance with rules and regulations prescribed by the DOL and IRS. Accordingly, no provision for credit losses is maintained or recorded.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

All information included in the accompanying financial statements related to investments, including yearend fair values, investment earnings (interest, dividends, and net appreciation) have been prepared by or summarized from reports prepared by Ascensus, LLC for 2024 and 2023, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustees that such information was complete and accurate. The trustees maintain separate accounts for each participant. It is the trustee's responsibility to invest a participant's funds as directed by the participant. Participants may change their investment options by contacting the Trustee at any time either online or by a toll-free telephone number.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements authoritative literature established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan qualifies as a tax-exempt plan under the applicable provisions of the Internal Revenue Code. The plan has been amended since receiving the exempt determination, however, the plan administrator believes the plan continues to operate and qualify in accordance with Internal Revenue Code requirements for tax-exempt status.

The Plan does not believe there are currently any tax positions which have a reasonable possibility of change from taxing authorities. Accrued interest and penalties with uncertain tax positions, if any, are recognized as part of administrative expenses. There were no taxes or accrued interest or penalties related to the tax positions of the Plan as of December 31, 2024. The years subject to examination by the authorities are 2024, 2023, and 2022.

NOTE 7 – ALLOCATION NET ASSETS

Net assets available for benefits at December 31, 2024 and 2023, include \$657,154 and \$752,671, respectively, allocated to the accounts of participants who as of or prior to that date had terminated employment with the Plan sponsor and were awaiting distribution of their account balances.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

A majority of the administrative functions are performed by the officers and employees of the Sponsor, who may also be participants in the Plan, at no cost to the Plan.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The audited financial statements and form 5500 are in agreement.

NOTE 10 – AMENDMENTS & SUBSEQUENT EVENTS

Subsequent events were evaluated through September 19, 2025, which is the date the statements were available to be issued.
