### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Shasta Community Health Center 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shasta Community Health Center 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

***General***

The following description of Shasta Community Health Center 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan according to Code Section 403(b) sponsored by Shasta Community Health Center (Health Center) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Health Center. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Empower Trust Company, LLC, serves as plan custodian, Empower Annuity Insurance Company of America holds the Plan's group annuity contract, and Empower Retirement, LLC, serves as recordkeeper.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Health Center make annual contributions of up to the maximum allowed by the Internal Revenue Code. Employee rollover and employee Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The plan document includes an automatic deferral feature for employees whereby a participant is treated as electing to defer 2 % of eligible compensation unless the participant made an affirmative election otherwise.

The Health Center may make discretionary matching contributions on behalf of employees who have attained age 18 and have completed 1,000 hours of service. During the years ended December 31, 2024 and 2023, the Health Center matched 100% of the participant's contributions up to 5% of qualified earnings. Catch-up contributions are excluded from eligibility for employer discretionary match contributions.

Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing contributions into any of the investment account options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Health Center's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Health Center's contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after five years of service. A participant earns a year of service for vesting purposes upon completing 1,000 hours of service during a plan year.

***Payment of Benefits***

If a participant ceases to be an employee of the Health Center and his or her account balance does not exceed \$1,000, the entire vested account balance will be payable to the participant or his or her beneficiaries in a single lump-sum payment. Balances greater than \$1,000 but not exceeding \$7,000 will be rolled over to an individual retirement account as designated by the Plan, absent an election by the participant. Participant balances in excess of \$7,000 can remain in the Plan until such time the participant elects to receive a distribution. A participant may elect to receive a lump-sum amount or installment payments equal to the participant's vested value. Withdrawals other than for termination are permitted under circumstances provided by the Plan. Prior to amendment effective April 1, 2024 balances not exceeding \$5,000 would be rolled over to an individual retirement account as designated by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, the balance in forfeited nonvested and unallocated accounts was \$40,801 and \$63,775, respectively. These accounts will be used to pay plan expenses or to reduce future employer contributions. During 2024 and 2023, employer contributions were reduced by \$54,514 and \$0, respectively, from forfeited nonvested accounts. Administrative expenses of \$0 were paid from forfeited nonvested accounts during 2024 and 2023.

***Participant Loans***

The plan document includes provisions authorizing loans from the Plan to active eligible participants or their beneficiaries. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The maximum number of loans a participant may have outstanding at one time is five. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on the prime rate at the time of the loan plus 1%.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds and money market mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Generally, a default occurs when any scheduled payment is not paid when due. However, there will be a grace period from the due date of the missed payment through the first day of the third month after the end of the quarter in which the required payment was due but not made. If the missed payment is not made during the grace period, then a taxable distribution will be deemed to have occurred.

Participants who leave service prior to the end of the loan term will be required to pay off the loan at termination of employment.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Health Center or the Plan, at the Health Center's discretion.

**Note 3. Certification of Plan Custodians**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$106,052 and \$69,879 of direct administrative fees for recordkeeping and plan consulting services during 2024 and 2023, respectively. In connection with the Plan’s consulting arrangement, the Plan received mutual fund revenue sharing credits of \$53,471 and \$44,333 during 2024 and 2023, respectively.

The Health Center provides certain administrative services at no cost to the Plan.

**Note 5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and a money market mutual fund. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 6. Investment Contracts with Insurance Companies**

In 2022, the Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (“EAIC”, formerly known as Great-West Life & Annuity Insurance Company). EAIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The fixed annuity account is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) employer initiated events (including complete or partial plan termination or merger with another plan, spin-offs, or layoff of at least 20% of the work force in any 12-month period), (2) changes to the Plan’s prohibition on competing investment options unless mutually agreed upon by EAIC and plan sponsor, or (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The fixed annuity account permits the insurance company or the Plan to terminate the agreement with 60 days notice.

Contract value at December 31, 2024 and 2023 was \$807,312 and \$766,312, respectively.

**Note 8. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets. The Plan had reportable delinquent remittances of \$182,196 attributable to the December 31, 2022 plan year. Certain amounts were not fully corrected as of December 31, 2024.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Plan Termination**

Although it has not expressed any intent to do so, the Health Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 11. Tax Status**

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan operates under a volume submitter 403(b) plan document sponsored by Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC). This plan document was pre-approved by the Internal Revenue Service according to an advisory letter dated March 31, 2017. Therefore, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 12. Subsequent Events**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
