Independent Auditor's Report

*Opinion*

We have audited the financial statements of Mercy Housing, Inc. 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

*Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

*Responsibilities of Management for the Financial Statements*

### *Auditor's Responsibilities for the Audit of the Financial Statements*

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. #### **Note 1 - Description of the Plan**

The following description of the Mercy Housing, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan Administrator is Mercy Housing, Inc. through the Audit Committee. The Audit Committee is responsible for the operation and management of the Plan, interpreting the Plan's provisions and recommending any changes to the Plan.

Transamerica Retirement Solutions, the trustee and record keeper, maintains individual participants' accounting records, calculates the allocation of contributions and income to the participants' accounts on a daily basis, and prepares statements, which are sent directly to the participants.

State Street Bank and Trust Company, the asset custodian of the Plan, holds the Plan's investment assets and executes transactions therein.

#### **General**

The Plan is a 403(b) plan covering all employees of Mercy Housing, Inc., Mercy Services Corporation, and Mercy Portfolio Services (the Organization or Employer) who regularly work 20 hours or more a week. Participants can enroll in the Plan on the first day of employment. During 2012, the Plan was amended and is no longer considered a "church plan" as defined in Internal Revenue Code (the "IRC") (Section 414(e)). Effective January 1, 2012, the Plan was amended to change the Employer's type of entity from a Nonelecting church (i.e., a church which has not made an election to be subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") under Code Section 410(d)) to a 501(c)(3) organization and to remove the annualization option for Employer Matching Contributions. As of January 1, 2012, the Plan elected to be subject to ERISA under a Section 404(c) plan. Effective January 1, 2014, the Plan was amended to clarify that 15-year Special 403(b) Catch-Up Contributions are permitted. Participants in the Plan who have completed at least 15 years of Service with a Participating Employer who is a "qualified organization", as defined, may make catch-up contributions to the extent permitted by the IRC.

#### **Contributions**

Each year, participants may contribute up to the maximum annual amount allowed under Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or contribution pension plans and Individual Retirement Accounts. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 24 investment options for participants. Effective April 1, 2020, the Plan was amended to permit Roth elective deferrals and Roth rollover contributions.

After completing one year of employment, the Organization matches, dollar for dollar, an employee's contributions up to 2%. Effective January 1, 2018, the Organization will match, dollar for dollar, an employee's contribution up to 4%. The Organization also makes a contribution to the Plan for eligible employees who have completed three to six years and seven or more years of employment. Employees with at least three but less than seven years' tenure may receive an additional contribution equal to 1% of compensation. Employees with seven or more years' tenure may receive an additional

contribution equal to 1% for a total of an additional 2% of compensation. The employees need not contribute to the Plan in order to receive these contributions. Contributions are subject to certain IRS limitations.

#### **Participant accounts**

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in their contributions, the Employer's contributions, plus the actual earnings thereon.

#### **Payment of benefits**

On termination of service due to death, a single lump-sum cash payment will be made to the participant's designated beneficiary. For participant balances in excess of \$5,000 for termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan has a small sum cashout provision for participant balances of \$5,000 or less that allows (1) involuntary cashout distributions of account balances of terminated vested Participants of \$1,000 or less and (2) automatic rollover provisions of terminated vested Participants with account balances of greater than \$1,000 and less than \$5,000, in which the account balance is automatically rolled over to an Individual Retirement Account unless the participant elects a distribution.

Participants may withdraw all or a portion of their account balance when they reach age 59½.

The Plan is required by law to distribute participant benefits no later than April 1st of the calendar year following the year in which the participant reaches age 70½. However, if the participant is still working for the Employer at the time they reach 70½ and they are not a 5% owner of the Employer, they may delay payment until April 1st of the calendar year following the year of retirement or choose to delay the rest of the benefit payments until April 1st of the calendar year following the year of retirement if benefit payments have already begun.

The Plan allows hardship withdrawals under certain conditions related to medical needs, purchase of a principal residence, post-secondary education, or possible eviction from a principal residence. However, a participant must exhaust the loan provisions discussed below before he or she may apply for a hardship withdrawal.

Participants attain his or her normal retirement date when they reach age 65.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Participants may borrow two loans at a time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate. Principal and interest is paid ratably through payroll deductions and must be repaid within five years unless the loan is used to purchase a principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years. If the loan is used to purchase a principal residence, the repayment period may be set for a loan term that will extend up to 30 years.

#### Note 2 - Summary of accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to the filing deadline of March 17, 2025.

##### **Payment of benefits**

Benefits are recorded when paid.

##### **Other fees**

Investment management fees and fees incurred for plan service charges and loan processing fees are charged directly to the participant's account and are included as expenses in the accompanying statements of changes in net assets available for benefits. Other investment-related expenses are included in net appreciation of fair value of investments.

##### **Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

#### Note 5 - Tax status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71 or the draft Listing of Required Modification issued April 4, 2009. The Plan Administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 7 - Party-in-interest transactions

Fees paid by the Plan to the trustee for administration and record keeping services amounted to \$245,543 and \$222,696, respectively, for the years ended December 31, 2024 and 2023. Fees paid by the Plan to an investment consultant, for investment management services amounted to \$33,645 and \$39,822, respectively, for the years ended December 31, 2024 and 2023. The Plan has a cash

reserve account that is managed by State Street Bank and Trust Company. As of December 31, 2024 and 2023, the balance in the account was \$297 and \$516, respectively.
