## Notes to Financial Statements

### 1. Description of the Plan

The following description of the Brechbuhler Scales, Inc. 401(k) Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement and summary plan description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan that covers all eligible employees of Brechbuhler Scales, Inc. (Plan Sponsor).

The Plan is administered by the Plan Sponsor's 401(k) Committee (Committee), which is a committee selected by the board of directors. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's board of trustees.

#### Contributions

Each year participants may contribute up to 100% of their pre-tax annual compensation, subject to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts Roth elective deferrals. All participants can rollover into the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan also provides for a qualified automatic contribution arrangement (QACA), unless elected otherwise, for eligible employees. In accordance with the QACA provisions, the Plan Sponsor automatically will withhold from new participant's compensation 6% per pay period (referred to as the "automatic deferral percentage"), increasing 1% annually up to 10%. Newly eligible participants can opt out of this automatic enrollment feature.

The Plan Sponsor makes non-elective QACA safe harbor contributions equal to 3% of eligible compensation for persons who were active participants at any time during the Plan year. Contributions are subject to certain IRC limitations. Total safe harbor contributions were \$674,845 for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions including elective deferrals and rollover contributions, allocations of the Plan Sponsor's contributions and Plan earnings, net of expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All investments of the Plan are fully participant directed.

#### Vesting

A participant is fully vested immediately in elective wage deferrals and amounts rolled over from other plans plus actual earnings thereon. Vesting for the non-elective QACA safe harbor contributions are based on years of continuous service. A participant is 100% vested after two years of credited service or upon retirement (age 59 ½), disability, retirement or death while employed.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years, or longer for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Interest rates for participant loans range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

### Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant, or designated beneficiary, may elect to receive the vested balance in the participant's account in the form of a single lump-sum cash payment or a rollover to another retirement plan. In the event that the participant's account balance is less than \$1,000, the plan administrator may make a single payment without the election or request of the participant. If a participant's vested account balance exceeds \$1,000 but does not exceed \$5,000, the plan administrator may make a direct rollover to an individual retirement account, if the participant does not make an election within a designated time period. Non-terminated employees may make withdrawals from their vested account balance within certain defined conditions.

### Forfeitures

The Plan provides that all forfeitures may be used to pay administrative expenses that would otherwise be paid by the employer or to reduce the earliest employer contributions made after forfeitures are determined. During the years ended December 31, 2024 and 2023, \$35,855 and \$27,014, respectively, were transferred into the forfeiture account. During the year ended December 31, 2024 and 2023, no forfeitures were used. There were \$69,648 and \$33,793 of forfeitures available for use as of December 31, 2024 and 2023, respectively.

## **2. Summary of Significant Accounting Policies**

### Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates that affect reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determine the Plan's valuation policies utilizing information provided by the investment advisor, custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on terms of the plan agreement.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain investment management and other fees are paid directly by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

## **3. Information Prepared and Certified by the Custodian and Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income (loss), net appreciation (depreciation) in fair value of investments, interest from participants, interest and dividends, benefit payments, and administrative expenses for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodian and trustee.

## **4. Fair Value Measurements**

The authoritative accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy in accordance with the authoritative accounting guidance are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs include quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**Registered investment companies** - Valued at the closing price reported on the active market on which the individual securities are traded.

**Money market deposit account** - The fair value of money market deposit accounts is estimated to approximate deposit account balances, payable on demand, as no discount for credit quality or liquidity were determined to be applicable.

**Self-directed brokerage accounts** - Assets in these accounts primarily consist of cash, money market funds (valued as noted above), registered investment companies (valued as noted above), exchange traded funds and common stocks that are valued daily on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right in accordance with the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions portion of their accounts.

**6. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Transactions with Parties in Interest**

The Plan's custodian and trustee, Charles Schwab Trust Bank, is a party in interest of the Plan as defined by ERISA Section 3(14) and accordingly, investment transactions in the respective funds are parties in interest transactions. Certain administrative expenses related to the Plan are paid by the Plan Sponsor. Additionally, the Plan pays another provider for investment advisory services which qualify as party in interest transactions. Other than as described above or pursuant to a trust agreement, the Plan has no agreements or transactions with any parties in interest.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
