Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of ITC Defense 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of ITC Defense 401(K) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ITC Defense 401(K) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ITC Defense 401(K) Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of ITC Defense Corp, (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees, age 21 years and older, who have completed at least 3 consecutive months of service except for employees covered by a collective bargaining agreement, non-resident aliens, and Residents of Puerto Rico. Once an employee has met the age and service requirements, they enter the Plan on the first day of the month following eligibility. The Plan was restated under IRS Cycle 3 restatement effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions

Participants may make pre-tax or post-tax contributions of up to 100% of annual compensation but may not exceed the limits set forth by the Internal Revenue Code. The Plan may accept rollover contributions made on behalf of any eligible employee, regardless of whether such employee has met the age and service requirements of the Plan. The Plan Administrator establishes the procedures that regulate the method by which rollovers will be accepted. Participants direct the investment of their contributions into various investments options offered by the Plan.

The employer provides a safe harbor match of 3%, after 3 months of service, regardless of employee contribution. Employees do not need to be employed on the last day of the year to receive the safe harbor match. During 2024 the employer matching contributions were \$336,646.

The Employer may make a discretionary matching contribution for 2024. Participants must be employed on the last day of the year to receive the discretionary matching contributions. Each year, the Employer will determine the amounts for the discretionary matching contribution. During 2024, the company did not make any discretionary matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions and allocations of (a) the employer's matching and discretionary profit-sharing contributions, and (b) Plan earnings or losses, and (c) an allocation of administrative expenses. Allocations are based upon the number of participants in the plan or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% vested in participant contributions, rollover contributions, safe harbor match and prevailing wage contributions. Vesting in the employer's nonelective and discretionary employer matching contribution is based on years of continuous service. A participant is vested based on below years of credited service:

Investments

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. The source of the loaned funds is restricted to the portion of the account balance related to participant vested interest in the plan. Participants are allowed one loan at a time. The loan is secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates as determined appropriate by the plan administrator. Principal and interest are paid ratably through payroll deductions over a period of not more than 5 years, unless a principal residence was purchased, and repayment terms are up to 30 years.

Payment of Benefits

Payment of benefits are allowed due to death, disability, in-service at age 59.5, retirement, or hardships, a participant or designated beneficiary may elect to receive a lump sum payment equal to the balance of the participant's vested account or partial payment. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan Sponsor may elect to distribute funds to terminated participants through the mandatory involuntary cash-out provision for amounts of \$5,000 or less.

Forfeitures

Forfeitures represent the non-vested portion of employer contributions that are forfeited by participants upon termination of employment before becoming fully vested. In accordance with the provisions of the Plan, forfeitures may be used to reduce future employer contributions, pay plan expenses, or be reallocated to participants. During the years ended December 31, 2024 and 2023 respectively, \$102,080 and \$10,209 forfeitures were used to reduce employer contributions. As of December 31, 2024 and 2023 the balance of unallocated forfeitures available for future was \$62,330 and \$101,862.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires that the Plan administrator make estimates and use assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates. The Plan administrator is not aware of any condition or event that is likely to severely affect its estimates in the near-term.

Investment, Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment, Valuation and Income Recognition -continued

Management fees and operating expenses charged to the Plan for investments in money market and mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Plan Sponsor, as provided in the Plan document.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025 the report date of the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED BY AND CERTIFIED BY THE TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Ascensus Trust Company, (“the Trustee”), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

NOTE 4. FAIR VALUE MEASUREMENTS

Generally accepted accounting principles, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1-Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2-Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

NOTE 4. FAIR VALUE MEASUREMENTS – CONTINUED

Inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at the reported amount on deposits held by the Plan at year end.

Shares of registered investment companies (mutual funds): Valued at the net asset value (NAV) of shares held by the Plan at year end. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

These valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting.

NOTE 5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Ascensus Trust Company is the custodian of the Plan's assets. Certain participant investments are in Vanguard investment vehicles, which are held by Ascensus Trust Company and these transactions are considered as party-in-interest transactions. Therefore, investment transactions in Vanguard mutual funds and money market funds qualify as party-in-interest transactions as defined by ERISA. Any transaction involving these investments are on the open market at fair market value as outlined in Note 4. Consequently, such transactions are permitted under the provisions of the Plan and are exempt party-in-interest transactions under ERISA. Fees for recordkeeping of \$1,823 were paid for the plan year ended December 31, 2024.

The Plan contracts with Woodberry Financial Services and Osaic Wealth Inc for financial advisory services and with Retirement Planners and Administrators for third party administrative services. Fees for financial advisory services were \$22,350, and third party administrative fees were \$1,900 for the year ended December 31, 2024.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer nonelective and discretionary contributions.

NOTE 7. TAX STATUS

The Plan has timely adopted a restated, via a non-standardized adoption agreement, pre-approved plan. The pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, whereby the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the pre-approved 's opinion letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. PROHIBITED TRANSACTION

The Plan Sponsor did not remit to the Plan's trust certain employee contributions totaling \$5,011 for the year ended December 31, 2024, within the timeframe prescribed by Department of Labor regulations. Delays in remitting contributions to the trust were due to administrative errors. Plan management has not made the necessary corrections for these late deposits, including calculating and remitting the lost earnings to affected participants accounts in accordance with the U.S. Department of Labor and/or Internal Revenue Service guidelines as of December 31, 2024.

NOTE 9. CONCENTRATIONS OF CREDIT RISK

Substantially all Plan assets are invested with one investment management company. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the investment management company, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
