1. Description of Plan

The following description of Milum Express, LLC 401(k) Plan (the "Plan") provides only general information. Participants may refer to the Plan's documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Milum Express, LLC, (the "Employer"). Union employees, non-resident aliens, leased employees, and interns are excluded from participation in the Plan. To participate in the Plan, employees are required to complete three (3) months of service and attain age 21 by the entry date. Employees may become participants in the Plan immediately following the date on which they meet the Plan's participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective February 1, 2025, the Plan changed third-party administrators and recordkeepers from Human Interest, Inc. to Automatic Data Processing, Inc. In conjunction with this change, the Plan signed a new adoption agreement with no significant changes to Plan provisions.

Contributions

The Plan allows contributions of up to 90% of a participant's pre-tax compensation and Roth contributions of up to 50% of a participant's post-tax compensation, subject to contribution limitations specified by law. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions.

The Employer is required and made minimum safe harbor matching contributions of 3% of eligible compensation for all eligible employees for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's safe harbor matching contributions, allocations of Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct their funds into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in employee and employer safe harbor contributions, plus actual earnings or losses thereon.

Participant Notes Receivable

Participants may borrow from their accounts, subject to certain restrictions. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms may not exceed five years. A participant may have no more than one loan outstanding from the Plan at any time. Notes are collateralized by the balance in the participant's account and bear interest at the prime rate on the day the note was initiated plus 1%. Notes outstanding at December 31, 2024 bear interest at rates ranging from 9.00% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, permanent total disability, death, or termination of employment, participants or their beneficiaries may elect to receive their portion of Plan assets under several payout options specified in the Plan. Participants who have attained fifty-nine and a half years of age are permitted to withdraw all or part of their vested accounts as in-service distributions. Participants automatically begin receiving distributions following the year in which they have attained 73 years of age. If a participant's account balance does not exceed \$1,000 at the time of termination, the Plan automatically distributes the participant's account balance in a lump sum. Subject to certain conditions, a participant may make hardship withdrawals from his or her balance in the Plan while employed.

Administrative Expenses

The Plan incurred fees for custodial, recordkeeping, and other professional or administrative fees of approximately \$6,000 and \$5,000 for the years ended December 31, 2024 and 2023, respectively. Any administrative expenses not paid by the Plan are paid by the Employer.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Plan Amendments

Effective June 21, 2023, the Plan was amended to adjust the service requirement for eligible participants to three (3) months instead of twelve (12). Additionally, the Plan was amended to automatically enroll participants at a deferral rate of 3% upon completing the eligibility requirements. Participants have the ability to opt-out of employee contributions or change the deferral percentage if they choose to do so.

2. Basis of Presentation and Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

Estimates

The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers all short-term, highly-liquid investments with an original maturity date of three months or less to be cash equivalents.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

Concentrations of Credit Risk

The Federal Deposit Insurance Corporation ("FDIC") insures amounts on deposit with the financial institution up to limits as prescribed by law. The Plan may hold funds with a financial institution in excess of the FDIC insured amount; however, the Plan has not experienced any losses in such accounts and management believes it is not exposed to any significant credit risk on the Plan's cash.

Participant Notes Receivable

Participants notes receivable are measured at their unpaid principal balance, plus any accrued, but unpaid interest. If a participant does not make repayments and the Plan administrator considers the participant note receivable to be in default, the note receivable balance will become immediately due and payable, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan documents.

Payment of Benefits

Benefits are recorded when paid.

3. Custodian Certification

Information presented in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, participant notes receivable, net appreciation in fair value of investments, and interest and dividends was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company (the custodian of the Plan).

4. Fair Value Measurements

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan's mutual fund investments were valued using Level 1 inputs, based on quoted market prices. Cash and cash equivalents are stated at cost, which approximates fair value.

The methods used to measure fair value may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Employer Contribution Correction

During 2024 and 2023, operational errors were discovered relating to employer safe harbor contributions that resulted in approximately \$21,000 and \$52,000, respectively, of contributions not being remitted to the Plan on a timely basis. These contributions were included in employer safe harbor contributions receivable in the accompanying 2024 and 2023 statements of net assets available for plan benefits. Management made the necessary corrections in 2025 and 2024.

Management will take the necessary corrective actions to ensure that the errors do not impact the Plan's tax status and to ensure that participants are made whole. This includes any possible corrective filings with the IRS or the Department of Labor.

6. Income Tax Status

The Plan operates under a non-standardized profit sharing plan document that obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

6. Income Tax Status (continued)

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified as of December 31, 2024. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress.
