## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Bourbon Heights, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bourbon Heights, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS**

Note 1. Plan Description

The following description of the Bourbon Heights, Inc. (the Company) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan covering all employees of the Company who satisfy eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to the maximum legal limit, as determined by the Internal Revenue Service (IRS), of pre-tax annual compensation as defined in the Plan. There is no age or service requirement for the participant contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various investments options through Metropolitan Life Insurance Company (MetLife).

Participants age 21 or older become eligible to receive matching contributions from the Company on the first day of the month coinciding with the date the participant has completed 1,000 hours of service in a twelve consecutive month time frame. The Company matches the employees' elective deferrals at a rate of 100% up to a maximum of 3% of compensation.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts were \$9,796 and \$9,307, respectively. These accounts will be used to pay certain plan expenses or to reduce the Company's contribution. During 2024, no accumulated forfeitures were used to pay employer matching contributions or plan expenses.

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Plan Description (Continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and actual earnings thereon is based on years of continuous service (1,000 hours). A participant is 100% vested after four years of credited service as described in the following schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year	25%
2 years	50%
3 years	75%
4 years or more	100%

Upon death, participants will become 100% vested in their accounts.

#### Payment of Benefits

Upon a participants' death, disability, severance of employment, attainment of age 59 ½, or retirement, distributions are permitted. Participant account balances with a vested benefit not exceeding \$5,000 may be distributed without prior consent of the participant. A participant's account is payable by a lump-sum amount if the vested account is \$1,000 or less. If the vested account is greater than \$1,000, but less than \$5,000, and the participant does not provide the Plan with an affirmative distribution election, the distribution must be rolled over to an individual retirement account set up in the name of the participant. If the vested account is greater than \$5,000, benefit payments can be deferred and the vested interest can be received in a lump sum payment, joint and survivor annuity payments, or in periodic monthly, quarterly, or annual installments over a fixed period.

### Note 2. Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

### Note 2. Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment adviser and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold and held during the year.

#### Payment of Benefits

Benefit payments are recorded when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at year-end, if any. There were no unpaid distributions as of December 31, 2024 and 2023.

#### Administrative Costs

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company does not intend to request reimbursement from the Plan for these costs. Fees related to the administration of certain withdrawals and annuity accounts are charged directly to the participant's account and are included in administrative expenses. When applicable, surrender fees are charged directly to a participant's account for early withdrawal from the group annuity contract. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

U.S. GAAP provides a framework for fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The methodology for measuring fair value specifies a three-tier hierarchy of valuation techniques based upon whether the inputs to those valuation techniques are based on quoted prices of identical assets or liabilities (Level 1), significant other observable inputs (Level 2), or significant other unobservable inputs that reflect the Plan's own assumptions of market participant valuation (Level 3).

All financial assets and liabilities as of December 31, 2024 and 2023, except for the fully benefit-responsive investment contract, are measured at fair value on a recurring basis (at least annually) into the most appropriate level within the fair value hierarchy based on the inputs used to determine the fair value at the measurement date. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Investments in publicly traded mutual funds with MetLife are held in separate accounts and are recorded at unit value. Unit value is determined daily using publicly traded net asset value or share prices, adjusted for dividend rates and management fee rates. The management fee rates are considered a Level 2 input; therefore, the Plan has determined that the publicly traded mutual funds held in separate accounts are classified within Level 2 of the fair value hierarchy. There are no significant unfunded commitments or restrictions on redemptions related to these types of investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTES TO FINANCIAL STATEMENTS

### Note 5. Guaranteed Investment Contract

Effective January 1, 1993, the Plan entered into a fully benefit-responsive group annuity contract with MetLife. MetLife maintains the guaranteed investment contract contributions in a general account. The accounts are credited with earnings guaranteed under the contract on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than three percent. Such interest rates are reviewed quarterly for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (3) the failure of the plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The group annuity contract permits the insurance company to terminate the agreement if the Company does not follow the terms of the contract.

### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### Note 7. Tax Status

The Plan is based on a volume submitter plan which has received a favorable advisory letter dated March 31, 2017, from the IRS that the volume submitter plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for a determination letter from the IRS. However, plan management and the plan administrator believe the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## NOTES TO FINANCIAL STATEMENTS

### Note 7. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### Note 8. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held in the guaranteed investment contract and separate accounts managed by MetLife. MetLife is the custodian and third-party administrator as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by participants to MetLife for participation in the guaranteed investment contract and the servicing of benefit payments and distributions were \$540 for the year ended December 31, 2024.

Jones, Nale & Mattingly PLC is the independent auditor of the Plan. Audit fees, recordkeeping and administrative fees paid to MetLife are paid by the Company and are excluded from these financial statements.

### Note 9. Loans to Participants

Participants may request a loan based on the vested value of their individual accounts. These loans are issued directly by MetLife to the participant. The loans are secured by the balance in the participant's guaranteed investment contract. No funds are withdrawn from the participant's account unless the participant defaults on the loan and incurs a distributable event.

Loans may range from a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1-5 years but may be longer if the loan is made for the purchase of the participant's primary residence. The loans bear interest as determined by MetLife and are repaid by coupon payment directly to MetLife.

As of December 31, 2024 and 2023, \$2,522 and \$1,146 of participants' balances served as security for the outstanding loans, respectively.

MetLife considers a loan to be in default if it is not paid within the 45th day after it is due at which point it would be treated as a taxable distribution to the participant. As of December 31, 2024 and 2023, \$2,522 and \$1,146, respectively, of the loans, inclusive of interest, were in default.

## NOTES TO FINANCIAL STATEMENTS

### Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 11. Prohibited Transactions

During the year ended December 31, 2023, the Company failed to remit certain employee contributions totaling \$1,988 to the Plan within the period described by the Department of Labor (DOL). During 2024, the Company remitted lost earnings on those contributions to compensate affected participants.

During the year ended December 31, 2022, the Company failed to remit certain employee contributions totaling \$5,418 to the Plan within the period described by the Department of Labor (DOL). During 2024, the Company remitted lost earnings on those contributions to compensate affected participants.

### Note 12. Plan Amendment

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which are laws that require the Plan to, among other things, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The Plan will be formally amended to reflect these provisions prior to the deadline of December 31, 2025.
