Opinion

We have audited the financial statements of The Ohio Valley Flooring Group Medical Benefit Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, the statements of benefit obligations and changes in benefit obligations as of and for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of The Ohio Valley Flooring Group Medical Benefit Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Opinion

1. DESCRIPTION OF PLAN:

The following description of The Ohio Valley Flooring Group Medical Benefit Trust (the "Trust") provides general information about the Plan. Participants should refer to the Plan agreement for a more complete description of Plan provisions.

General

The Ohio Valley Flooring Group Medical Benefit Trust was established as of January 1, 1985 as a self-insured health and welfare plan covering eligible employees of Ohio Valley Flooring, Anchor Flange, BLC Development (inactive), and Onesta (collectively the "Company", "Employer" or "Sponsor"). The Plan was revised in June 1991, June 1995, and July 1998 to further define Plan provisions. Claims are processed through United Healthcare, a claims administrator who receives a fee for these services. The claims administrator is periodically reimbursed by the Plan for the cost of the services provided. The Plan recognizes insurance reimbursements as they are received.

The Plan Administrator is responsible for the Plan's operation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees contribute to the Plan based upon the level of coverage elected. Contributions are made by the Company on a "pay as you go" basis. In addition, the Sponsor has purchased insurance to insure against losses over a stipulated annual amount. This annual amount was \$100,000 per covered participant at December 31, 2024 and 2023.

Benefits

The Plan provides for hospitalization, surgical, medical, and loss of time benefits for covered participants as specified in the Plan.

Participation

All full-time employees of Ohio Valley Flooring, Anchor Flange, and Onesta are covered on the date immediately following a 30-day period of continuous active employment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Changes in circumstances could cause actual results to differ materially from those estimates.

Plan benefits

All medical claims of participants and their dependents are processed by United Healthcare, but the responsibility for funding the payments is retained by the Plan. The liability for health claims incurred but not reported is estimated based on claim lag reports and actual claims experience during the year and subsequent to year end.

The liability for benefit obligations is particularly sensitive to recent claims frequency, claims severity, and reinsurance coverage. The Trustees believe that the liability for benefits is adequate to cover the benefits to date, but the liability is based on estimates and the amount ultimately paid may be more or less than such estimates. The estimates are continually reviewed and adjusted as necessary as experience develops or new information becomes known. Such adjustments are included in current operations, as known.

Premiums and administrative expenses

Participant enrollment, claim processing fees, and stop-loss insurance premiums totaling \$696,167 and \$677,549 were paid by the Company on behalf of the Plan for the years ended December 31, 2024 and 2023, respectively. These fees have been recorded as Company contributions and insurance premiums and administrative expenses on the accompanying financial statements. Certain other administrative expenses are paid directly by the Company on behalf of the Plan and are excluded from these financial statements. Stop loss proceeds that were netted with benefit payments totaled \$287,534 and \$903,736 for the years ended December 31, 2024 and 2023, respectively.

Reclassification

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

Subsequent events

The Company evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Interest-bearing cash: The carrying value approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

5. TAX STATUS:

The Internal Revenue Service (“IRS”) has informed the Trust by an exemption letter dated March 18, 1981, that the Trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal revenue Code (“IRC”). Although the Plan has been amended since receiving the exemption letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with IRC 501(c)(9) and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

6. CONCENTRATION OF CREDIT RISK:

Substantially all of the Plan's cash is maintained in bank deposit accounts, which may, at times, exceed federally insured limits. Accounts at the institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. Plan management believes it is not exposed to any significant credit risk of loss in cash.

7. SIGNIFICANT ESTIMATE - PLAN BENEFIT OBLIGATIONS:

The benefit obligation recognized includes claims incurred (reported and unreported) and the estimated costs of ongoing health care costs expected to be incurred in future periods. The Plan’s estimated benefit obligation at December 31, 2024 and 2023 is \$119,720 and \$226,778, respectively. As permitted by professional standards, these amounts are based on estimates developed by the Sponsor of the Plan. The amount of the liability could change if claims levels, stop loss insurance reimbursements and other factors used to calculate the liability differ from actual events.

These estimates are based on the nature of claims incurred during 2024 and 2023, as well as the Plan's insurance coverage, which limits losses exceeding a certain amount (Note 1). It is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan assets are held in non-interest-bearing and interest bearing accounts managed by PNC Bank, N.A., the custodian of the Plan. As described in Note 1, the Plan also has arrangements with certain service providers. These transactions qualify as party-in-interest transactions under ERISA.

9. NONEXEMPT PROHIBITED TRANSACTIONS:

During 2024 and 2023, certain participant elective deferral contributions totaling \$319,197 and \$269,229 were not remitted to the Plan on a timely basis within the Department of Labor guidelines. These late remittances, constituted nonexempt prohibited transactions. The Employer calculated lost earnings on these late contributions and made a corrective contribution on July 3, 2025.
