**INDEPENDENT AUDITOR'S REPORT**

To the 401(k) Committee/Plan Administrator and Those Charged with Governance  
*Berendsen, Inc. Retirement Savings Plan*

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the *Berendsen, Inc. Retirement Savings Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the *Berendsen, Inc. Retirement Savings Plan's* financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## **NOTE 1 - DESCRIPTION OF THE PLAN**

Berendsen, Inc. (the Company or Employer) sponsors the *Berendsen, Inc. Retirement Savings Plan* (the “*Plan*”). The following description provides only general information. Participants should refer to the *Plan* document for a more complete description of the *Plan*’s provisions.

### *General:*

The *Plan* is a defined contribution plan covering substantially all employees of the Company. Collectively bargained employees, leased employees and nonresident aliens are excluded by the *Plan*. The *Plan* is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The *Plan* is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

The *Plan* is administered by the Company. Fidelity Management Trust Company (the “Trustee”) serves as trustee of the *Plan*, processes and maintains the records of the participant data and holds the *Plan* assets.

### *Eligibility:*

Non-excluded employees are eligible to participate in the *Plan* immediately upon their hire date.

### *Employee Contributions:*

Participants may contribute up to 90% of their compensation, as defined in the *Plan* document, as either pretax or Roth deferrals. Participants who have attained age 50 before the end of the *Plan* year are eligible to make catch-up contributions. Participants may also roll over amounts from other qualified plans.

Participants direct the investment of their contributions into various investment options offered by the *Plan*. Contributions are subject to certain limitations of the Internal Revenue Code (the “Code”).

### *Employer Contributions:*

The Company matches participant contributions equal to 50% of the first 8% of base compensation that a participant contributes to the *Plan*. At the end of the *Plan* year, the Employer may elect to make an additional matching Employer contribution equal to a percentage (as declared by the Employer) of the deferral contributions made by the participant during the *Plan* year.

## **NOTE 1 - DESCRIPTION OF THE PLAN** (continued)

### *Participant Accounts:*

Each participant's account is credited with participant contributions, Employer matching contributions and *Plan* earnings, which are allocated proportionately among all participants based upon their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting:*

Participants are immediately vested in their own contributions, plus actual earnings thereon. Vesting in the Employer contributions and related earnings thereon is based on years of continued service and is determined as follows:

Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6	100%

### *Payment of Benefits:*

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of a death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72. Distributions from rollover accounts may be made at any time. The *Plan* allows hardship withdrawals, subject to account balance limits and applicable laws.

### *Administrative Expenses:*

The *Plan* allows certain administrative expenses to be paid from *Plan* assets. Investment expenses netted against investment income represent amounts associated with net expense ratios of the investments in the *Plan's* fund lineup.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### *Basis of Accounting:*

The financial statements of the *Plan* have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### *Use of Estimates:*

The preparation of financial statements in conformity with U.S. GAAP requires *Plan* management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition:*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the valuation policies utilizing information provided by the Trustee. See note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the *Plan's* gains and losses on investments bought and sold, as well as held during the year.

### *Payment of Benefits:*

Benefits are recorded when paid. There were no benefits requested before year end that were not paid.

### *Forfeited Accounts:*

Non-vested Employer contributions forfeited because of termination of employment are used either to reduce administrative expenses or reduce employer contributions. In 2024, Employer contributions were reduced by \$80,076 and administrative expenses were reduced by \$0 from forfeited non-vested accounts. In 2023, Employer contributions were reduced by \$22,342 and administrative expenses were reduced by \$0 from forfeited non-vested accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$37,451 and \$42,768, respectively.

### *Subsequent Events:*

The Plan Administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

## **NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). These three levels of the fair value hierarchy are described as follows:

---

**Level 1** - Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.

**Level 2** - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies* – Value is based upon quoted market price available in an active market.

*Common/collective trust* - The T. Rowe Price Stable Value Fund (the "Fund"), held in a common collective trust fund, invests in conventional and synthetic guaranteed interest contracts ("GICs") issued by life insurance companies, banks, and other financial institutions with excess cash invested in cash equivalents. The Fund allows for earnings stability regardless of the volatility of the financial markets and is recorded in the accompanying financial statements at fair value. Fair value represents quoted market prices for synthetic GICs, while the fair value of conventional GICs is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve as of December 31, 2024 and 2023. The average yield earned by the *Plan* and credited to participants for the Fund for the years ended December 31, 2024 and 2023 was 2.68% and 2.28%, respectively.

Certain events limit the ability of the *Plan* to transact at contract value with the issuer. Such events include termination of the contract, spinoffs, divestures, corporate relocation, partial or total *Plan* termination, retirement incentive programs, and the liberalization of *Plan* withdrawal or transfer rules. Upon recurrence of any of these events, a market value adjustment may apply. The Plan Administrator does not believe that the occurrence of any such event, which would limit the *Plan's* ability to transact at contract value with participants, is probable. The Fund may terminate the investment contract with the *Plan* by providing twelve months advance written notice to the contract holder for reasonable cause,

which includes the contract owner's failure to abide by federal law, failure to render performance necessary to comply with the terms of the contract, *Plan* disqualification, and failure to adopt the *Plan* in a reasonable period of time. Upon termination by the Fund, a market value adjustment may apply.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the *Plan* believes its valuation methods are appropriate and consistent with other market participants, the use of a different methodology or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The *Plan's* independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the *Plan* for these services. Certain administrative expenses, totaling approximately \$11,000, were paid by the Company on behalf of the *Plan* for the year ended December 31, 2024. The Company does not expect reimbursement from the *Plan* for these expenses.

Certain mutual funds are issued by the Trustee. These transactions qualify as party-in-interest transactions. Certain fees incurred by the *Plan* are included in net appreciation (depreciation) in fair value of investments.

## **NOTE 6 - TAX STATUS**

The Company adopted a Preapproved Plan sponsored by Fidelity Management and Research Company. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the *Plan*. *Plan* management believes the *Plan* is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the *Plan* is qualified and the related trust is tax-exempt.

## **NOTE 7 - RISKS AND UNCERTAINTIES**

The *Plan* invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

## **NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the *Plan* to discontinue its contributions at any time and to terminate the *Plan* subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the *Plan* of any vested right.
