### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of EANJ 401(k) Retirement Advantage Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

**NOTE 1 PLAN DESCRIPTION**

The EANJ 401(k) Retirement Advantage Plan (Plan) is administered by the Employer Association of New Jersey (Company or Plan Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Descriptions and Plan Documents.

**General**

The Plan is a multiple employer defined contribution plan that became effective January 1, 1993, covering all employees who have reached the minimum age and service requirements, which varies by each participating employer. With the consent of Employer Association of New Jersey, Plan Sponsor, an employer may adopt the Plan and become a party to the Trust by executing a Multiple Employer Participation Agreement, which becomes part of the Plan Agreement. The participating employers can make selections in the Multiple Employer Participation Agreement that provides different policies and parameters regarding various aspects of the Plan, such as eligible employees, conditions of eligibility, 401(k) safe harbor contributions, discretionary employer-matching contributions, discretionary profit-sharing contributions, and automatic deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration**

The Company is the Plan Sponsor and Plan Administrator. The Plan Administrator is responsible for carrying out the duties imposed under ERISA, including oversight of the Plan, appropriateness of investment offerings, and monitoring of investment performance.

**Contributions**

Participants can make voluntary pretax contributions and Roth 401(k) contributions to the Plan up to 100% of eligible compensation, as defined by the Plan. The Plan accepts rollover contributions from other qualified retirement plans in accordance with ERISA. Contributions are subject to certain limitations as stipulated by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions in accordance with, and subject to, IRC statutory limits.

Participating employers have elected to make either a safe harbor contribution to the Plan, a discretionary matching contribution, or a discretionary profit-sharing contribution. If the participating employer elects to satisfy safe harbor rules, participants will receive a notice that indicates which one of the safe harbor contributions will be made for the year. For the years ended December 31, 2024 and 2023, participating employers made discretionary matching contributions of \$1,159,821 and \$1,849,214, respectively. For the years ended December 31, 2024 and 2023, participating employers made safe harbor contributions of \$209,818 and \$192,691, respectively. For the years ended December 31, 2024 and 2023, participating employers made discretionary profit-sharing contributions of \$94,742 and \$16,672, respectively. For the year ended December 31, 2024 participating employers made qualified nonelective contributions of \$289,015.

**NOTE 1 PLAN DESCRIPTION (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the participating employer's discretionary matching contributions, the participating employer's safe harbor contributions, as well as allocations of the participating employer's discretionary profit-sharing contributions, and an allocation of the Plan's earnings, gains, or losses in accordance with the provisions of the Plan. Investment fees normally charged by the investment funds are applied against the participants' accounts and reported as a reduction of fund earnings. Allocations are based on a participant's compensation or account balances, as defined in the Plan Documents.

**Vesting**

Participants are immediately vested in their salary deferrals, rollover contributions, and safe harbor contributions, plus earnings thereon. Vesting in the employer's discretionary matching contributions and discretionary profit-sharing contributions is based on years of service. A participant is 0% vested until they complete three years of service. A participant is 100% vested in the employer's discretionary matching contributions and discretionary profit-sharing contributions after three years of service.

**Investment Options**

Upon enrollment in the Plan, participants may direct their employee and employer contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options at any time.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months). Participants may have one loan outstanding at any given time. Loans bear a rate of interest of prime plus 1%. The interest rate will remain fixed throughout the duration of the loan. Terms depend on the type of note; a general note must be repaid within five years unless the loan is used to acquire a principal residence. Loans will be secured by one-half of the participant's vested balance. Notes must be repaid through payroll deductions or check. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is considered to be a deemed distribution to the participant.

**Payment of Benefits**

On termination of service, a participant may elect to receive either: a cash, lump-sum amount equal to the value of their vested account or receive a rollover directly to the participant's account of choice. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1 following the calendar year of attaining the age of 72 or age at retirement. If participants are still employed by the age of 72, the mandatory distribution date generally is April 1 following the termination date of employment. If a participant's vested balance is greater than \$5,000, receipt of distribution can be postponed until the time it is required by law to receive minimum required distributions. If a participant's vested account balance is less than \$5,000 the participant will automatically receive a distribution in the amount of their vested balance.

Hardship withdrawals are subject to approval by the Plan Administrator and also subject to income tax withholding and penalties.

**In-Service Withdrawals**

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Transfers To and Out of the Plan**

When participating employers join the Plan, their respective participant accounts are reported as transfers to the Plan on the statements of changes in net assets available for benefits. During the years ended December 31, 2024 and 2023, there were \$205,259 and \$18,124,529 of transfers to the plan from six and three qualified plans, respectively. There were \$745,299 and \$285,597 of transfers out of the plan during the year ended December 31, 2024 and 2023. In 2024, \$644,634 of the transfer out was payable to Van Hydraulics, Inc. 401(k) Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with the accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by Mid Atlantic Trust Company, the Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses and Participant Transaction Fees**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Forfeitures**

On or before each anniversary date, any forfeitures may be made available to reinstate previously forfeited account balances of participants, if any, and any remaining forfeitures may be used to pay administrative expenses. The remaining forfeitures, if any, will be used to offset respective employer contributions. The balance in the forfeiture account at December 31, 2024 and 2023, was \$118,044 and \$81,705, respectively. The Plan utilized \$11,003 of forfeitures for the year ended December 31, 2024. The Plan did not use any forfeitures for the year ended December 31, 2023.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants in 2024.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Employer Contributions Receivable**

Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions are due from employers as specified in the participation agreement. The estimate for expected credit losses considers historical loss experience, current economic conditions, and forward-looking information, including factors such as payment history, employer financial condition, and labor trends. As of December 31, 2024 and 2023, the allowance for credit losses was insignificant.

**Subsequent Events**

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024 through October 10, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Company elected to merge into the EANJ Retirement Advantage PEP (Pooled Employer Plan).

**NOTE 3 INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements and certain ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Mid Atlantic Trust Company, the Custodian of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held by the Custodian, Mid Atlantic Trust Company. Any transactions involving Mid Atlantic Trust Company, the Plan Sponsor, participating employers, or the third-party administrator (BCG Securities) are considered party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 TAX STATUS**

The IRS has determined, and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions, however, there are no audits for any periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events that could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
