## Independent Auditors' Report

### The Plan Administrator and Participants Elevate ENT Partners, LLC 401(k) Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Elevate ENT Partners, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **1. Description of the Plan**

The following description of the Elevate ENT Partners, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution plan administered by ENT MSO, LLC (d/b/a) Elevate ENT Partners, LLC (the “Plan Administrator”). The Plan covers all employees of Elevate ENT Partners, LLC, Florida ENT Associates, Inc (“FENTA”), ENT of Louisiana MSO, LLC, Southern E.N.T. Associates (“SENTA”), which during 2024 changed its name to Louisiana Ear Nose & Throat Specialists, Inc. (“LENT Specialists”), Texas Ear, Nose & Throat Specialists, PLLC, and Louisiana Ear, Nose, Throat, and Sinus (“LENT Sinus”), (collectively, the “Participating Employers”), who have attained 21 years of age and have completed two months of service, except for leased and temporary employees, (“Participants”). Texas Ear, Nose & Throat Specialists, PLLC is an unrelated employer and LENT Sinus was an unrelated employer until February 2024, at which time it became part of LENT Specialists.

Fidelity Management Trust Company (“FMTC” or the “Custodian”) provides asset Custodian Services. Fidelity Workplace Services, LLC (“FWS” or the “Recordkeeper”), an affiliate of FMTC, provides recordkeeping services and executes investment transactions. Fidelity Investments, an affiliate of FMTC, manages the investments in the Plan.

The Plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2530.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”). Accordingly, the Custodian has certified certain data in the accompanying financial statements (See Note 3). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant-directed.

#### ***Plan Mergers and Acquisitions***

During 2024, due to an acquisition, Southern E.N.T. Associates, Inc (“SENTA”) became a participating employer in the Plan. The Plan Administrator approved an amendment to merge Southern E.N.T. Associates, Inc. Profit Sharing Plan into the Plan effective June 15, 2024. For the plan year ended December 31, 2024, \$4,858,402 of assets were transferred into the Plan from SENTA.

Due to an acquisition, employees of North Florida Center for Otolaryngology that became employees of a Participating Employer are eligible to participate in the Plan once the eligibility requirements have been met. An aggregate of \$2,538,490, including \$52,625 of notes receivable from participants, were rolled into the Plan during the year ended December 31, 2024, and is included in rollover contributions on the statement of changes in net assets available for benefits.

### **1. Description of the Plan (continued)**

#### ***Plan Mergers and Acquisitions (continued)***

Due to an acquisition, employees of Coastal Ear Nose and Throat PA that became employees of a Participating Employer are eligible to participate in the Plan once the eligibility requirements have been met. An aggregate of \$799,118 was rolled into the Plan during the year ended December 31, 2024, and is included in rollover contributions on the statement of changes in net assets available for benefits.

#### ***Plan Administration***

The Plan Administrator has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged directly for administrative expenses, if not paid by the Employer. Individual participant accounts are charged directly for loan recordkeeping, if applicable.

#### ***Subsequent Events***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is October 8, 2025.

#### ***Participant Deferral Contributions***

Each year Participants may defer up to 100% of their eligible compensation, as defined by the Plan, on a pre-tax or roth basis not to exceed a dollar limitation established under the Internal Revenue Code (the "IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, Participants may also contribute amounts representing distributions from other qualified plans.

Employees, upon eligibility to participate in the Plan, will be automatically enrolled to defer 3% of their eligible compensation, as defined. A Participant may choose not to defer or may choose a different percentage once enrolled. Automatic enrollment deferrals are invested in the Fidelity Freedom Target Retirement Date funds based upon the Participant's expected retirement date. Participants who are automatically enrolled will be subject to automatic escalation of 1% on the first day of each plan year until the Participant's rate of deferral reaches 10% or until the Participant elects to change the amount they are contributing or ceases contributing.

#### ***Employer Contributions***

The Participating Employers, at their discretion, may elect to make matching contributions as determined by their Board of Directors. To be eligible, Participants must be making deferral contributions to the Plan. For the year ended December 31, 2024, the Participating Employers elected not to make a matching contribution.

### **1. Description of the Plan (continued)**

#### ***Employer Contributions (continued)***

Each year, the Participating Employers will contribute an amount equal to 3% of a Participant's eligible compensation, as defined. Participants are eligible for the employer safe harbor non-elective contribution, regardless of a Participant's elective deferral contributions. For the year ended December 31, 2024, the Employer made safe harbor non-elective contributions of \$2,099,153, net of forfeitures of \$3,502.

The Participating Employers, at their discretion, may make non-elective contributions to the Plan, as determined by the Plan's Board of Directors. All Participants are eligible for the employer non-elective contribution. Employer non-elective contributions are allocated at the Participating Employers' discretion based on groups. Each eligible Participant is considered their own allocation group. The amount allocated to each group is based on eligible compensation. For the year ended December 31, 2024, the Participating Employers made a non-elective employer contribution of \$6,923,724, net of forfeitures of \$205,191.

#### ***Participant Accounts***

Each Participant's account is credited with the Participant's contributions, the respective Participating Employer contributions and an allocation of Plan investment earnings and losses, and charged with an allocation of administrative expenses, as applicable. Allocations are based on Participant compensation, group, or account balance, as defined. The benefit to which a Participant is entitled is the benefit which can be provided from the Participant's vested account.

#### ***Vesting***

Participants are immediately vested in their participant contributions, rollover contributions, and employer safe harbor non-elective contributions, plus allocated earnings thereon. Participants begin vesting in Employer non-elective contributions and the discretionary Employer matching contribution, if any, plus earnings thereon, in 33% increments after one year of service and are 100% vested after three years of service, unless termination due to death, disability, or attainment of retirement age, at which time a Participant is 100% vested.

#### ***Forfeitures***

A Participant who leaves the employment of the Participating Employers forfeits any non-vested balance. Forfeited balances of terminated Participants' accounts are used to first pay administrative expenses and then to reduce all Employer contributions in the year of forfeiture. During 2024, \$208,693 of forfeitures were used to fund employer contributions and \$279 of forfeitures were used to offset administrative fees. At December 31, 2024 and 2023, there are unallocated forfeiture amounts of \$67 and \$65,019, respectively.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, termination, or retirement, a Participant or beneficiary may elect a lump-sum distribution in an amount equal to the value of the Participant's vested interest in his or her account. The payment can either be a cash distribution to the Participant or a tax free rollover to an individual retirement account or another qualified plan. If a Participant's vested account is more than \$1,000 but less than \$5,000, the plan administrator, after notification, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the plan administrator, after notification, may distribute the account balance to the Participant.

In-service withdrawals from a Participant's account are permitted only due to financial hardship or upon reaching age 59½. In-service withdrawals upon reaching age 59 ½ are allowed from all Participant's vested accounts. Hardship withdrawals are permitted to a minimum of \$500 and may be taken from the Participant's elective deferral account.

#### ***Notes Receivable from Participants***

Subject to approval by the plan administrator, Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only borrow from their pre-tax deferral or Roth 401(k) deferral accounts. A Participant may only have one loan outstanding at a time. Loan terms range up to five years (or longer for the purchase of a primary residence). The loan is secured by the vested balance in the Participant's account and bears interest at the Wall Street Journal prime rate plus 1% at the time the loan is made. Principal and interest are paid ratably through payroll deductions. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is recorded as soon as a distributable event occurs. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Interest rates for outstanding loans range from 4.25% to 9.50% at December 31, 2024 and 2023 and mature at various dates through January 2032.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified as Level 1 investments.

*Common collective trust funds:* Valued at the NAV of units in the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants’ accounts are charged or credited with the number of units properly attributable to each Participant. The collective investment fund has no unfunded commitments at December 31, 2024 and 2023.

*Self-directed brokerage account:* Consists of interest-bearing cash, mutual funds, and corporate stocks which are valued at the closing price reported on the active market on which the individual securities are traded and are classified as Level 1 investments.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred.

#### ***Benefits Paid***

Benefit payments are recorded in the period in which the Participants are paid.

### **3. Information Certified (Unaudited)**

Certain information related to investments, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i, Schedule of Assets (Held at End of Year) including investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian, a qualified institution.

### **4. Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **5. Party-In-Interest Transactions**

Plan investments include funds that are managed by an affiliate of FMTC. Therefore, transactions with affiliates qualify as exempt party-in-interest transactions. Administrative fees of \$234,969 were paid to FMTC during 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

### **7. Tax Status**

The underlying volume submitter profit sharing plan has received its latest opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the IRC, is exempt from federal income taxes under Section 501(a) of the IRC and that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan’s policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Prohibited Transactions**

During 2024 and 2023, certain Participant contributions and loan repayments were not remitted to the Plan by the Plan Administrator on a timely basis as required under DOL 2510.3-102. Under ERISA, such delinquent contributions are considered prohibited transactions and are reported on Schedule H, Part IV, Line 4(a) of Form 5500. During 2024 and subsequent to year end, the Plan Administrator funded the lost earnings on the delinquent contributions to the effected Participants’ accounts.
