The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Employees' Savings Plan of FN America, LLC (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, adopted by FN America, LLC (the "Company"), which covers all of the eligible employees of the Company. Employees are eligible upon reaching 18 years of age and completing 90 days of eligible service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute up to 100% of their annual pre-tax and after-tax compensation, as defined in the Plan, limited to the amounts set forth in the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan has a 3% automatic elective deferral contribution, which is set to increase by 1% each January 1 up to 12% unless the participant elects no deferral or changes the deferral percentage. The Company provides a matching contribution on employee pre-tax salary deferrals equal to 100% of such contributions for the first 6% contributed and a discretionary contribution to eligible employees according to their allocation group. Contributions are subject to certain limitations and eligibility requirements. There were no discretionary contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings and charged with withdrawals, as applicable, and an allocation of Plan losses and certain Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Matching contributions, including discretionary contributions, are qualified matching contributions that are immediately 100% vested. In the event of death while employed or while performing qualified military service, permanent disability, early retirement or normal retirement, participants or their designated beneficiaries are fully vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of whichever is less:

- (a) \$50,000 (reduced by any outstanding loan balance) or
- (b) the greater of 50% of their vested account balance or \$10,000 (reduced by any outstanding loan balance).

Employees are limited to three loans outstanding and no more than two loans granted within any 12-month period. The loans are secured by the balance in the participant's account and bear interest between 4.25% - 9.5% as of December 31, 2024 and 2023. The interest rate applied to participant loans is based on rates

available for similar loans from commercial lending institutions. Once a loan is granted, the interest rate will not change. Principal and interest are paid ratably through payroll deductions. Loans outstanding as of December 31, 2024 are set to mature on various dates between 2025 and 2029.

Forfeitures

Forfeitures of terminated participants' nonvested accounts are used first to pay administrative expenses and then to reduce Company contributions to the Plan. Forfeitures that have not been used to pay administrative expenses or used to reduce Company contributions shall be allocated to participant accounts as of the last day of the Plan year. Forfeitures used to reduce Company contributions totaled \$87,267 for the year ended December 31, 2024. Forfeitures used to pay administrative expenses totaled \$638 for the year ended December 31, 2024. Forfeiture amounts available as of December 31, 2024 and 2023 were \$3,525 and \$27, respectively.

Payment of Benefits

Upon death, retirement, disability or termination of employment, a participant or his or her beneficiary may elect to receive a lump-sum payment equal to the value of his or her account or may elect to rollover the account balance directly into an IRA or another qualified plan. In the event a participant terminates employment with the Company and the participant's vested account balance is less than \$5,000, the participant will automatically receive a lump-sum payment. A participant may request a withdrawal from his or her account balance based upon financial hardship as defined by IRC regulations. In the event such a withdrawal is made, the distribution is subject to a 10% penalty if the participant has not attained age 59½. Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

Plan Termination

The Company has the right to discontinue its contributions and terminate the Plan at any time. In the event of termination of the Plan, all participants' accounts would become fully vested and all assets remaining in the trust fund shall be distributed to the participants. The Company presently has no intention to terminate the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent asset and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as reported by Principal Trust Company ("Trustee"). Principal Life Insurance Company ("PLIC") determines the net asset value ("NAV") of investments in pooled separate accounts based upon quoted market prices of the underlying investments. Individual participants are able to make changes to investments daily with no restrictions.

The Plan invests in mutual funds valued at the NAV of shares held by the Plan at year end based upon the trading price on a national security exchange.

The Plan invests in the Putnam Stable Value Fund ("SVF"), which invests in investment contracts through a collective trust fund. The contract value of the SVF represents contributions made under the contracts, plus earnings, less withdrawals and administrative expenses. The fair values of participation units held in the SVF are based on NAV to reflect all fund investments at fair value.

The Plan also includes a self-directed brokerage option which allows participants to establish a personal brokerage account within the Plan. There are more investment options in brokerage windows than in the plan menu. This gives participants access to a broader array of stocks, bonds, mutual funds, and exchange-traded funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

The majority of Plan administrative expenses are paid from the net assets of the Plan. The Company may elect to pay certain administrative expenses on behalf of the Plan. Administrative expenses are expensed when incurred. Investment related expenses are included in net appreciation in fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and in the statement of changes in net assets available for benefits.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 FR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Valued at the NAV of shares held by the Plan at year end, as traded on a national securities exchange.

Self-Directed Brokerage Account

Consists of publicly traded common stock and mutual funds valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trust

In accordance with U.S. GAAP, the Plan's investment in collective trust fund is measured at NAV per share (or its equivalent) as a practical expedient, and is excluded from the fair value hierarchy. The fair value of the Plan's interest in the collective trust fund is based on the NAV reported by the fund manager as of the financial statement date. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts

Valued at the NAV daily based on the market value of the underlying net assets in each separate account as a practical expedient. The majority of the underlying net assets have observable Level 1 and/or Level 2 quoted pricing inputs which are used to determine the unit value of the pooled separate accounts ("PSA") which are not publicly quoted. The redemption frequency of each of these PSAs is daily and there are no redemption restrictions. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. In addition, there are no unfunded commitments.

NOTE 5 - TAX STATUS

The Plan received its most recent determination letter from the Internal Revenue Service ("IRS") dated June 1, 2017, which covered the Plan document and amendments executed through December 14, 2015. In this determination letter, the IRS indicated that the Plan, as designed, was in compliance with applicable regulations under Section 401(a) of the IRC and, thus, was exempt from income taxes. The Plan has been subsequently amended, but management believes the Plan remains in compliance with the applicable regulations and, thus, remains exempt from income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by PLIC, an affiliate of the Trustee. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA. In addition, notes receivable from participants are also party-in-interest transactions.
