Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



**1. Description of Plan**

The Contractors Retirement Plan (“the Plan”) is a defined contribution profit sharing plan providing benefits to eligible employees of Florence Crittenton Services of Orange County, Inc. The Plan became effective on January 1, 2024. Participation is open to all eligible employees effective upon their date of hire, except as specifically excluded under the Plan. Contributions include employer profit sharing, prevailing wage contributions, and permitted employee rollover contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a non-contributory defined contribution retirement plan. It is subject to the provisions of the ERISA.

**Contributions**

Employer contributions consist of profit sharing and, as applicable, prevailing wage contributions for eligible employees. Employees may elect to roll over distributions from other qualified retirement plans or certain IRAs. There are no employee salary deferrals in this Plan. There are annual limits on contributions as defined by IRS regulations.

**Participant Accounts**

Each participant’s account is credited with the participant's share of employer contributions and rollover contributions, as well as an allocation of earnings and plan expenses. Allocation of plan expenses may be on a proportional or per-participant basis. Investment options are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

**Vesting**

Participants are always 100% vested in both rollover contributions and prevailing wage contributions. Profit sharing contributions vest in accordance with the Plan’s vesting schedule if applicable. All amounts become fully vested upon normal retirement age, plan termination, or other stipulated circumstances.

**Payment of Benefits**

Benefits may be distributed upon retirement, disability, death, or termination of employment. In-service and hardship withdrawals are permitted under specified conditions. Distributions are generally made in lump sum; however, other forms may be available for accounts over \$5,000. Minimum required distributions are made in accordance with IRS guidelines.

**1. Description of Plan, continued**

**Loans to Participants**

The Plan permits participant loans in accordance with its written loan policy. Loans are limited to the lesser of \$50,000 or 50% of the vested account balance, have a minimum of \$1,000, and are secured by the participant's account. The interest rate is set at prime plus 1%. Loan terms and repayments comply with IRS and Department of Labor requirements.

**2. Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, revenues, and expenses as of the date and for the period presented. Actual results could differ from those estimates.

**Fair Value Measurements**

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments and revenue at fair value. The specific techniques used to measure fair value for these financial statement elements are described in the notes below that relate to each element.

**Administrative Expenses**

The Plan is administered by Florence Crittenton Services of Orange County, Inc. All assets are held in trust by ERISA Smart, Inc. Certain administrative expenses are paid from trust assets and allocated among participants. Expenses specifically attributable to a participant (such as distributions ordered under a qualified domestic relations order) are charged directly to that participant's account.

During 2024, total custodian expenses of the Plan were \$4,758.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

**3. Information Prepared and Certified by the Custodian**

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following summarizes the information certified by Transamerica Trust Company, the custodian of the Plan as of December 31, 2024.

The Plan invests in the Transamerica Stable Value Account, a fully benefit-responsive group annuity contract issued by Transamerica Life Insurance Company and backed by its general account. The credited interest rate is set semi-annually; for the year ended December 31, 2024, the rate was 2.46%. Balances are reported at contract value. All participant-initiated withdrawals, loans, and transfers are permitted at contract value, subject to plan and contract limits.

Plan-level withdrawals may be subject to holds up to 270 days, or, if the contract is discontinued, a delay of up to 12 months, with settlement at a value other than contract value based on contract provisions. Principal and interest are subject to the claims-paying ability of the insurer. Assets are pooled in the general account and not allocated to specific plan investments. Fees and asset charges apply per the contract schedule; there are no unfunded commitments.

**6. Related Party and Party-in-Interest Transactions**

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$4,758.

**6. Related Party and Party-in-Interest Transactions, continued**

The Plan's investment options include funds managed by Transamerica Trust Company or its affiliates. As custodian and recordkeeper, Transamerica Trust Company's transactions qualify as exempt parties-in-interest transactions.

**7. Plan Termination**

While the Employer intends to continue the Plan indefinitely, it reserves the right to amend or terminate the Plan at any time. Upon termination, all affected participants will become fully vested and entitled to benefits as permitted by the Plan.

**8. Tax Status**

The Plan is intended to be qualified under Section 401(a) of the Internal Revenue Code. Distributions from the Plan may be subject to income taxes and early distribution penalties. Participants are provided with tax notice explanations.

**9. Subsequent Events**

Effective June 1, 2025, the Plan transferred custodial responsibilities from Transamerica Trust Company to Mutual of America Life Insurance Company. In connection with this change, the plan was amended to transition from a profit sharing plan structure to a defined contribution plan under Section 401(a) of the Internal Revenue Code.

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available for issue. Except as noted above, no other events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.
