## Independent Auditor's Report

To the Plan Administrator of  
DLH 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of DLH 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of DLH 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**NOTES TO FINANCIAL STATEMENTS**  
**December 31, 2024 and 2023**

**1. DESCRIPTION OF PLAN**

The following description of DLH 401(K) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and summary for a more complete description of the Plan’s provisions.

**General**

The Plan was adopted and became effective January 1, 1996, and has been amended from time to time to qualify under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is designed to provide retirement benefits to qualifying employees of DLH Holdings Corp. (the “Company”). The Plan is a defined contribution Plan to which participants who have attained the age of twenty-one can make contributions to an account held in the participant’s name. The entry date into the Plan is the first day of the month following employment. The retirement benefits the participant receives depends upon their investment selection and upon the investment performance of the amounts that are in their accounts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2021, the Plan changed plan custodian from Principal Trust Company (“Principal”) to Fidelity Management Trust Company (“Fidelity”). At this time, substantially all Plan assets were transferred from Principal to Fidelity.

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Annual contributions are subject to certain limitations set by the Internal Revenue Service (“IRS”). Participants direct the investment of their contributions into various options offered by the Plan.

The Plan provides for three types of employer contributions. *Employer Matching Contributions:* The employer will make a safe harbor matching contribution of 100% of employee deferrals on the first 3% of compensation and 50% of employee deferrals on the next 2% of compensation. The Company may elect, at the discretion of the Board of Directors, to contribute 100% of employee elective deferral contributions, limited to 4% of eligible compensation. Any matching Company contribution is invested in the portfolio of investments as previously determined by the participants. *Wage Rate Contributions:* The Company will also make wage rate contributions which are equal to the fringe benefit amount determined according to the prevailing rate schedule for each person reduced by contributions made to other plans that count towards the fringe rate stated in the prevailing rate schedule. *Discretionary Profit-Sharing Contributions:* The Company may elect to make a discretionary contribution of profit-sharing amounts at the approval of the Board of Directors; however, no such profit-sharing contributions were made for 2024.

For the year ended December 31, 2024, Company contributions consisting of employer matching contributions and wage rate contributions were \$5,905,074.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of: (a) the Company’s contribution and (b) Plan earnings (losses), and (c) an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options**

All contributions are deposited in various investment funds administered and managed by Fidelity. Each participant makes the selection as to what portion, in increments of 1%, of their investment is allocated among the funds. The general investment policy for the funds is established by the Plan’s trustee.

## **Vesting**

A participant's interest in his/her deferral, wage rate contributions, and the investment earnings (losses) thereon, under the Plan, is at all times fully vested and non-forfeitable. Safe harbor employer matching contributions are always 100% vested.

Multiple vesting schedules apply to various classifications of participants and various employer-sourced contributions. Participants should refer to the Plan document for a more detailed explanation of the vesting provisions.

## **Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 and a maximum of 50% of their vested account not to exceed \$50,000. Participants may repay the note through payroll deductions and may extend payments over a five-year period. If purchasing a home, participants may extend payments over a 15-year period. The interest rate on the notes receivable will be equal to the prime rate plus 1%, as disclosed in the *Wall Street Journal*. The loans bear interest ranging from 4.25% to 9.5%. Principal and interest repayments are credited to the participant's account in the Plan.

## **Forfeitures**

Participants who terminate employment before becoming fully vested will forfeit the non-vested portion of their matching account balances unless they resume employment before incurring a five-year break in service. Forfeitures may be used to pay Plan expenses or reduce Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$204,631 and \$39,606, respectively. In 2024, employer contributions were reduced by \$47,777 from forfeited nonvested accounts.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities, and additions and deductions to net assets available for benefits at the date of the financial statements. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Purchases and sales are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The Plan adheres to the provisions described in Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 962. This guidance clarifies the definition of fully benefit-responsive investment contracts for defined contribution Plan's along with the financial statement presentation and disclosure of such contracts. In evaluating the provisions of this guidance, the Plan's investment contracts are required to be reported at fair value. The plan does not hold any benefit responsive investment contracts as of Dec. 31, 2024 and 2023.

Net investment income earned and unrealized gains or losses on investments and Plan expenses are allocated to the participant's account based on the ratio that the individual account bears to all participant accounts within each investment fund as of each valuation date. Accounts are valued on a daily basis.

### **Administrative Expenses**

All administrative costs of the Plan are absorbed by the Company, except for Fidelity's expenses, including certain investment related expenses which have been offset against net investment income.

## Payment of Benefits

Participants in the Plan are eligible to receive payment of vested benefits when the participant attains the retirement age of 62 years, dies, becomes disabled, or terminates his or her service with the Company. Benefits are payable in a lump-sum payment or, under certain circumstances, in periodic installments as elected by the participant or beneficiary. Benefits paid to participants are recorded upon distribution. In-service distributions are permitted when a participant reached age 59 ½, becomes disabled or due to financial hardship.

## Termination of the Plan

The Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the Plan document. In the event of Plan termination, participants will become 100% vested in their accounts. These amounts may be distributed to the participants at that time or may be distributed in accordance with the Plan's benefit distribution rules.

## Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income from notes receivable is recorded when earned. No allowance for losses is deemed necessary by Plan management as principal and interest are repaid through payroll deductions.

## 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities, in active markets that the Plan has the ability to access. Such inputs include quoted prices in active markets for identical assets or liabilities.

*Level 2* - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* - Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Registered Investment Companies - Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* Valued at NAV as determined by the issuer of the fund based on the fair value of the underlying investments. NAV is used as a practical expedient to estimate fair value.

#### 4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

No auditing procedures were performed by the independent public accountants as permitted by ERISA Section 103(a)(3)(c) with respect to information certified as complete and accurate by Fidelity Management Trust Company (Fidelity, the current trustee) except for comparing such information with the information reported in the financial statements.

Based on information provided and certified by the trustee, there are no fixed obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of December 31, 2024. Accordingly, the trustee of the Plan assets has certified to the completeness and accuracy of:

Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 as well as the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Net appreciation in fair value of investment, dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### 5. TAX STATUS

The Plan adopted a non-standardized pre-approved profit-sharing plan with Cash or Deferred Arrangement ("CODA"). By letter dated June 30, 2020, the IRS has determined that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. Furthermore, there are no tax related interest or penalties included in the accompanying financial statements.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity is the investment Trustee as defined by the Plan and therefore, these investments and any related net investment income (net of certain investment related expenses) qualify as party-in-interest transactions. Fees paid by the Plan amounted to \$271,187 for the year ended December 31, 2024, which are included in administrative expenses. Notes receivable from participants qualify as exempt party-in-interest transactions.

## **7. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of stocks, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the December 31, 2024 statement of net assets available for benefits. As of December 31, 2024 and 2023 three and four investments, respectively, represented a concentration of over 10% of the Plan's net assets available for benefits.

The Plan is exposed to credit loss in the event of non-performance by the companies with whom investment contracts are placed. However, the Plan does not anticipate non-performance by these companies and believes that the risk to Plan assets from credit loss is not material due to the diversified nature of the assets held.

## **8. DELAYED DEPOSITS OF EMPLOYEE CONTRIBUTIONS**

U.S. Department of Labor regulations require that salary deferrals to a defined contribution plan that are withheld from employees' paychecks be deposited into the Plan as soon as they can be reasonably segregated from the employer's general assets. For the years ended December 31, 2018 and 2017, the Company delayed making certain deposits of employee withholdings as soon as they could be reasonably segregated. Such delayed deposits totaled approximately \$60 and \$474,000, respectively.

Corrective action relating to the delayed deposit consists of calculating and restoring lost earnings to affected participants. The calculation resulted in a de minimis amount to be allocated to the affected participants therefore, the Company will not be making a corrective deposit of lost earnings to the affected participants' accounts. Such lost earnings are immaterial to the financial statements as a whole.

## 9. RECONCILIATION OF INFORMATION CONTAINED IN FINANCIAL STATEMENTS AND INFORMATION CONTAINED ON THE FORM 5500, SCHEDULE H

The Plan financial statements are on the accrual basis of accounting which includes recording receivables and accruing payables and expenses. However, the IRS Form 5500 does not require the use of the accrual basis of accounting, and as such, the Plan sponsor prepares the IRS Form 5500 on the cash basis of accounting. Accordingly, the IRS Form 5500 does not report receivables and accruals.
