**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Southeastern Construction & Maintenance, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering full-time employees of the Southeastern Construction & Maintenance, Inc. (the “Company”) who have three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Southeastern Construction & Maintenance, Inc.’s (the Company’s) Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board of Trustees.

**Contributions** - Participants may contribute up to, but not exceed, the maximum amount allowed by the Internal Revenue Code limits. Participants who have attained the age of 50 are eligible to make pre-tax catch-up contributions, subject to certain limitations. Additionally, the plan permits rollovers from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 25% of the first 4% of base compensation that a participant contributes to the Plan. Contributions are subject to certain statutory limitations.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution, the Company’s contribution, if any, and Plan earnings; and is charged with the participant’s withdrawals, Plan losses, and an allocation of administrative expenses. Allocations are based on participant investment account earnings, elective deferrals, or account balances, as defined. The benefit to which a participant is entitled is the vested balance in the participant’s account. All participant accounts are maintained by the Insurance Company.

**Investment Options** - Upon enrollment in the Plan, a participant may direct employee and employer contributions into various investment options, which includes mutual funds. Participants may change their investment options at their discretion, as permitted by the Plan.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts an amount not less than \$1,000 of the vested portion of the participant’s account balance. The term of the loan may not exceed five years, unless meeting certain criteria for residential loans. The Plan limits the number of loans a participant can have outstanding at any time to one. The loans are secured by the balance in the participant’s account and are charged an interest rate of Wall Street Prime, plus 1%. Principal and interest are paid ratably through payroll deductions. Loans at December 31, 2024 had interest rates between 4.25% and 9.5% and a final maturity date of September 2033.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

***Vesting*** - Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company contribution portion of their accounts, plus actual earnings thereon, is based on each employee's years of continuous service, as defined by the Plan. The Plan's vesting provision is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 Years	0%
2 Years but Less than 3	20%
3 Years but Less than 4	40%
4 Years but Less than 5	60%
5 Years but Less than 6	80%
6 Years or more	100%

An active participant who is less than 100% vested is deemed to be 100% vested upon death, total disability or termination of the Plan.

***Forfeited Accounts*** - Pursuant to the plan document, the non-vested portion of discretionary matching and nonelective contributions credited to the accounts of participants who withdraw from the Plan are forfeited and held as nonparticipant-directed investments. These amounts may be used to pay administrative expenses of the Plan and any remaining amounts may be allocated to qualifying participants as an additional discretionary nonelective contribution. The Plan had \$0 of forfeitures available to pay administrative expenses as of December 31, 2024 and 2023, respectively. The Plan Sponsor used \$4,694 and \$1,716 of forfeitures to pay administrative expenses for the 2024 and 2023 Plan years, respectively.

***Benefit payments*** - Upon termination of service due to death, retirement, disability, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

***Hardship Withdrawals*** - Withdrawal of a portion of a participant's account will be permitted due to an immediate and heavy financial need, if it meets IRS requirements.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting*** - The accompanying financial statements have been prepared on the accrual basis of accounting.

***Subsequent Events*** - The Plan evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Estimates** - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investments, Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for investments as of the reporting date. As of December 31, 2024 and 2023, the Plan did not have such assets.
- Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets. As of December 31, 2024 and 2023, the Plan did not have such assets.
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets include financial instruments whose value is determined using pricing models, for which the determination of fair value requires significant management judgment or estimation. As of December 31, 2024 and 2023, the Plan did not have such assets.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual Funds*: These investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded ("Level 1").

The estimated fair value is subjective in nature and involves uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could affect these fair value estimates. The fair value estimates do not take into consideration the value of future business and the value of assets and liabilities that are not financial instruments.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

There were no transfers into or out of Level 1 and Level 2 fair value measurements during the years ended December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Benefits Paid to Participants* - Benefits are recorded when processed and paid by the Plan.

*Administrative Expenses* - The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**NOTE 3 - CERTIFIED PLAN ASSETS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31:

**NOTE 5 - PLAN TERMINATION**

The Company anticipates the Plan will continue without interruption but reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, the participants shall become 100% vested in their plan accounts and the net assets of the Plan shall be distributed to the participants and beneficiaries of the Plan.

**NOTE 6 - INCOME TAX STATUS**

The Plan is placing reliance on an opinion letter dated March 31, 2014 received from the Internal Revenue Service on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code and is, therefore, not subject to income tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter, however, the Plan administrator and the Plan's sponsor believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Internal Revenue Code. Accordingly, the Plan administrator believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 - ADMINISTRATIVE EXPENSES**

Administrative expenses are comprised primarily of investment fees and are paid by the Plan. Additionally, any professional fees incurred on behalf of the Plan are paid by the Company.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

For the year end December 31, 2024, the Plan held 100% of its investments in managed by FMTC and, therefore, payments to FMTC for investment management fees and record keeping fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
