## Independent Auditor's Report

To the Plan Administrator of  
Greater New York Mutual Insurance Company 401(k) Employee Savings Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Greater New York Mutual Insurance Company 401(k) Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Greater New York Mutual Insurance Company 401(k) Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Greater New York Mutual Insurance Company 401(k) Employee Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

## NOTES TO FINANCIAL STATEMENTS

### NOTE 1 - Description of the Plan

The following is a brief description of the Greater New York Mutual Insurance Company 401(k) Employee Savings Plan (the "Plan") and provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Greater New York Mutual Insurance Company (the "Company") is the Plan sponsor. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal") is the Trustee and administrative service provider to the Plan.

The Plan was effective January 1, 2002 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). An employee is eligible to participate in the Plan on the first day of the month following their hire date. Leased employees, independent contractors, part-time, temporary, or seasonal employees, and residents of Puerto Rico, are excluded from the Plan.

### NOTE 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present net assets available for benefits and changes in those net assets of the Plan.

#### Payment of Benefits

Amounts paid to participants are recorded upon distribution.

#### Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except certain recordkeeping and service fees, which are paid by the Plan. Administrative expenses charged against plan assets for the years ended December 31, 2024 and 2023 amounted to \$87,667 and \$71,854, respectively. In addition, certain investment related fees have been reflected within net appreciation in fair value of investments in the statement of changes in net assets available for benefits and are not readily determinable.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent liabilities and assets. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in registered investment companies at December 31, 2024 and 2023 are valued at the closing price on the active market on which that individual security is traded.

Investments in pooled separate accounts are valued at Net Asset Value ("NAV"). The NAV is based on the fair value of the underlying mutual fund, which is obtained from third party pricing vendors or by utilizing observable market information.

Funds held in insurance company general account are valued at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's matching contribution, and an allocation of Plan earnings, which are net of investment management expenses charged by the Plan's investment providers. Administrative costs charged by the administrative service provider are deducted from participants' accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Benefits

Participants are immediately 100% vested in employee contributions and earnings within their participant accounts. Participants vest in 50% of their employer matching contributions subsequent to their second full year of service and are 100% vested after three years of service.

Forfeitures

Forfeitures occur when employees terminate their employment with unvested employer matching contributions and related earnings. For the year ended December 31, 2024, forfeitures totaled \$22,136 and were used to offset 2024 employer matching contribution. For the year ended December 31, 2023, forfeitures totaled \$4,200 and were used to offset 2023 employer matching contributions. Forfeitures generated by the plan are not always the same amount as forfeitures used, due to investment gains/losses generated while the funds were invested.

Effects of New Accounting Pronouncements

The Plan is not aware of any new accounting standards that were required to be adopted in 2024, or yet adopted, that would impact the Plan's 2024 or prospective financial statements.

Plan Termination

The Company reserves the right to terminate the Plan at any time. Termination of the Plan shall result in immediate vesting of the entire amount credited to each participant. Upon such termination, the Plan Administrator shall notify the Trustee and the Trustee shall pay to each participant the value of his or her interest in the Plan as soon as practicable.

NOTE 3 – Contributions

The Plan allows each participant to contribute from 1% to 100% of the participant's annual compensation to the Plan subject to IRS prescribed limitations and other required withholdings from wages. However, a participant's salary deferrals in any taxable year may not exceed a certain dollar amount, which is set by law. The Plan also has a Roth option, which allows the participant to contribute after-tax dollars and withdrawals of any money (including investment gains) are tax free. All eligible employees not contributing to the Plan are automatically enrolled with a contribution rate of 6% into the pre-tax portion of the Plan. The plan utilizes a service offered by Principal known as RetireView which is an asset allocation of certain investments offered by the Plan which varies based on the employees age and desired level of risk. Employees who are auto-enrolled will have the age appropriate RetireView option assigned as their default investment, unless they have an existing investment election on file, which would be invested accordingly. Employees can change their investment and/or contribution options, as needed.

The Plan includes an automatic contribution escalation feature whereby participants in the plan who are contributing less than 10% will have their contribution percentage automatically increased by 1% effective with the first payroll after May 1<sup>st</sup> each year, up to a maximum contribution percentage of 10%.

Each year an employer matching contribution is made for employees employed by the Company at year end equal to 50% of each participant's salary deferrals that do not exceed 6% of annual compensation as defined by the Plan. In addition, the Company can make additional matching contributions for any year in an amount determined by the Company's Board of Directors, in its sole discretion. There were no additional matching contributions for 2024 or 2023.

NOTE 4 – Payment of Benefits

Participants' benefits under the Plan are payable to participants, their beneficiaries or their estates upon the termination of employment, normal retirement, late retirement, attaining age 59½, and death. Benefits are payable in the form of cash lump-sum distributions or periodic payments not to exceed the participant's life expectancy.

The normal retirement date is the first day of the month following the date on which the employee attains age 65. Late retirement applies to employees who retire after age 65.

Participants who have retired generally need to take a required minimum distribution ("RMD") from the Plan at age 73. The Plan provides for Principal to process RMDs directly with plan participants.

All terminated employees with vested benefits equal to or less than \$5,000 have 60 days to make a decision regarding their funds. After 60 days, all terminated employees with vested benefits equal to or less than \$1,000 who have not made a decision, will have their funds distributed as cash. After 60 days, all terminated employees with vested benefits greater than \$1,000, but equal to or less than \$5,000, who have not chosen to receive cash or rollover amounts to a qualified plan, will have their benefits rolled into a qualified Individual Retirement Account designated by the Plan Administrator.

NOTE 5 - Notes Receivable from Participants

The Plan provides for loans to participants. The Plan permits loans for any purpose. A participant may have only two loans outstanding at a time. The minimum amount a participant can borrow is \$1,000. The maximum amount a participant can borrow is the lesser of: 50% of the participant's vested account balance, or \$50,000, which will be reduced if the participant had an outstanding loan in the preceding 12 months.

Any loan to a participant under the Plan is secured by the vested interest of the participant's account.

A fixed interest rate is charged at 1% above the prime rate published in The Wall Street Journal on the last business day of the month preceding the month in which a loan is approved. The interest rate remains fixed throughout the life of the loan. For 2024 and 2023, the interest rates ranged from 3.25% to 9.50%. A loan for the purpose of purchasing a principal residence must be repaid in 15 years and all other loans must be repaid within 5 years. Loans will normally be repaid through regular payroll deductions.

The outstanding balance of a loan is due and payable upon a participant's termination of employment with the Company or upon death. Loans not repaid as of the participant's termination are deemed to be a distribution to the participant.

NOTE 6 - Tax Status

The Plan adopted a volume submitter plan, designed and administered by Principal on behalf of the Plan sponsor. Principal obtained an opinion letter from the IRS, dated June 30, 2020, stating that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter, however, the Plan sponsor believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or Department of Labor ("DOL"). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - Investments

The Company has adopted a daily valuation, multi-fund family program for eligible employees. Under the daily valuation program, participants are able to invest their accounts under a menu of registered investment companies, pooled separate accounts, and funds held in an insurance company's general account.

Under the daily valuation program, participants may (i) access their accounts at any time and (ii) direct the investment of their existing accounts and future contributions at any time among the registered investment companies, pooled separate accounts, and funds held in an insurance company's general account offered by the Plan.

The existence of certain conditions can limit the Plan's ability to transact at contract value with Principal. Specifically, any event outside the normal operation of the Plan that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to the withdrawal.

Examples of such events include, but are not limited to: (a) partial or complete Plan termination, (b) tax disqualification of the Plan, and (c) certain Plan amendments if Principal's consent is not obtained. As of December 31, 2024, the occurrence of an event outside the normal operation of the Plan that would cause a withdrawal from an investment contract is not considered to be probable.

The Plan invests in a fully benefit-responsive investment contract whereby the Trustee maintains the contributions in a general account. The investment contract is included in the statement of net assets available for benefits at contract value as reported to the Plan by the Trustee. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum interest rate guaranteed to the Plan is 1%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

NOTE 8 - Information Certified by the Plan's Trustee (Unaudited)

The Company has elected the method of annual compliance reporting permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Trustee of the Plan has certified the completeness and accuracy of all investments and related investment activity, notes receivable from participants and interest income from notes receivable from participants in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

No auditing procedures were performed by the independent auditors as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA with respect to information certified as complete and accurate by the Trustee, except for comparing such information with the related information included in the financial statements, and supplemental schedule. Based on information provided and certified by the Trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit. Due to the level of risk associated with certain investment securities and other economic factors, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. However, the Company does not anticipate non-performance by these investment securities and believes that the risk to Plan assets from credit loss is not material due to the diversified nature of the assets held.

NOTE 10 - Party-In-Interest

Certain Plan investments are shares of registered investment companies, pooled separate accounts and funds held in an insurance company's general account managed by the Plan's Trustee. In addition, certain investment fees have been included within net appreciation in fair value of investments. Accordingly, these transactions qualify as party-in-interest transactions. Participants are a party-in-interest to the Plan and therefore notes receivable from participants qualify as party-in-interest transactions.

NOTE 11 - Fair Value Measurements

FASB guidance relating to fair value measurement clarifies the definition of fair value, establishes a framework for measuring fair value, and requires the disclosures of fair value measurements.

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 11 - Fair Value Measurements, continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts ("PSA"): Fair value of the mutual fund, in which the PSA invests, is a publicly quoted pricing input used in determining the NAV of the PSA, which is not publicly quoted, but is available via Principal's website to current investors. This investment has a readily determinable fair value. PSA funds can be redeemed daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
