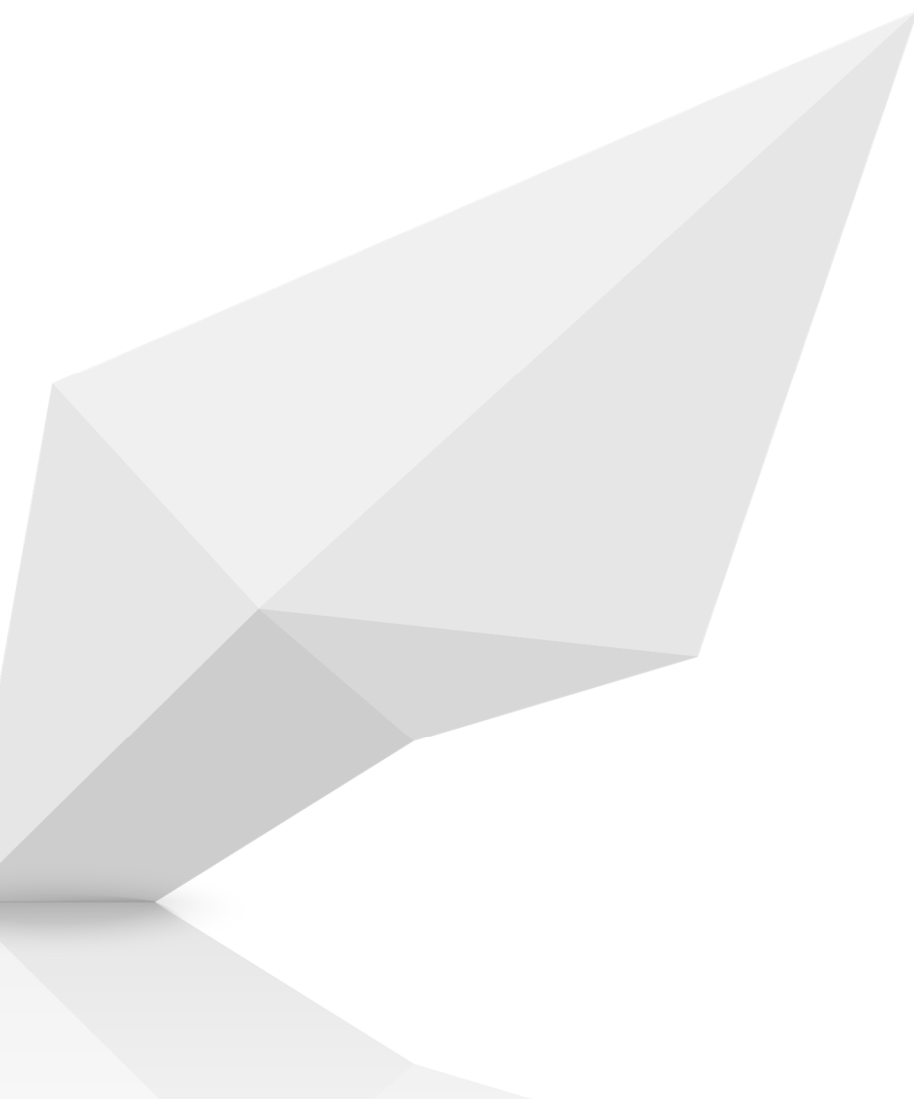

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Perlick Corporation Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements

Note 1: Description of Plan

The following description of the Perlick Corporation Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

General

The Plan is a participant-directed defined contribution plan sponsored by Perlick Corporation (the "Sponsor"). The Sponsor is the Plan Administrator. Investments are all participant-directed. T.Rowe Price ("T.Rowe") is the Custodian and recordkeeper of the Plan. The Plan also utilizes Francis Investment Counsel ("Francis") for investment advisory services.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision(s) to elect in the future.

Eligibility

Substantially all employees are eligible to participate in the Plan after they have completed two consecutive months of service.

Contributions

Participants may contribute a portion of their annual compensation, as defined in the Plan document, subject to the annual maximum amount allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Upon meeting eligibility requirements, employees are automatically enrolled in the Plan with a deferral rate of 3% and will increase by 1% each Plan year to a maximum of 6%, unless the employee has elected not to participate or to contribute at a different rate. Participants may also contribute distributions from other qualified plans ("rollovers").

The Sponsor may make discretionary matching and other discretionary contributions ("Profit Sharing") to the Plan. Under its collective bargaining agreement, the Sponsor is required to match \$0.25 for each \$1.00 contributed by union employees up to a maximum of 6% of the participant's eligible compensation and make a minimum Profit Sharing contribution of 3.75% of total annual wages earned by participants. In 2024, the Sponsor matched \$0.50 for each \$1.00 contributed by non-union employees up to a maximum of 6% of the participant's eligible compensation. The Sponsor accrued a Profit Sharing contribution for union and non-union employees in 2024 at a rate of 3.75% and 2.25%, respectively. The total Profit Sharing contribution in 2024 totaled approximately \$456,000, which was offset by approximately \$216,000 of forfeitures subsequent to December 31, 2024. Participants generally must be employed on the last day of the Plan year to receive Sponsor contributions other than matching contributions.

Note 1: Description of Plan (Continued)

Investment Options

Participants direct all contributions into one or a combination of investment fund choices. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, the Sponsor intends that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement. Participants should refer to the individual prospectuses for a more complete description of Plan investments.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Sponsor's contributions, and allocations of Plan investment income (loss) and administrative expenses. Allocations are based on participant compensation or investment balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon retirement at normal retirement age, disability, death, or termination of employment, a participant or their beneficiary can elect to receive either a lump-sum amount equal to the value of their vested account, or monthly, quarterly, semi-annual, or annual installments. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon.

Sponsor matching contributions, other discretionary contributions, and any earnings (losses) thereon, vest according to the following schedule:

Forfeitures

Forfeitures are portions of participant account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures from Sponsor contributions may be used to pay Plan expenses, be allocated as additional Sponsor contributions, or used to reduce Sponsor contributions at the Sponsor's discretion. The Plan provides for restoration of forfeited funds upon re-employment of former participants in certain circumstances. At December 31, 2024 and 2023, there were \$131,846 and \$138,877, respectively, of unallocated forfeitures. As previously disclosed, approximately \$216,000 of forfeitures were used to fund the Profit Sharing contribution subsequent to December 31, 2024.

Notes Receivable from Participants

Participants may receive a note from their account balance at the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Fees relating to the administration of notes receivable from participants are charged directly to the participant's accounts and are classified as administrative expenses. Fees charged by the Custodians and recordkeeper are paid by the Plan and are also classified as administrative expenses. Certain expenses of maintaining the Plan that are paid directly by the Sponsor and are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued as determined by the issuer of the common collective trust using NAV per share measurement.

The Putnam Stable Value Fund ("Stable Value Fund") is comprised of common collective trusts with underlying investments in fully benefit-responsive investment contracts. The objective is to maintain safety of principal while generating a level of current income exceeding that of a money market. The Stable Value Fund seeks to maintain a stable \$1.00 unit value although there is no guarantee it will be able to do so. The Stable Value Fund invests in traditional and synthetic guaranteed income contracts with various crediting formulas. The Stable Value Fund's manager may limit withdrawals in order to maintain sufficient liquidity.

Investments in the Stable Value Fund can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by Custodian

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by T. Rowe as of December 31, 2024.

Note 5: Tax Status

The Sponsor adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 8: Party-In-Interest Transactions

The Plan pays fees to the Custodians, recordkeeper, and its investment advisor. These transactions are party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations. Administrative and recordkeeping fees incurred by the Plan for services provided by T.Rowe were \$49,782 for the year ended December 31, 2024.
