Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Mission Critical Group 401(k) Plan (the Plan and formerly the Mission Critical Facilities International 401(k) Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the 2024 financial statements, is complete and accurate.

Emphasis of Matter

As disclosed in Note 5 to the financial statements, the Plan Sponsor acquired Point Eight Power, Inc. (PEP) effective February 26, 2024. As a result of the acquisition, the assets related to the PEP participants in the Orion South, Inc. Profit Sharing Plan and Trust merged into the Plan, effective March 29, 2024, and the assets were transferred into the Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the 2024 financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the 2024 financial statements.

December 31, 2024 (Audited) and 2023 (Compiled)

1. Description of Plan

The following description of the Mission Critical Group 401(k) Plan (the Plan and formerly the Mission Critical Facilities International 401(k) Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2015, and restated effective August 1, 2024. The Plan covers all employees of Mission Critical Group LLC and subsidiaries (collectively, the Company, Employer, or the Plan Sponsor), excluding union employees, leased employees, and nonresident aliens. Mission Critical Group LLC, Mission Critical Facilities International, Johnson Thermal Systems, Inc., and Point Eight Power, Inc. (PEP), are the participating employers in the Plan.

As described in Note 5, on February 26, 2024, the Company acquired PEP. Employees of PEP began participating in the Plan effective March 11, 2024.

Through July 31, 2024, the Plan was known as the Mission Critical Facilities International 401(k) Plan. During this period, employees became eligible to make elective deferrals upon attainment of age 21 and completion of 250 hours of service within a three-month period, with plan entry on the first day of the following calendar quarter.

Effective August 1, 2024, the Plan was restated and renamed as the Mission Critical Group LLC 401(k) Plan, and eligibility requirements were updated. Employees are now eligible to make elective deferrals upon attainment of age 18 and completion of one month of service, with entry on the first day of the following month. Employees become eligible to receive non-elective employer contributions after completing one year of service or 1,000 hours of service in a plan year, provided they are employed on the last day of the year. In addition, long-term part-time employees who meet the eligibility criteria under the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (SECURE Act 2.0) are also eligible to participate in the Plan.

Effective December 26, 2024, the Plan transitioned its recordkeeping and custodial services from John Hancock Retirement and John Hancock Life Insurance Company to Empower Retirement, LLC and Empower Trust Company, LLC, each respectively. All participant account balances and plan assets were transferred in accordance with Plan provisions, and participant account access was maintained throughout the transition.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company has designated the 401(k) Committee to oversee the Plan. The 401(k) Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the 401(k) Committee.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes an annual safe harbor non-elective contribution equal to 3% of each employee's eligible compensation. The Company's safe harbor non-elective contribution amounted to \$1,221,590 for the year ended December 31, 2024. Additional non-elective discretionary contribution amounts may be contributed at the option of the 401(k) Committee. For the year ended December 31, 2024, there were no non-elective discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's safe harbor non-elective contributions and non-elective discretionary contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, safe harbor non-elective contributions plus actual earnings thereon. Vesting in the Company's non-elective discretionary contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through weekly, bi-weekly, and bi-monthly payroll deductions. Terms range from 1 to 5 years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of a lump sum cash payment or a distribution to an Individual Retirement Account (IRA), depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$29,318 and \$14,372, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$19,467, from forfeited nonvested accounts, in accordance with Plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

Cash consists of noninterest bearing account which represents funds held pending acquisition of investments.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Notes receivable bear interest at rates from 4.25% to 9.75% as of December 31, 2024. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Other Receivables

The Plan has a receivable of \$230,824 as of December 31, 2024, which pertains to plan assets in transit from the previous recordkeeper of PEP's plan assets. These receivables were received by the Plan on May 15, 2025. Refer to Note 5 for additional information.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions and recordkeeping are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Regulatory Updates

The SECURE Act 2.0 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE Ac 2.0 did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

The Company amended the Plan effective January 1, 2025. As part of this amendment, employer non-elective matching contributions up to 4% of Plan compensation and a safe harbor match of 100% on employee contributions up to 4%, funded each pay period with a year-end true-up, were added to the Plan. As a result of that change, the annual safe harbor non-elective contribution was removed. Employer non-elective matching contributions vest on a 2 to 6 year graded schedule, while safe harbor contributions continue to be immediately vested. In addition, eligibility was revised to exclude interns and to also allow participants to become eligible to participate in the plan after attaining the age of 18 and completing one month of service. The amendment also adds a requirement for a participant to be employed on the last day of the year and to have completed one year of service or 1,000 hours in order to receive employer non-elective matching contributions.

The Company further amended the Plan effective September 30, 2025, to include the service provided to predecessor employers in determining eligibility.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end. These funds are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Consisting of common-collective trusts, are valued at the NAV of units of a bank collective trust. The NAV, as provided by the Custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Concentrations

As of December 31, 2024 and 2023, the Plan has investments of \$16,109,153 and \$560,163, respectively, that were concentrated in one fund each, which individually exceeded 10% of the Plan's net assets available for benefits.

5. Transfers from Another Plan

Effective February 26, 2024, PEP was acquired by the Company. Prior to the acquisition, PEP participated in a separate defined contribution plan (the predecessor plan). As a result of the acquisition, PEP ceased to be a participating employer in the predecessor plan on the same date.

Subsequently, eligible employees of PEP began participating in the Plan effective March 11, 2024.

Plan assets related to PEP participants totaling \$14,508,042 were merged into the Plan effective March 29, 2024. The Plan received \$14,277,218 on June 3, 2024, and the remaining \$230,824 was received on May 15, 2025, which is recognized as an other receivable in the accompanying statement of net assets available for benefits as of December 31, 2024.

6. Information Certified by Custodians

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for the years ended December 31, 2024 and 2023. Accordingly, Empower Trust Company LLC, the current Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activities and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period December 27, 2024 through December 31, 2024.

John Hancock Life Insurance Company, the previous Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statement of net assets available for benefits as of December 31, 2023, and the related investment activities and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through December 26, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain Plan investments were managed by John Hancock Life Insurance Company, the prior Custodian, and therefore, these transactions qualify as party in interest transactions.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any unvested account balances.

9. Tax Status

The Plan adopted a pre-approved plan offered by CCH Incorporated dba FTWilliam.com. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

11. Delinquent Participant Contributions

For the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions and loan repayments to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances, including loan repayments, as reported on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, totaled \$167,198 and \$11,005 for the years ended December 31, 2024 and 2023, respectively. Additionally, the Company will be compensating participants for lost earnings resulting from the delay in contributions.
