### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. ### **Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting**

As described in Notes 2 and 6 to the financial statements, management of IPC Management (the "Company"), the Plan Sponsor, terminated the Plan effective February 20, 2025. As a result of the termination of the Plan, the Plan Sponsor accordingly approved a plan of liquidation, and management determined that liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting previous financial statements, to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



## Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 (IN LIQUIDATION) AND 2023 (ONGOING)

**Note 1 – Description of Plan**

The following description of the IPC Management, Inc. 401(k) Plan (the “Plan”) provides only general information before the plan was terminated. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan, covering substantially all full-time employees of IPC Management, Inc. (the “Company”) who have met the Plan participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each year, participants may elect to contribute up to 100% of pre-tax annual compensation, as defined in the Plan, or as a post-tax Roth deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations. The aggregate contributions to each participant account may not exceed \$69,000 (\$76,500 including catch-up contributions) and \$66,000 (\$73,500 including catch-up contributions) for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and deferred annuity contracts as investment options for participants.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s discretionary profit-sharing contribution, (b) the Company’s safe harbor matching percentage, (c) the Company’s prevailing wage contributions, and (d) earnings of participants’ self-directed investments, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Participants are also vested immediately in the safe harbor employer contributions, as well as the prevailing wage contributions, plus actual earnings thereon. Vesting in the Company’s discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of service under a graduated vesting schedule (listed below), whereby a participant is 100% vested after six years of credited service.

**Note 1 – Description of Plan – Continued**

Payment of Benefits – Upon termination of service due to any reason other than death, a participant will receive a lump-sum payment. Upon termination of service due to death, distributions may be made over a period not greater than the life expectancy of the beneficiary, commencing on or before December 31 of the calendar year immediately following the calendar year in which a participant dies. Participants with vested account balances of \$1,000 or less will receive a lump-sum distribution.

Those participants with vested account balances in excess of \$1,000, but less than \$5,000, may have their balance rolled into a default individual retirement account (“IRA”) if they do not make an affirmative election to withdraw their money from the Plan. If the vested amount exceeds \$5,000, the participant must consent to any distribution of their account. All terminated participants have the option of receiving a cash distribution, rolling the money into their new employer’s retirement plan, or rolling the money into an IRA.

**Participant 401(k) Deferral**

Eligibility and Participation – Employees are deemed eligible for participation in the Plan, provided they are at least 18 years of age and have completed at least 1,000 hours of service in a 12-consecutive month period beginning with their first day of employment. Entry into the Plan is the first day of the next month following the date eligibility requirements are met.

Participant Contributions – Participants may elect to contribute up to 100%, in whole percentage increments, of their compensation, as defined in the Plan, as a pre-tax contribution up to the limits established by the Internal Revenue Service (the “IRS”) of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, or as a post-tax Roth deferral. Participants may direct their contributions or re-allocate their account balance at any point in time during the Plan year into one of the investment options offered. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 for the years ended December 31, 2024 and 2023, respectively.

**Employer Safe Harbor Contribution**

Eligibility and Participation – Employees are deemed eligible for participation in the Plan, provided they are at least 18 years of age and have completed at least 1,000 hours of service in a 12-consecutive month period, beginning with their first day of employment. Entry into the Plan is the first day of the next month following the date eligibility requirements are met.

Company Contributions – The Company will make a matching contribution on eligible employees’ behalf if they make a “Matched Employee Contribution” during the Plan year. A “Matched Employee Contribution” is any 401(k) contribution or catch-up contribution made during the year. If an employee makes a “Matched Employee Contribution”, the employer will contribute a safe harbor matching contribution to an employee’s “Matching Contribution Account” in an amount equal to 1) 100% of the “Matched Employee Contributions” that are not in excess of 3% of their compensation, plus 2) 50% of the amount of the “Matched Employee Contributions” that exceeds 3% of an employee’s compensation, but that do not exceed 5% of their compensation. Compensation is defined as the total of a participant’s wages, salary, and other amounts subject to federal income tax withholding received from the Company for services rendered. ERISA regulations limit maximum compensation to \$345,000 and \$330,000 for the years ended December 31, 2024 and 2023, respectively.

**Employer Safe Harbor Contribution – Continued**

Forfeitures – Forfeitures of non-vested accounts are applied to reduce the Company contribution. Forfeitures can also be used to pay Plan expenses. Forfeitures from all participants that terminated employment before they became fully vested, in respect to their fixed account balance, amounted to \$5,269 and \$5,195 during the years ended December 31, 2024 and 2023, respectively.

**Employer Discretionary Profit-Sharing Contribution**

Eligibility and Participation – Employees are deemed eligible for participation in the Plan, provided they are at least 18 years of age and have completed at least 1,000 hours of service in a 12-consecutive month period beginning with their first day of employment. Entry into the Plan is the first day of the next month following the date eligibility requirements are met.

Company Contributions – Company contributions to the Plan are discretionary and are determined by the Board of Directors. Contributions are pro-rata in the ratio that each participant's compensation bears to the compensation of all eligible participants. Profit-sharing contributions are allocated to the participant accounts at the end of the Plan year.

**Employer Prevailing Wage Contributions**

Eligibility and Participation – Employees are deemed eligible immediately upon hire. Those that work on prevailing wage jobs have immediate entry into the Plan for prevailing wage contributions.

Company Contributions – Company contributions to the Plan are discretionary and are based on employees' hours of work performed on qualifying government jobs. The allocation of Prevailing Wage Contributions is based on the following formula:

- For each hour of service of covered employment under a government contract, the employer shall contribute an amount per the government contract formula.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting – As a result of the Plan's termination subsequent to yearend on February 20, 2025, and the approval of the plan of liquidation, the Plan has adopted the liquidation basis of accounting. This basis of accounting is considered appropriate when liquidation of the plan is imminent. Under the liquidation basis of accounting, assets are valued at the estimated amount of cash or other consideration that the Plan expects to collect in settling or disposing of Plan assets in carrying out its plan for liquidation, and liabilities are stated at their estimated settlement amounts. The 2024 financial statements of the Plan were prepared under the liquidation basis of accounting. The financial statements of the Plan for the 2023 plan year have been prepared using the accrual method of accounting.

**Note 2 – Summary of Significant Accounting Policies – Continued**

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. Investments in mutual funds are recorded at fair value based on the funds' reported closing net asset values as of the last business day of the year, times the number of shares held by the Plan. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Participants may borrow from their combined vested profit-sharing employer contributions, safe-harbor matches, prevailing wage contributions, and 401(k) deferral account balances up to a maximum equal to the lesser of (1) \$50,000 less the highest outstanding balance of the participant loan for the prior 12 months, or (2) up to 50% of the present value of the participant's vested account balance. Loan transactions are treated as transfers between the investment funds and the loan fund. Loan terms range from 1-5 years, except in cases where the proceeds are used to purchase a primary residence, in which case loans can be up to 30 years. The loans are secured by the balance in the participant's account and generally bear interest at prime (7.50% and 8.50% as of December 31, 2024 and 2023, respectively), plus 1.00%. Principal and interest are paid ratably through payroll deductions. The entire balance is due immediately upon the first distributable event after the participant's termination of employment with the Plan's sponsor.

Participant loans are reported as a separate line-item titled Notes Receivable from Participants on the Statements of Net Assets Available for Benefits, and they are measured at unpaid principal, plus accrued interest. The Plan is required to report interest income from notes receivable from participants separately from interest and dividends on the Statement of Changes in Net Assets Available for Benefits. However, the DOL requires Notes Receivable from Participants to be reported as Participant Loans on Schedule H, Line 4i of Form 5500. As such, this presentation is used in the corresponding supplemental schedule included with the financial statements.

Administrative Expenses – Certain administrative expenses of the Plan totaling \$22,550 and \$21,040 during the years ended December 31, 2024 and 2023, respectively, were paid by the Company, are not reflected in the accompanying financial statements, and are not considered an employer contribution.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, as well as disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Note 4 – Fair Value Measurements**

The Plan reports investments at fair value. Market price observability is impacted by several factors, including the type of investment, the characteristics specific to the investment, and the state of the marketplace (including the existence and transparency of transactions between market participants). Investments with readily available, actively-quoted prices, or for which fair value can be measured from actively-quoted prices in an orderly market, will generally have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on inputs:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments which would generally be included in Level I include listed equity securities and listed derivatives. The Plan, to the extent that it holds such investments, does not adjust the quoted price for these investments, even in situations where the Plan holds a large position, and a sale could reasonably impact the quoted price.

Level II – Pricing inputs are observable for the investments, either directly or indirectly, as of the reporting date, but are not the same as those used in Level I. Fair value is determined using models or other valuation methodologies. The types of investments which would generally be included in this category include publicly-traded securities with restrictions on disposition, debt securities, and partnerships that hold Level I assets and real estate held for investment, if measured by a current appraisal.

Level III – Pricing inputs are unobservable for the investment and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant judgment or estimation by the Plan. The types of investments which would generally be included in this category include debt and equity securities issued by private entities, as well as real estate held for investment, if measured using management estimates.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the determination of which category within the fair value hierarchy is appropriate for any given investment is based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

\* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits. Such investments have no redemption restrictions or un-funded commitments, and redemptions of these investments may occur each business day.

The Plan has a deferred annuity contract with Great-West Life & Annuity Insurance Company (“Great-West”) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest-crediting rate is based on the earnings of the underlying assets in the entire medium / long-term portfolio, compared to the minimum interest crediting rate (as stated in the contract) and prevailing market conditions. The interest-crediting rate is reset quarterly.

The average yield earned by the Plan for the benefit-responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average was 1.41% and 1.23% during the years ended December 31, 2024 and 2023, respectively.

**Note 4 – Fair Value Measurements – Continued**

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the deferred annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan);
- (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
- (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or
- (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 5 – Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Great-West Trust Company, LLC, as the prototype sponsor of the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were netted against net appreciation or depreciation in fair value of investments during the years ended December 31, 2024 and 2023.

**Note 6 – Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. Any un-allocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine. The Plan was officially terminated as of February 20, 2025. In June 2025, all Plan assets were transferred to an acquiring company's plan.

**Note 7 – Tax Status**

The IRS has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Generally accepted accounting principles (“GAAP”) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 – Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and determined that the following subsequent events have occurred:

**Plan Termination**

The Plan was officially terminated as of February 20, 2025 (see Note 6). In June 2025, all plan assets were transferred to a new plan.
