## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Harper Brothers Construction LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of Harper Brothers Construction LLC (“Plan Sponsor”), Texas Wall Systems, LLC, HB Trenchless, LLC, HB Farmer Foundation, LLC and JDHB JV (collectively, the “Company”), except union employees, leased employees, and nonresident aliens. Employees are eligible to participate on the first day of the calendar month of the plan year coinciding with, or next following, the completion of one month of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may elect to make pre-tax salary deferral contributions to the Plan up to 100% of their eligible compensation, subject to limits provided under the Internal Revenue Code (IRC). Participants who have attained the age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollovers from other qualified plans.

The Company makes a safe harbor matching contribution equal to 100% of each participant’s deferral contribution up to 4% of eligible compensation each pay period. The Company may also make a discretionary non-elective contribution at the end of the plan year. Participants must be employed on the last day of the plan year to receive the discretionary non-elective contribution. There was no discretionary non-elective contribution made for 2024.

The Plan is participant directed, and participants may change their contribution rates at the beginning of each month and investment options at any time.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are at all times fully vested in their contributions, safe harbor matching contributions, and the appreciation or depreciation thereon. Vesting in the Company’s discretionary non-elective contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest 20% per year after one year of service and are 100% vested after five years of service. A participant shall be immediately vested upon death, retirement, or termination of employment due to total or permanent disability.

**Forfeited Accounts**

Forfeitures of nonvested Company contributions are used to reduce Company contributions to the Plan. There was no balance in the forfeiture account at December 31, 2024 or 2023. There were no forfeitures used during 2024.

**Notes Receivable from Participants**

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan, reduced by the excess, if any, of the participant's highest outstanding loan balance during the one-year period ending on the day before the loan is issued. Loans are repaid in level installments through payroll deductions for periods ranging up to 5 years, or 15 years for the purchase of a primary residence. The loans bear interest at the effective prime rate plus 1% at the date of the loan and are secured by the participant's vested account to the extent of the principal amount of the loan plus accrued interest. Participants may have up to two loans outstanding.

**Benefit Payments**

Normal retirement age under the Plan is 65. Upon death, retirement, disability, or termination of employment, participants are eligible for a benefit payment. The Plan also allows for hardship and in-service distributions from a participant's vested account balance. The funds in a participant's account are distributed in a lump-sum payment or other form of payment as permitted by the terms of the Plan.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and would be entitled to benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Contributions**

Contributions from Plan participants and the Company safe harbor matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investments**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, distributions, certain other transaction fees, and the general administration of the Plan are charged directly to the participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are measured at fair value using net asset value (NAV) per share as a practical expedient. The Plan's investments at fair value as of December 31, 2024 and 2023 are as follows:

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The investments in pooled separate accounts are valued using NAV as an estimate of fair value as reported by John Hancock Life Insurance Company (U.S.A.) based on the value of the underlying investments. The Plan has no unfunded commitments or contractual obligations to further invest in these accounts and there are no restrictions on redemption of these accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), an insurance company, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are in pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) qualifies as a party in interest. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 6 - INCOME TAX STATUS**

The Plan has adopted a volume submitter prototype plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the prototype document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

**NOTE 6 - INCOME TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - SUBSEQUENT EVENTS**

Effective February 10, 2025, the Plan was restated to include Badeco Inc dba HB Utilities LLC as a participating employer and to merge Badeco Inc. 401(k) Plan into the Plan. Net assets totaling approximately \$541,000 were transferred into the Plan in February 2025.

The Plan was amended and restated effective July 1, 2025, to adopt a new nonstandard adoption agreement provided by Principal Life Insurance Company. There were no changes to Plan provisions.

The Plan's pooled separate investment accounts with John Hancock Life Insurance Company (U.S.A.) were transferred into comparable collective investment funds and mutual funds. The conversion initiated a blackout period which began July 7, 2025 and continued through July 27, 2025. During this period, participants could not initiate transactions such as contribution changes, investment transfers, withdrawals or loans until the trustee accurately completed the conversion. During this period, participant contributions continued to be made through payroll deductions.

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.
