## INDEPENDENT AUDITORS' REPORT

To the Trustees of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ripley Entertainment 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. DESCRIPTION OF PLAN:

The following description of the Ripley Entertainment 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, adopted effective January 1, 2002, amended and restated April 1, 2022, is a defined contribution and profit sharing plan covering substantially all employees of Ripley Entertainment, Inc. (the Employer, the Company, or the Plan Sponsor). Employees are eligible to participate in the Plan upon completing at least three months of service and having attained the age of 21, with the entry date being the first day of each month coinciding with or next following the date on which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a percentage, or flat dollar amount of pre-tax annual compensation, as defined in the Plan agreement, up to 100% of their eligible compensation, not to exceed the dollar limitation provided by section 402(g) of the Internal Revenue Code (IRC). Participants may also make Roth 401(k) contributions pursuant to Section 402A of the IRC consistent with the guidelines above. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Newly hired employees will be automatically enrolled into the Plan upon eligibility at 5% pre-tax deferral rate (3% before the restatement on April 1, 2022) unless an election is made otherwise. Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer, at its discretion, matches 100% of the first 3% of deferred wages and 50% of the next 2% of deferred wages. The Plan allows the Employer to make a discretionary profit sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's matching contributions, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations of earnings are based on participant investment earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (CONTINUED):

Vesting

Participants are immediately vested in their own contributions, any rollover contributions, and the actual earnings on those amounts. Vesting in the Employer's discretionary matching contributions and profit sharing contributions is based on years of service. Participants vest at a rate of 20% for each year of service starting with two years of service. A participant becomes fully vested in matching contributions after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have two loans outstanding at any given time, with terms not to exceed five years, unless for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. Principal and interest are paid ratably through equal payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested account balance, a lump sum for a portion of the account balance, or installment distributions. The Plan also permits withdrawals due to circumstances of financial hardship, in accordance with provisions specified in the Plan agreement. Participants are allowed to make in-service withdrawals from their account balances upon reaching the age of 59½.

Forfeited Accounts

Forfeited accounts will be used to either reduce future Employer contributions or expenses related to the administration of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$202,982 and \$125,370, respectively. For the year ended December 31, 2024, the Employer used \$11,833 of forfeitures.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the guaranteed interest account which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the Plan year in which employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the loan is deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan's management has evaluated subsequent events for adjustment to or disclosure in its financial statements through October 14, 2025, the date the financial statements were available to be issued. No recordable or disclosable events occurred through this date.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts* – Valued at NAV of units held by the Plan after adjustment to reflect the fair values of the collective trust's underlying investments, including direct and indirect interests in fully benefit-responsive contracts, based on information reported by the investments advisor using the audited financial statements of the collective trust at year end. The NAV is used as a practical expedient to estimate fair value. As of December 31, 2024 and 2023, there were no unfunded commitments.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

\*Certain investments that are measured at fair value using the NAV per share (or its equivalent) as a practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. GUARANTEED INTEREST ACCOUNT:

The Plan holds a guaranteed investment contract with Massachusetts Mutual Life Insurance Company (MassMutual) totaling \$298,098 and \$214,897 at December 31, 2024 and 2023, respectively. The MassMutual Capital Preservation Account is a fully benefit-responsive investment contract, and is reported at contract value. Contract value (generally equal to historical cost plus accrued interest) is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest rate is reviewed on a quarterly basis for resetting. The guaranteed interest rate is based on thirty-six month average of the five-year constant maturity treasury note as of the month preceding the quarterly reset date less 1.25% and subject to a maximum of 3.00% and a minimum of 1.00%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: i) the Plan Sponsor provides effective communication to MassMutual that the agreement will be fully or partially terminated as of a date selected by the Plan Sponsor, which will be no earlier than thirty (30) days after the Plan Sponsor provides effective communication to MassMutual, ii) the Plan Sponsor breaches a material provision of the agreement and such breach is not cured by the Plan Sponsor within ten (10) business days after effective communication of the breach is provided by MassMutual to the Plan Sponsor, iii) the portion of the market value account attributable to the Plan Sponsor is not more than \$1,000 or the book value account balance is zero, iv) MassMutual determines that it will not be able to continue to operate the agreement under its current terms following the Plan's establishment, activation or material change to, any Plan investment fund, v) the Plan fails to make the contributions to the Capital Preservation Account Investment Option, or vi) MassMutual provides effective communication to the Plan Sponsor that the agreement will be terminated as of a date at least thirty (30) days after MassMutual provides effective communication to the Plan Sponsor. The plan administrator does not believe the occurrence of any such event is probable.

5. CERTIFIED INFORMATION:

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator has elected that information certified by Empower Trust Company, LLC, the trustee, not be subjected to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedules. 6. TRANSACTIONS WITH PARTIES-IN-INTEREST:

Empower Retirement, LLC and related entities perform recordkeeping and trustee services, and receive compensation from the Plan, therefore, these transactions qualify as party-in-interest transactions.

The Plan issues notes to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

7. INCOME TAX STATUS:

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Internal Revenue Service has issued an opinion letter dated November 14, 2022, that the Non-Standardized Pre-Approved Profit Sharing Plan adopted by the Plan, as then designed, is in accordance with applicable sections of the IRC. The plan administrator believes the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Employer may direct benefits to be distributed to participants as soon as practicable, or the trust created by the Plan may be continued and benefits distributed to participants as if the Plan had not terminated. Additionally, all participants would become fully vested in Employer matching contributions and related earnings in the event of a Plan termination.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. CONCENTRATIONS:

Four investments comprised 48% of net assets available for benefits as of December 31, 2024. Two investments comprised 25% of net assets available for benefits as of December 31, 2023.

11. PROHIBITED TRANSACTIONS:

As described in the schedule of delinquent participant contributions (included in the supplemental information), the Employer did not remit certain contributions to the Plan in a timely manner, as defined by ERISA. The Employer has intention to correct such instances and will reimburse affected participants for lost income associated with the delay in contributions. These contributions are considered non-exempt party-in-interest transactions, which may result in the imposition of a 15% excise tax on the amount of the transactions. The tax status of the Plan is not affected by these non-exempt transactions as the Employer intends to pay all fines that may be imposed; however, were the Employer not to complete corrections in a timely manner, the Plan could become disqualified.
